He said that this man is a liar and that the ROSENBERGS will live for ever, and that the Committee, referring to the Committee to Secure Justice for MORTON SOBELL, intends to prove the shameful wrong done to them. He also stated that there are certain forces at large who are trying to shut the mouthes of those who speak up for peace and democracy.

EYNOPSIS OF FACTS

The IACSJRC was formed in January or February, 1952, with SOPHIR DAVIDSON chairman. It changed its name to IARSC in October, 1953, following the National Conference in Chicago, Illinois. Its offices were moved to 355 South Broadway. Los Angeles, California, in early 1953, where the offices are now located. The IACSJRC and the IARSC operated through a Steering Committee and a Ways and Means Committee, whose chairmen act as co-Chairmen of the organization. The IARSC's current chairman is WIDGE NEWMAN and its objectives are to obtain transfer of MORTON SOBELL from Alcatras Prison, to obtain a new trial for SOBELL, and to vindicate the names of the ROSENBERGS. A majority of the leadership of the Larsc and its area committees have been reported as being CP members by reliable informants. AARON SCHNEIDER, National Secretary, stated the growth of the Committee arose from the distribution of literature and door-to-door visits.

HARRY PIERCE, former chairman, reported 3500 persons were activated in the Los Angeles area during the clemency campaign. Approximately 20 area committees operated in 1953 in the Los Angeles city and county areas. The Southern California Trust Fund Committee was set up in late 1953 to secure funds for the ROSENBERG children and approximately \$10,000 was raised towards this fund. As of

January, 1954, the LARSC was reported to be "dying" due to lack of leadership and funds. Following the execution of the ROSENBERGS in June, 1953, the LACSJRC began a campaign to vindicate the names of JULIUS and ETHEL ROSENBERG and to free MORTON SOBELL from prison. Since early 1954 informants report Committee having difficulty securing support and funds. Committee has issued thousands of pieces of literature urging clemency for the ROSENBERGS.

I. ORIGIN, SCOPE AND ACTIVITIES

ORIGIN

At a Mid-West Conference on the ROSENBERG case held in Chicago, Illinois, under the auspices of the Chicago Committee to Secure Justice in the Rosenberg Case, on August 16 and 17, 1952, DAVID ALMAN, National Executive Secretary, stated that the LACSJRC was started by a Mrs. DAVIDSON. U

Informant advised on March 2, 1953, that the LACSJRC offices were now located in Room 404, 355 South Broadway, Los Angeles, California.

Dn May, 1954, informant advised that the LACSJRC was formed for the purpose of preventing the execution of

JULIUS and BTHEL ROSENBERG, who were sentenced to death on April 15, 1951, in the U. S. District Court, Southern District of New York, for conspiring to commit espionage by furnishing United States atomic secrets to the Government of the USSR. The LACSJEC was controlled and dominated by the LACEP

on all important issues from leaders of the IACCP.

On June 19, 1953, the ROSENBERGS were executed at Sing Sing Prison in New York State, after having been convicted of violation of the Espionage Act of 1917.U

Bhortly after the execution of the ROSENBERGS, the LACSJRC changed its name to the LARSC, and included in its campaign the plea for the release of MORTON SOBELL from prison. SOBELL was convicted along with the ROSENBERGS on charges of violation of the Espionage Act of 1917 and was sentenced to 30 years imprisonment.

Informant advised on May 13, 1954, that the LARSC is controlled and its leadership is dominated by the members of the LACCP. The LARSC receives advice and directives on all important issues from leaders of the LACCP.

This Committee's avowed purpose is to commemorate the memory of JULIUS and ETHEL ROSENBERG and to secure the release from prison of MORTON SOBELL, all of whom have been convicted in U. S. District Court, Southern District of New York, for violation of the Espionage Act of 1917, in that they conspired to transmit United States atomic data to the USSR. ()

SOPHIE DAVIDSON, as of December, 1949, was Blucational and Literature Director of the Sojourner Truth Club, West Jefferson Section, LACCP.



At a meeting of the LACSJRC held at the Embassy Auditorium, 9th Street and Grand Avenue, Los Angeles, California, on April 6, 1953, AARON SCHNEIDER, National

Secretary, stated that the most of the growth of the Committee was of an independent character arising from the distribution of literature in this case and home-to-home visits. He said he had received a letter from France signed by the Attorney General of France and generals of the Army, as well as members of Parliament. He also said he had received a letter from Berlin to the effect that "they" had dispatched 60,000 letters to President EISENHO ER. He further stated that he had received 5,000 postcards from Belgium.

He said that the major weakness in the campaign was the almost complete absence of trade union support in the United States but that in Europe the response was the broadest ever witnessed or in a case of this kind.

REID ROBINSON stated that there was "no point in kidding ourselves about this case." ROBINSON pointed out that the Sobell Case would never approach the proportions of the Rosenberg Case because SOBELL was not faced with death. He also pointed out that the LACSJRC had never had the support of the labor unions and that "it" would have to find a person in a union having a parallel case and to work with the union on this case to gain its support.


Local Scope

It was stated that it was necessary to give all these people additional ammunition to help them accomplish their job of reaching 100,000 new people, each of whom must raise his voice for the ROSENBERGS. These active workers must also raise money for 100,000 copies of a Pact Sheet on the Rosenberg Case and for newspaper, radio and television advertisements.





National Activities

The Committee recommended the following actions in behalf of elemency for the ROSENBERGS: (1) Contact all senators and congressmen, (2) Hold another White House vigil, (3) Apply pressure on the Pope.

At a meeting of the L. CSJEC

D.VE BROWN urged that one last effort be made to save the ROSENBERGS. DOROTHY N.RSH.LL requested suggestions for assisting the Committee. Among those offered were (1) Send representatives to Washington, D. C., to picket the White House, (2) Make person to person calls to President EISENHOWER. It was pointed out in the latter case that this would not cost anything because the call would not go directly to the President but would give the President an idea of how many persons wanted the death sentenced repealed.

DAN MARSHALL was the main speaker. MALSHALL claimed having read the transcript of the ROSENBERG trial many times without determining justification for the death sentence imposed and stated that the witnesses in the case were not reliable and that their testimony was poor and doubtful. M.RSHALL blamed "the war hysteria" for the plight of the ROSENBERGS. He added that a truce in Korea was imminent and concluded by stating that since the courts have denied all appeals only one action was left to save the ROSENBERGS and that was pressure from the people. He said that telegrams, letters and telephone calls must be sent to the President urging clemency.

At a meeting of the LACSJRC

outlined the tactics to be used in starting the campaign to free MORTON SOBELL from prison. He stated there were three problems confronting the committee: (1) SOBELL's unexplained flight to Mexico; (2) SOBELL's use of five aliases, and (3) the fact that SOBELL has never issued a public statement of his innocence as did the ROSENBERGS.

To meet these problems, ALMAN stated that the Committee will move cautiously. The SOBELL attorneys are opposed to going to the Supreme Court during the Fall Term because it is too soon after the executions and they feel that the Court will turn them down. The attorneys are also opposed to any campaign at this time calling for SOBELL's transfer from Alcatraz. ALMAN also stated that there are positive aspects to the SOBELL case to be exploited. First, the "kidnapping" from Mexico; Second, his harrassment; Third, his wife and two children. Around these factors it will be possible to build up a broad coalition, even bigger than was possible in the ROSENBERG case. It was decided at this meeting to use an enlarged Steering Committee to develop the Los Angeles campaign in line with ALMAN's

During a meeting of the LACSJRC
REID ROBINSON reported that the National Conference
in Chicago laid plans for a long fight to free MORTON
SOBELL. He reported that the policy would be to declare
SOBELL the victim of a frame-up; that while the National
Committee took a position that he was innocent, the appeal
for general support would be based on the allegation that
SOBELL should get a new trial and that there were grave

doubts as to his guilt. ROBINSON also stated that the fight to free SOBELL must be linked up with McCarthyism and the fight for Smith Act victims. He stated that this would develop naturally during the campaign.

REID ROBINSON stated that the National Committee had decided to (1) educate the people as to the facts in the SOBELL case; (2) bring all phases into the campaign, including industry and the professions; (3) distribute one million pieces of literature during the first six months; (4) get the best legal talents in the country to prepare the case to try to free SOBELL and to vindicate 8>0 the ROSENBERGS.

the LaCSJRC should be very careful not to become "sectarian" because they would void plans of saving the ROSENBERGS. She also cautioned that speakers should be very careful not to involve themselves in discussions of the McCarran-Walter Law.

At a meeting of the LACSJRC held at the Embassy Auditorium, Los Angeles, on April 6, 1953, MARON SCHNEIDER, National Secretary, pointed out that the U.S. Supreme Court might reach a decision on the ROSENBERG case during this week end and stated that this meant that those fighting for the ROSENBERGS must start that very night to work by telephone and every other way. He suggested:

(1) That the amicus brief petitions must be completed during this weekend; (2) that everyone must "shoot the works" on finances; (3) that the Committee must prepare for any eventuality on Monday in order to move into action; (4) that all people must be gotten together and go out with the amicus brief petitions on a call basis.

REID ROBINSON stated "Perhaps many of us do not know what amicus brief means... When you ask someone to sign the amicus brief you do not say it is for the purpose of supporting the ROSENBERGS, but you say you are a friend of the Court of the United States and that it is for the purpose of rectifying an error which may affect the whole judicial system." ROBINSON said further "Of course all of us here tonight are mostly interested in the ROSENBERGS, but we must have it in the back of our minds that it is for all Americans when we approach others."

Informant advised in May, 1953, of the organization of a Planning Committee for a Conference of Inquiry into the facts of the ROS: NBERG case. The informant stated that the purpose of the Conference is to obtain sponsors for the ROSENBERG clemency appeal from a broader level of the people.

At a meeting of the LACSIRC DAVE BROWN urged that one last effort be made to save the ROSENBERGS. DOROTHY MARSHALL received the following suggestions to assist in this effort:

- 1. Obtain a union work stoppage in the Los Angeles area.
- 2. Send representatives to Washington, D. C., to picket the White House.
- 3. Form a picket line in front of the Federal Building, Los Angeles.

4. Person-to-person calls to President EISENHOWER.


Informant advised on June 16, 1953, that the Los Angeles Committee for Protection of Foreign Born (LACPFB) has planned a 24 to 36 hour vigil in front of the Federal Building, Los Angeles, for June 17 and 18, 1953. The vigil would be in the form of a picket line.

Informant furnished a one-page Mimeographed "throw away" issued by the LACSJRC entitled "Stop ROSENBERG Executions". The pamphlet reflects that an interdenominational vigil would be held on June 16 and 17, to last 24 hours, on the steps of the Federal Building, Spring and Temple Streets, Los Angoles. The "throw away" urges leaders to wire President EISENHO Per for clemency. (Exhibit #5)

On March 2, 1954, informant furnished a letter on legal sized paper, headed "Dear Friend. This is an appeal for money." According to informant, these letters were widely distributed and attached to them were two \$10 defense coupons for MORTON SOBELL. He stated that it was intended that persons receiving these letters would return it for each coupon received and that through this means money would be realized for the continued operation of the LRSC.

ie also stated that the Committee worked jointly with the Civil Rights Committee (CRC), which sponsored picket lines.

The CRC has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

Since the execution of the ROSENBERS, a new spirit has developed and the possibilities for a strong fight for MORTON SOBELL are good.

Independent Progressive Party (IPP) did a wonderful job in getting signatures on the ROSEMBERG clemency petitions and will help on the SOBELL case.

He said that after the ROSENBERG executions all activities stopped. He stated that during the ROSENBERG campaign the Committee mailed out literature enclosing postcards for remailing similar to chain letters. He also stated that the Committee sponsored a public-participation radio program. 



According to information furnished by T-43 in April, 1950, Revenant STEPHEN FRITCHIAN was a member of the CP in Boston, Massachusetts.

A prayer meeting sponsored by the LaCSJRC was held at the Embassy Auditorium on June 17, 1953, to mourn the deaths of ETHEL and JULIUS ROSERBERG. Approximately 1,000 persons attended.

Reverend STEPHEN FRITCHMAN acted as Chairman and announced that members of the press would be permitted to attend on condition that no pictures would be taken. A prayer was offered for the ROSENBERGS. After this prayer



U. S. Government will keep putting on pressure "with their lies and false witnesses" because they know we are strong. We are not going to free MORTON as that is what they want us to do. We will not reopen the case, but will ask for a review of the case in order to obtain justice. The Government would not free MORTON because they would admit that they have murdered the ROSENBERGS. We will secure justice for the ROSENBERGS by proving to the people that the Government murdered ETHEL and JULIUS ROSENBERG.

A memorial meeting of the Rosenberg Committee was held at Park Manor on July 17, 1953. Approximately 1200 persons attended. The principal speakers were REID 800 ROBINSON and HORACE ALEXANDER.

ROBINSON spoke of the lack of support by labor in the ROSEMBERG case, stating labor must put forth more and more effort since the Government is trying to discorganize the Labor Movement.

ALEXANDER also spoke on the ROSENBERG case from the Negro's point of view, stating that the Negro knows what it means to be "double crossed" and "murdered". He stated that the "Jews" are being persecuted because of their stand for peace.



At a meeting of the Rosenberg Committee

BEN DREYFUS, Attorney from San Francisco, reviewed the ROSLNBERG case and that that it was up to the people to write Attorney General BROWNELL urging the transfer of MORTON SOBELL from Alcatraz Prison and to agree to a new trial for SOBELL.

REID ROBINSON stated "there is no point in kidding ourselves about this case". He said that many had stayed in the Committee "for a band ride" and that many others were here "to face the cold facts". ROBINSON pointed out that the SOBELL case would never approach the proportions of the ROSENBERG case because SOBELL was not faced with death.

Approximately 800 persons attended a meeting of the Southern California Trust Fund Committee held at the Embassy Auditorium on December 4, 1953.

EMANUEL BLOCH told how he, a stranger to the ROSENBERGS, had been entrusted as guardian to care for the ROSENBERGS! sons. He told of the mistreatment the children had received at the hands of the various school officials and other persons. BLOCH announced that he would head the National Trust Fund Committee.

NORMA ARONSON of the National Rosenberg - Sobell Committee spoke at a meeting

ARONSON commented regarding the "Fort Monmouth Spy Hoax" and stated that it was important to know that all concerned in that investigation were "Jews". She said that "the whole deal" was anti-Semetic. She stated that the National Committee had met with Senator LANGER of the Senate Judiciary Committee to prefer charges against the Attorney General's Office for obstructing justice.

ARONSON also said Senator LANGER was "sympathetic" and that "the Democrats and new dealers are to be used to good advantage in this matter." She stated that J. LDGAR HOOVER and the FBI were not above playing politics. She said that the European countries were behind the fight to vindicate the ROSLNBERGS and to free SOBELL.

ARONSON also stated that her purpose in coming to the West Coast at this time was to bring progress of the SOBELL case to all areas. She said that she would like to get in touch with the producers of "Salt of the Earth"; that the National Committee wanted to make a full length picture on the ROS NBL 6 case for exhibition in the United States and Europe.





DAN MARSHALL eulogized BLOCH as an attorney and characterized his death as being a result of personal persecution and harrassment by the Government, the press and the Bar Association.





The ROSENBERG memorial meeting sponsored by the LARSC was held at the Embassy Auditorium, 9th Street and Grand Avenue, Los Angeles, on June 18, 1954. The meeting was opened with a memorial tribute to the ROSENBERGS by a choral group. DAN MARSHALL acted as chairman and explained that the purpose of the meeting was to commemorate the first anniversary of the ROSENBERG executions, to prove their innocence and to secure justice for MORTON SOBELL.

ALBERT KAHN from New York city stated that the ROSENBERG case is neither closed nor forgetten but will be remembered for generations to come. He said that a nation-wide campaign telling the truth about what happened in the ROSENBERG trial is the key to the vindication of their innocence.

The "American Nightmare", a dramatic presentation based on the story of MORTON SOBELL concluded the program.

Two resolutions were presented and passed at this meeting: (1) That a request for the transfer of MORTON SOBELL from Alcatraz Prison be made; (2) that a demand for a new trial for MORTON SOBELL be prossed.

At the ROSENBERG memorial meeting held on June 18, 1954, at the Embassy Auditorium (supra), DAN M.RSHALL acted as chairman of the meeting. He read excerpts from an Annual Message of ABRAHAM LINCOLN of December, 1862. Among statements made by MARSHALL during this meeting are the following:


"The ROSENBERG case is our business. Innocents who were sent to their death are the business of the whole world. Everywhere people cried out to you - watch out - you judge yourselves in judging them. Everyday it was the whole Europe. They moved as one. Its masses, its priests, its cabinet members, its heads of state, to ask your president the simplest gesture of humanity. We know now what kind of weight we amount to in your scales. On one side you put the world, on the other side MC CARTHY. Then the ROSENBERGS sat on the electric chair the scales were down on the side of MC CARTHY. Your country is sick with fear, you are afraid of everything. You are afraid of one another. You are afraid of the shadows of your own bond."

Among the statements made by ALBERT KAHN were the following:

"This meeting and other meetings like it throughout the entire world give living proof to the fact that the
ROSENBERGS are not forgotten, nor will JULIUS and ETHEL
ROSENBERG ever be forgotten. There are some individuals
who ask why it is important now to prove the innocence of the
ROSENBERGS. Are we to forget that the ROSENBERGS were

killed so that their deaths might serve, in the words of JULIUS ROSENBERG, 'as a warning to all ordinary men and women that there are forces which hope to silence by death those who speak for peace and democracy. We are witnessing the degrading of man and his disintegration deliberately as a product of social disintegration. see spies and informers raised to the level of national heroes. We see a slick-haired degenerate in Washington associated with MC CARTHY boasting on the televised comic extra extravaganza of how he helped to murder the ROSENBERGS... e see a band of men who control the riches of the land seeking to aggrandize their wealth and power through the massacre of millions of men and women and children... He are here tonight to honor valor's wharfs in honoring JULIUS and ETHEL ROSENBERG and their valor as a special significance to all mankind and for us..."





He said that the men in Mexico making the arrest did not look like police and this method was used because the case was too weak to secure extradition.

At a meeting of the LACSJRC held at the Embassy Auditorium on February 12, 1953, Reverend STEPHEN FRITCHMAN stated that the objective of the Committee was to prevent the execution of the ROSENBERGS and to secure clemency for them.

The announcement reflects that the speakers were to be Dr. HAROLD C. "Defend all victims of the witch hunt. The Socialist Workers Party gives full support to the demand for clemency for the ROSENBERGS. They are victims of the witch hunt to silence all opposition to the drive towards World War III. The must not die. The death sentence is

designed to intensify and extend the attack upon militant workers and unions and political organizations. A labor movement can strike the most powerful blow at the witch hunt by coming out with a vigorous policy of protest and struggle against the judicial murder of the ROSENBERGS." (Exhibit 7)

The SWP has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

Turnished a one-page leaflet captioned "The ROSENBERGS Must Not Die", issued by the SVP. The leaflet announced a ROSENBERG Defense meeting to be held at 1702 East 4th Street on June 12, 1953, with speakers to be MAX GELDMAN, described as one of eighteen SWP members imprisoned under the "Smith Gag Act" for opposition to World War II; and ROSE KARSNER, described as a veteran of the International Labor Defense and Civil Rights Defense 670 Committees.

The leaflet further states:

"In an atmosphere of hysteria, the ROSENBERGS were convicted on unsubstantial evidence and the testimony of bought witnesses. The unprecedented death sentence is the result of a legal frameup and is a part of the McCarthyite witch hunt. Workers - This is your case - the drive against civil rights is part of the drive to crush labor with repressive legislation. Students - This is your case - McCarthyites are taking the witch hunt into the schools and colleges to intimidate teachers and suppress freedom of discussion." (Exhibit 8)



V. LITERATURE DISTRIBUTED

In early 1953, informant furnished a four-page panchlet issued by the LACSING and captioned "Perjury in the Rosenberg Case." The panchlet raised doubts on the testimony of DAVID GREENGLASS at the trial of the ROSENBERGS and states new documents reveal that the major witness lied. It also alleges that an FBI affidavit admits perjury. The pamphlet states that the ROSENBERGS were "offered a deal" by the United States Attorney Ceneral and if they (the ROSENBERGS) cooperated, their lives would be spared. (Exhibit 11)

Informant, on January 26, 1953, furnished cooles of "Petition for Clemency", which informant advised were being circulated by "progressive groups" in the Los Angeles area.


The petitions are in the form of a letter to President DMIGHT D. EISENHOWER and contain spaces for ten names and addresses of signers. The letter appeals for clemency for the ROSENBERGS, stating that new documents in the case have revealed that lirs. DAVID GREENGLASS has called her husband unworthy of belief and that DAVID GREENGLASS had admitted lying to the Government, the court and his family. (Exhibit 12)

Informant, on February 27, 1953, furnished a one-page printed leaflet captioned "An Appeal for Clemency". The leaflet contains statements from POPE PIUS XII, Dr. BERNARD M. LOOMER, Dean of the School of Theology, Chicago University, and Rabbi ABRAHAH CRONBACH regarding the clemency of appeal of the ROSENBERGS. It was issued by the LARSC. (Exhibit 13)



On April 17, 1953, informant furnished a four-page printed pamphlet entitled "Fact Sheet in the Rosenberg Case" issued by the LACSJRC.

The "Fact Cheet" attempts to raise doubts regarding the guilt of the ROSENBERGS and lists names of prominent persons who advocate clemency, including POPE PIUS XII, Dr. ALBERT EINSTEIN and Chief Justice JANES WOLFE of the Utah Supreme Court. (Exhibit 14)





On Nay 9, 1953, informant furnished a two-page mimeographed "News Letter" captioned Clemency for the ROSENBERGS" issued by the Los Angeles Rosenberg Committee.

The news letter reflects that 25,000 "New Yorkers" sttended a clemency rally at Randall's Island on May 3, 1953. It also reflects that JOSEFH BRAININ, National Chairman, spoke regarding a memorandum written by DAVID GREENGLASS which contradicts his testimony in the Rosenberg trial.

The news letter announced that an emergency meeting would be held on May 11th at the Park Manor, 607 South western Avenue. (Exhibit 15)




Informant furnished a four-page printed pamphlet "The Shocking Truth" on May 25, 1953. The pamphlet was issued by the LACSIRC and is in the form of an open letter to President DWIGHT D. EISENHOUER. It alleges that POPE PIUS' plea was concealed and charges that the Justice Department "criminally" kept the POPE's clemency appeal from reaching the President. It also accuses the Justice Department of being guilty of "conspiracy to commit a crime" against the ROSENBERGS and to perpetuate a "monstrous hoax" against the American people. The pamphlet concludes by listing what readers can do in behalf of the ROSENBERGS. (Exhibit 16)

In June, 1953, informant furnished a one page printed leaflet issued by the LACSJRC entitled "Parents to Die on Wedding Anniversary". The leaflet contains a letter from MICHEL ROSENBERG, son of the ROSENBERGS, to President EISENHOWER pleading for clemency. (Exhibit 17)

On June 12, 1953, informant furnished a four-page printed pamphlet captioned "Comments From the Jewish Press on Clemency for ETHEL and JULIUS ROSENBERG" issued by the National Committee to Secure Justice in the Rosenberg Case.



The pamphlet contains statements published in various Jewish publications regarding the clemency appeal of the ROSENEERGs. (Exhibit 18)

On June 12, 1953, informant furnished a four-page printed panishlet issued by the Los Angeles Rosenberg Committee captioned "Leading Rabbis of Israel Protest Rosenberg Death Sentence". The pamphlet is written in English and Yiddish and contains a statement by Rabbi Dr. MEYER SHARFF reflecting his support of the clemency campaign to save the lives of the ROSENBERGS. (Exhibit 19)



On September 4, 1953, informant furnished copies of a 48-page pamphlet captioned "The Rosenbergs--Their Story", issued by the LACSJRC. The pamphlet is described by GUY ENDORE in the preface as a Rosenberg Clemency Erochure. It describes the background of the ROSENBERGs, and the history of the ROSENBERG case. It also contains poems, death house letters, statements by prominent persons and other miscellaneous items, including an "Honor Roll". (Exhibit 20)
