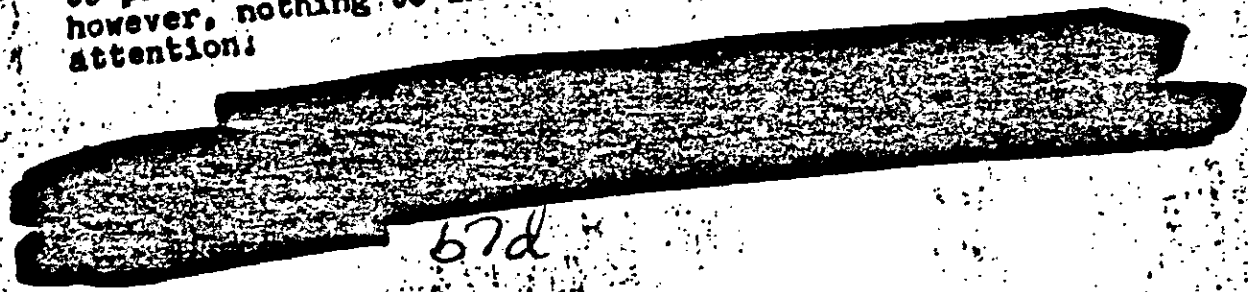



## EMMA LAZARUS CLUB OF WASHINGTON, D. C. (ELCW)

A source on June 16, 1951, furnished information reflecting that there was in existence in Washington, D. C., an organization of the Emma Lazarus Women's Division, Jewish People's Fraternal Order (JPFO), of the International Workers Order (IWO).

On April 5, 1961, a second source advised that the ELCW is an affiliate of the Emma Lazarus Federation of Jewish Women's Clubs (ELF), and that June Gordon, Executive Secretary of the ELF spoke at a ELCW meeting on that date.

During her speech, June Gordon stated that the activities of the ELF include the perpetuation of Jewish Culture, civil rights, opposition to the House Committee on Un-American Activities, and the need for a Statute of Limitations on the Walter-McCarran Immigration and Nationality Act.

EMMA LAZARUS FEDERATION OF

"The Jewish Fraternalist" dated October, 1947, self identified as the official publication of the Jewish People's Fraternal Order (JPFO) of the International Workers Order (IWO), on page 6, contained an article which reflected that the Emma Lazarus Division (ELD) of the JPFO was to hold its first national convention in New York City on November 15 and 16, 1947, after having been first established at a National Women's Conference called three years previously by the JPFO.

The "Morning Freiheit" on January 25, 1951, contained a report of the National Convention of the ELD of the JPFO which took place in New York City on January 20 and 21, 1951. At this convention it was noted that the ELD changed its name to Emma Lazarus Federation of Jewish Women's Clubs (ELF) and adopted a new constitution.

On May 15, 1962, a source advised that the ELF is one of several mass organizations comprising the Jewish cultural progressive movement. JUNE GORDON, ELF Executive Director, who is a member of the New York State Communist Party (CP) Board and Committee, is the leading force in the organization, whose leadership is largely made up of Communists.

The source stated that the ELF claims to be for peace and interested in protecting the rights of the foreign born. It is against the BEN GURION Government of Israel, bomb testing, anti-Semitism, Negro discrimination, and the rearmament of West Germany.

The source related that the ELF renders support to and receives support from the "Morning Freiheit" and other Jewish progressive organizations.

The source also stated that the ELF is recognized by the CP, USA, as an important progressive national organization of women.

The address of the national office of the ELF is 160 Fifth Avenue, Room 911, New York City.

The IWO and JPFO have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

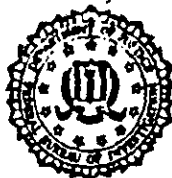

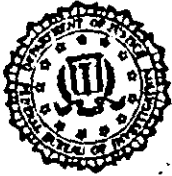



COMMITTEE TO SECURE JUSTICE

The CSJHS is identified in the Appendix.

On October 7, 1962, a source, who has furnished reliable information in the past, advised that Helen Sobell and members of her family planned on picketing in front of the White House, Washington, D.C., protesting the continued imprisonment of her husband, Horton.

On October 8, 1962, [REDACTED]

[REDACTED] had learned that Helen Sobell had contacted local Washington, D.C. newspapers and had told of her plans to picket the White House. b7d

A Special Agent of the Federal Bureau of Investigation observed on October 8, 1962, at approximately 11:37 a.m., that Helen Sobell, her son, Mark, her daughter, Sydney Prindle, and her mother-in-law, Rose Sobell, approached the Northwest gate of the White House and announced to the guard that they had written for an appointment with the President. They were told that this request had been denied. At 11:43 a.m., these four began picketing and carried placards with the following messages:

Rose Sobell:

"Mr. President, free my innocent son, Horton Sobell, on this Holy Day of Yom Kippur."

"Mr. President, 13 years ago my innocent son, Horton Sobell, who had been honored in work and school, was wrongly imprisoned."

Helen Sobell:

"Mr. President, end the persecution, free my innocent husband, Horton Sobell."

THE CASES

Mark Sobell:

"For thirteen years I have only seen my innocent father, Morton Sobell, in prison."

"Mr. President, on our Ten Zipper Day of prayer, give me back my innocent father, Morton Sobell."

Sydney Brindler:

"Noted Americans ask freedom for my father, Morton Sobell, 1100 clergymen, atomic scientist Dr. Harold C. Gray, U. S. Senator Lee H. Wiggin, Arthur James T. Farrell,

"World leaders urge my father's freedom. Bertrand Russell, Martin Luther, 50 members of the British Parliament, Jean-Paul Sartre, the Belgian Queen Mother, Pablo Picasso."

It was also observed that Aaron Katz was standing in the vicinity of the picket activity, but did not participate.

At approximately 2:02 p.m. the Sobell family ceased picketing and accompanied by Katz, departed from the area on foot.

[REDACTED] an admitted former member of the Communist Party (CP) in Washington, D.C. [REDACTED] on [REDACTED] identified Helen Curwitt (widow of the late, Mrs. Morton Sobell) as a member of the Education and Literature Committee of the CP in Washington, D.C. as of February 2, 1944. b7d

[REDACTED] advised during 1949 that the Sobell family had resided at this address from about July, 1941, to December, 1949. [REDACTED]

[REDACTED] although he believes that Sobell to be a CP member because of this, he could not confirm her as a member of the CP or a communist front organization. b7d

RE: KATZ

A second source, who has furnished reliable information in the past, on April 27, 1944, advised that Aaron Katz was a member of the CP for six years and had been transferred into the Entertainment Section of the CP on December 23, 1943. According to the informant, Katz held CP membership book number 31230 in 1944.

A third source, who has furnished reliable information in the past, advised Katz sat on the stage at the 49th Anniversary celebration of the CP-USA, held September 25, 1939, at Carnegie Hall, New York City.

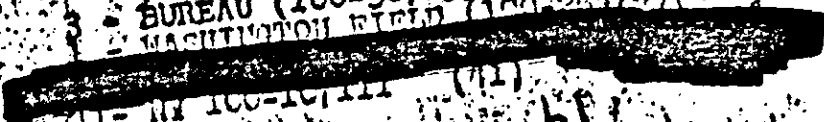

On [REDACTED] furnished information concerning a fund-raising dinner sponsored by the CSJMS, Syracuse Chapter, held on May 26, 1962, at the home of ELIZABETH ALLEN\* and JANE ANDERSON\* at Cazenovia, New York, with the principal speaker described as YURI SUHL, an author. b7d

Source stated that SUHL reviewed the MORTON SOBELL case for the benefit of new people who had become interested in the cause, and the source stated that approximately forty individuals were in attendance, [REDACTED] through a collection, as well as an auction which occurred during this function. b7d

Source concluded by stating that a new appeal was made for funds at this function, and inasmuch as SOBELL's appeal for parole was coming up in July, 1962, source stated the general feeling was one of pessimism concerning SOBELL's being paroled but, nevertheless, the organization in Syracuse would continue to fight on his behalf.

"Dear Friends:

"Early in July, Helen Sobell received word from the Parole Board that her husband's application for parole had been denied.

"All technical requirements such as a job, a highly-respected rabbi as his sponsor and so forth, had been fulfilled. It seems to many that the Parole Board Officials exhibited an almost inhuman callousness considering that Morton Sobell had already spent twelve years in prison for a crime which he has steadfastly maintained he never committed. Whether you believe him guilty or innocent you may wish to join the thousands of your fellow countrymen who feel he has already been punished enough.

"The president should now be asked to use his executive powers to grant clemency or to commute Morton Sobell's sentence to time served.

"Personal letters are most valuable. But we enclose a postcard which many busy people find it expedient to use. We hope you will take some action on behalf of justice so long deferred.

A confidential source advised on June 6, 1962, that the Syracuse Sobell Committee was still in existence and that Lillian Reiner was the titular head of this organization with ELSIE COHN, the Treasurer, and JANE ANDERSON and ELIZABETH ALLEN being Co-Secretaries of the Syracuse Sobell Committee.

Another confidential source advised on January 15, 1962, that the Syracuse, New York Chapter was one of the affiliates of the Committee to Secure Justice for Morton Sobell in the Eastern Region of the United States.

On July 2, 1962, another confidential source advised that the purposes and aims of the Syracuse Sobell Committee were, insofar as this source was concerned, the same as those of the National Committee to Secure Justice for Morton Sobell, namely, to continue to fight for the parole of MORTON SOBELL and to raise funds on his behalf to carry out this fight successfully.

Another confidential source advised as follows:

As of March 11, 1951, LILLIAN REINER was not known as a Communist Party member, but as Chairman of the American Labor Party at Syracuse, New York, she worked

They succeeded in capturing the Manhattan and Brooklyn Sections of the American Labor Party, but outside of New York City they have been unable to win control." 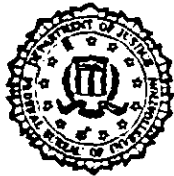

A source who has furnished reliable information in the past advised on October 30 and 31, 1962, that the Committee to Secure Justice for Morton Sobell held a meeting on the evening of October 29, 1962, at the International Student House, 1825 R Street, N. W., Washington, D. C. There were approximately forty people present. To the source's knowledge,

of favorable decisions in the case of initial parole hearings. She also said that when she began working for Morton's release, she wanted both his release and his vindication. Now she will settle for his release and work for vindication later on. She called on those present to attend the Parole Board hearing on October 30, 1962.

A movie was shown, the theme of which was an attempt to vindicate Morton Sobell. The film consisted of newsreel clips and interviews with individuals who contended that Sobell was innocent. Helen Sobell announced that the film was made by "distinguished members" of the film industry who would identify themselves after Morton Sobell was released. The film is about one month old. Helen said that she hoped to show the film on television and to make a special tape of the material in the film for radio presentation. She claimed each reel costs \$75 and that its presentation would cost "money."

It was suggested at the meeting that letters be written to the President and Attorney General requesting Sobell's release. No definite program of letter writing was set up, but Helen Sobell said it would be all right to write to the President as the Parole Board would probably get the letter.

## 16 Ask Board To Parole Spy Sobell

The United States Parole Board today began weighing testimony to decide whether Morton Sobell, imprisoned 12 years ago for conspiracy to commit espionage, should win his freedom.

The board, in its first hearing of the case yesterday, heard 16 witnesses testify 2½ hours on behalf of Mr. Sobell, sentenced to a 30-year prison term.

Last to appear was the convicted conspirator's 13-year-old son, Mark, who tearfully asked the board to send his father home. "My father is innocent," he said.

James C. Neagles, staff director, indicated it will be some time before a decision is reached.

Sobell was convicted of conspiring to pass wartime secrets to the Soviet Union. Two co-defendants, Julius and Ethel Rosenberg, were convicted and later executed for theft of atomic secrets. Sobell, however, was not linked to theft of data.

His case has roused opinion both in the United States and abroad. Mr. Sobell's supporters include Bertrand Russell, the British philosopher; French author Jean-Paul Sartre; cellist Pablo Casals; Israeli philosopher Martin Buber; American scientist Linus Pauling and author James T. Farrell.

"Dear Friend:

"MORTON SOBELL's application for parole has again been turned down. He had had letters of support from leading law professors, sociologists, criminologists, clergymen and writers. A job was waiting in accordance with requirements. A nationally known rabbi had agreed to become MORTON's parole advisor.

"We understand the parole rules say it is possible to ask for a review in 90 days and demand a hearing before the Board. This will be done.

"We suggest that you write a letter to President KENNEDY, protesting denial of parole. Be sure to send a copy of your letter to Committee to Secure Justice for MORTON SOBELL, 940 Broadway, New York 10, New York. This

"A motion picture was then shown which attempted to vindicate Morton Sobell. Helen said that it was made by distinguished members of the film industry who would identify themselves when Morton walked free. Helen said that the film was about a month old. It is composed mainly of news reel clips and interviews with 'distinguished' Americans who believe in Morton's innocence.

"After the film, a short question and answer session was held. Rabbi Horowitz said a few words on how he got interested in the case i. e., he was asked to research it for his Rabbinical Association. He requested that 'no man stand aside' and to do their part to support Morton. A collection was taken; the actual amount collected unknown; however, it probably amounted to between 50 and 75 dollars.

"Helen said that each reel cost \$75.00 and that the collection money would go toward the purchase of additional reels. It is hoped that this picture will be shown on T.V. and a special tape recording is being made for radio presentation. Sara Hammond said that as everyone knew this would be expensive.

"Someone said that it would be good idea if people started writing letters to the President or The Attorney General requesting that Sobell be pardoned. Helen said that it would be OK to write to the President because from his office the letters would be forwarded to the parole board. The letter writing was not stressed.

"Helen said that she would not give up hope. Previously she had asked for his vindication and release; however, she would now be happy with just his release, vindication would come later.

"Helen also said that it would have been very unusual if the parole board had granted Morton's release on his first appeal. Only 14% of all Federal prisoners are paroled and very few of them achieve their freedom on their first appeal. It appeared to the author that Helen did not expect the 10/30/62 appeal to the parole board to be successful and secure Morton's release."

This memorandum has been compared with the original statement and it is correct in substance.

All necessary action which should be taken in connection with this information has been taken.
