is attached hereto.

On page 6 of the November 29, 1962 issue of the  
"National Guardian" is a news item entitled, "Premiere of  
Sobell Film Scheduled December 3 in New York", which reports  
that the half hour documentary film, "Morton Sobell, A Plea  
for Justice", would be shown at the Village South Theater,  
15 Vandam Street, New York City, December 3, 1962 at  
5:30, 7:30 and 9:30 p.m.

A characterization of the "National  
Guardian" is attached hereto.

Sources, who have furnished reliable information  
in the past, advised on December 4, 1962, that three showings  
of the documentary film concerning the innocence of Morton  
Sobell took place at the Village South Theater, 15 Vandam  
Street, New York City on December 3, 1962. Prior to and  
subsequent to the showing of the 29 minute film, food and  
alcoholic beverages were served in a downstairs lounge at  
the theater. No admission charge was made for the showing  
of the film and it was announced that since the food and  
alcoholic beverages had been donated, there would be no  
charge for them. It was estimated that a maximum of 125  
persons were present in the theater and the downstairs  
lounge at any one time with approximately 80 individuals  
being present for each showing of the film. The majority  
of persons were estimated to be in the 55 plus age group  
and the appeal made during the reception in the lounge was  
to persons in that age group. This appeal centered on the

Fact that the Sobell children were fatherless as a result of his conviction. It was stated that the purpose of the showing was to raise money to purchase time for a showing of the film on a Washington, D.C. television station and an envelope was handed to each person entering in which it was expected each would put his contribution. Most persons present seemingly acknowledged the fact that Sobell was guilty but were hopeful for a reduction in sentence or pardon by the President.

**1. COMMITTEE TO SECURE JUSTICE  
FOR MORTON SOBELL**

"Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the 'Communist campaign assumed a different emphasis. Its major effort centered upon MORTON SOBELL,' the ROSENBERGS' codefendant. The National Committee to Secure Justice in the Rosenberg Case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953, and 'then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case'

("Guide to Subversive Organizations and Publications" dated December 1, 1961, issued by the House Committee on Un-American Activities, page 116.)

In September, 1954, the name "National Committee to Secure Justice for Morton Sobell" appeared on literature issued by the Committee. In March, 1955, the current name, "Committee to Secure Justice for Morton Sobell," first appeared on literature issued by the Committee.

The Address Telephone Directory for the Borough of Manhattan, New York City, as published by the New York Telephone Company, on April 9, 1962, lists the "Committee to Secure Justice for Morton Sobell" (CSJMS) as being located at 940 Broadway, New York, New York.

Although it denies having any affiliation with the Communist Party, it has manifested itself from the beginning as a virtual official propaganda arm of Soviet Russia.' 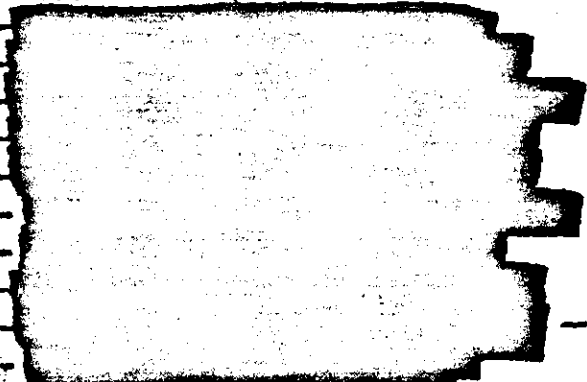

"Day by day, month by month, over the years, thousands of public-spirited citizens have urged Morton's release from prison. Each additional day of imprisonment compounds the terrible injustice in this case.

"The so-called scientific basis for this case - stealing atom bomb secrets - has been discredited, not only by scientists themselves, but by the facts of life in recent years - and the great scientific achievements which have taken place. The chief witness, David Greenglass, is a free man; his wife, an accused accomplice was never tried; neither was another chief witness, Max Elitcher who perjured himself. The one man involved in the trial, still alive, who has always sworn his innocence, is Morton Sobell - and he remains imprisoned by the authorities. On August 16, he will have been in prison 12 long, suffering years

"The Sobell Committee will immediately re-activate the clemency petition presented to the Justice Department last year. The power to exercise executive clemency clearly exists at this time and our attorney will proceed on this immediately. Another appeal will be made to the Parole Board in 90 days, as permitted by the rules. Our appeal for a new trial is still before the Court and will be pursued.

"Our committee pledge to continue our work, and to the end a National Conference will be held in September.

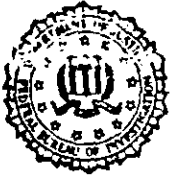

JULIUS and ETHEL ROSENBERG and MORTON SOBELL were convicted in the United States District Court, Southern District of New York, on March 29, 1951, on a charge of conspiracy to commit espionage on behalf of the Union of Soviet Socialist Republics (USSR). The ROSENBERGS were sentenced to death on April 5, 1951, and MORTON SOBELL was sentenced to 30 years imprisonment on the same date. JULIUS and ETHEL ROSENBERG were legally executed at Sing Sing Prison, Ossining, New York, on June 19, 1953. MORTON SOBELL is currently serving his sentence at the United States Penitentiary, Atlanta, Georgia.

On July 27, 1955, a source said a committee had been formed in Baltimore early in 1952 to urge clemency for the ROSENBERGS. In December, 1952, the Communist Party instructed that the committee be given all-out support by Communist Party members.

On May 15, 1958, another source stated the committee was last known as the Baltimore Sobell Committee and that GEORGE MEYERS, Acting Chairman of the CP of Maryland - D. C., claimed he tried to get the Baltimore Sobell Committee reactivated in the Fall of 1957.

The second source advised on August 8, 1960, that on August 1, 1960, GEORGE MEYERS, Chairman, CP, Maryland - D. C. District, stated that a Sobell Committee has been formed in Baltimore to get prominent people locally to write to the President of the United States requesting clemency for MORTON SOBELL.

Another source advised on September 27, 1960, that CP members in the Baltimore area are being urged to support this committee and the CP, Baltimore, has rendered financial aid to the committee.

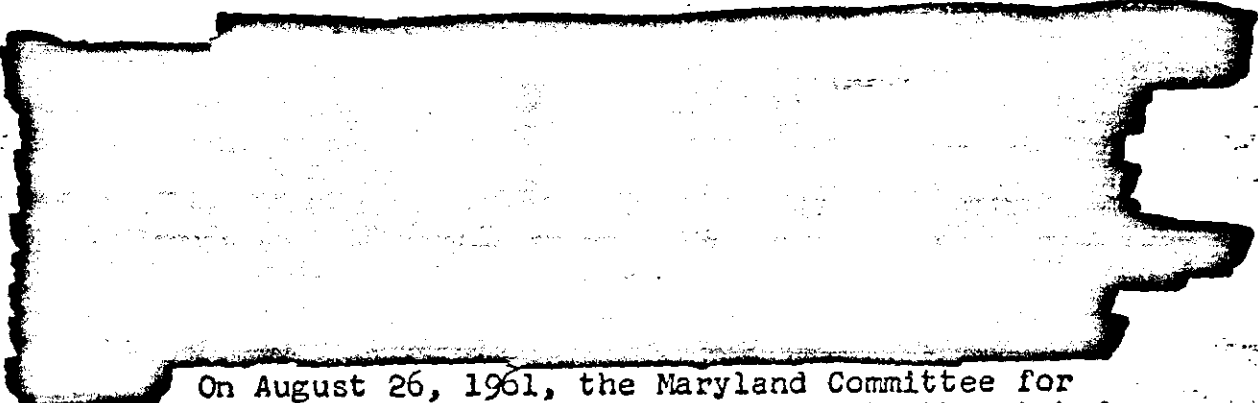

# Assail New Denial Of Sobell Parole

EMINENT persons throughout the world are condemning the new denial of parole for Morton Sobell that has come from the U.S. Parole Board in Washington. Sobell has maintained his innocence of the conspiracy to commit espionage charge on which he was condemned to 30 years.

Professor Thomas I. Emerson of the Yale Law School branded the denial of parole to Sobell, now in his 13th year of imprisonment, as the result of a policy that is "a disgrace to our democratic society." He said the only explanation was a general policy of the Parole Board to refuse parole to persons convicted of political offenses.

"President Kennedy," he asserted, "should appoint a commission of outstanding citizens to inquire into this practice and make recommendations for a more civilized policy."

Mrs. Morton Sobell, whose husband was tried together with Julius and Ethel Rosenberg, said she and her husband's mother, the 68-year-old Rose Sobell, had received letters from the Parole Board, January 7, containing the denial.

Sobell's health is a factor, since he has been suffering severe stomach discomfort, not alleviated by the gall bladder removal

operation which he underwent in prison. At Sobell's parole hearing on Oct. 30, 1962, a leading internist, Dr. Sidney Greenberg, Assistant Professor of Clinical Medicine at Cornell Medical School and member of the staff at Bellevue Hospital, expressed serious concern for Sobell's condition. The parole hearing was attended by eminent persons from across the United States, and letters recommending release had come from throughout the world. Sobell's conviction was denounced as unfair, based on flimsy testimony of a confessed perjurer, and the sentence called an outgrowth of the McCarthy era hysteria.

Writer Dwight MacDonald branded the parole denial as "disgraceful" and said: "The only reason for their action I can think of is a political one, since Mr. Sobell's record in prison and his prospects for a constructive living if he were released are of such a nature that if political prejudices were not involved, he would almost certainly have been granted parole."

Mrs. Sobell declared new appeals would be pressed to the Board and to President Kennedy. She called the denial "vindictive, inhuman and unjust." She said: "Just as the U.S. Attorney on Dec. 7 admitted that Ethel Rosenberg, 10 years after her death, was entitled to freedom or a new trial, so the vindictive, inhuman and unjust treatment of my husband will be condemned. To continue to gratuitously ruin the life of a man and his entire family is immoral. It can be justified under no circumstances."

Mrs. Sobell made public the following other comments:

Rebbi Philip Horowitz of Cleveland: "What a sad commentary, that an unquestionable criminal fares better than one whose conviction is based on political views? If only our President would act to right this wrong He would thereby silence the righteous indignation which will surely follow this denial of parole."

Rev. David Colwell, Pastor, First Congregational United Church of Christ, Chairman, Department of Church and Society, Council of Churches, National Capital Area, Washington, D. C.: "I am deeply disappointed in the denial of parole. It is hard to see how righteousness and justice are thus served. Surely, the image of American mercy and justice is hereby tarnished. The only recourse now open is in presidential clemency; I trust that Mr. Kennedy will act swiftly and surely."

Attorney William Kunstler of New York: "I feel it is a harsh and unjust epilogue to what I consider to be an equally harsh and unjust sentence."

Psychologist Tom Levin of New York: "I was most distressed to hear that the Parole Board was not able to recognize that the cause of justice and humanity in the Morton Sobell case would best be served by his release at this time."

The story reports that the CSJMS had scheduled a fund raising dinner at the restaurant in 1958 and as a result of public protest and pressure, the Tavern on the Green had cancelled the event. Details of the settlement were not revealed.

On page 6 of the July 23, 1962 issue of the "New York Post", a New York City newspaper, is a story entitled "U.S. Board Denies Sobell Parole, New Clemency Plea Expected" which reports that the Federal Parole Board in Washington, D.C., had turned down the parole application of MORTON SOBELL.

On page 22 of the October 30, 1962 issue of the "New York Post" is an article entitled "Sobell Release Asked by Bertrand Russell" which reports that the British philosopher, according to a CSJMS release, appealed to the President of the United States for the release of MORTON SOBELL on the grounds that he (MORTON SOBELL) had been the victim of "a vicious act of injustice".

On page 63 of the November 1, 1962 issue of the "New York Times" is a similar news story to the October 30, 1962 issue of the "New York Post".

Contained therein is a letter signed HELEN SOBELL which points out the rejection of MORTON SOBELL's application for parole and states that a National Conference of the CSJMS would be held in New York City on September 22-23, 1962. This letter requests suggestions as well as contributions by sent to the "National Office, Sobell Committee, 940 Broadway, New York 10, New York".

On page 8, column 2 of the August 7, 1962 issue of "The Worker" is a news article entitled "Damage Suit is Settled" which reports that the CSJMS had received \$1,350 as a settlement for an out-of-court agreement with the Tavern on the Green which had cancelled an April, 1958 fund raising dinner.

On page 2 of the September 10, 1962 issue of the "National Guardian" is an editorial article entitled "Report to Readers - The State of the Union" which is quoted in part as follows:

On page 10 of the October 15, 1962, issue of the "National Guardian" is a news article entitled "Sobell Vigil at UN October 17" which reports that an appeal to the UN urging international appeals for SOBELL's freedom would be held October 17 at the UN in New York City and would continue each day thereafter from 12 noon to 2:00 p.m.

On page 8 of the November 3, 1962 issue of the "National Guardian" is a news article entitled "Russell Backs Appeal for Parole of Sobell" which reports that Lord Bertrand Russell sent a message to the United States Parole Board in Washington, D.C. appealing for the release of MORTON SOBELL and charging that the sentence was "a vicious act of injustice in the tradition of judicial murders which have been prevalent at different periods of American history."

According to the article, Mrs. MORTON SOBELL presented a print of the film to the Federal Parole Board at a hearing held October 30, 1962.

On page 7 of the November 22, 1962 issue of the "National Guardian" is a news article entitled "Sobell Film Presented to United States Parole Board" which article reports that a motion picture documentary had been presented to the Federal Parole Board in connection with the application for parole of MORTON SOBELL. The article reports further that the film would be sent abroad for distribution as well as being made available for showing in movie houses and on TV in the United States.

On page 6 of the November 29, 1962 issue of the "National Guardian" is a news article entitled "Premiere of Sobell Film Scheduled December 3 in New York" which reports that the first public showing of the half hour SOBELL film would take place December 3 at the Village South Theater in New York City with showings at 5:30, 7:30 and 9:30 p.m.

On page 12, column 4 of the December 9, 1962 issue of "The Worker" is a news article entitled "Hear New Sobel Plea This Friday" which reports that the United States Court of Appeals for the Second Circuit would hear arguments on Friday, December 7 in the Federal Courthouse on the latest appeal by MORTON SOBELL. According to the article SOBELL asked the court to reverse a lower court decision and grant him freedom, a new trial or set aside his 30 year sentence as illegal.

'FRANK WILKINSON was called as a witness when he appeared in Atlanta as a representative of the Emergency Civil Liberties Committee to propagandize against the Committee on Un-American Activities and to protest its hearings. In 1956 WILKINSON was identified as a Communist Party member by a former FBI undercover agent within the party. Summoned at that time to answer the allegation, his reply to all questions was, "I am answering no questions of this

committee." This also became his stock reply to questions when he appeared during the Atlanta hearings. \* \* \* WILKINSON has since been convicted of contempt of Congress and sentenced to one year in jail.'

'Disputing the non-Communist claim of the organization, the committee finds that a number of other individuals connected with the ECLC also have been identified under oath as Communists.

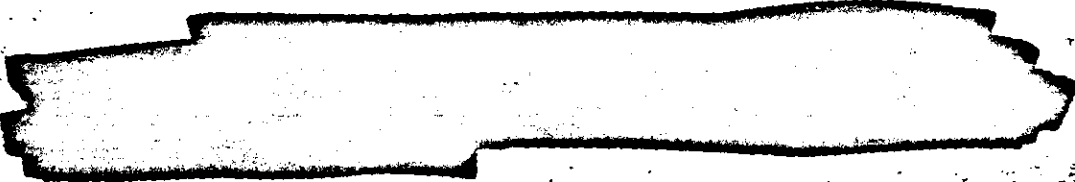

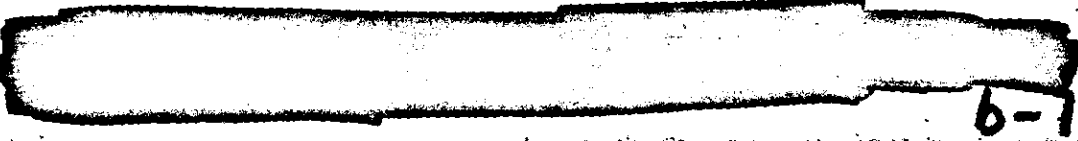

A characterization of the Committee  
to Secure Justice for Morton Sobell (CSJMS)  
is attached hereto.

On February 14, 1963, radio station WMCA,  
New York City, on its 11:00 p.m. program featuring  
radio announcer Barry Gray, featured for the first  
half of the program a public debate with Helen Sobell,  
wife of Morton Sobell; Stephen Love, retired professor  
of law from Chicago's University of Northwestern; and  
Roy A. Cohn, professor of law at New York Law School.  
and one of the Government prosecutors in the  
Rosenberg-Sobell case.

Helen Sobell introduced the debate by stating  
that Morton Sobell, who had been in prison for 13 years,  
had been unjustly accused, convicted and sentenced,  
and added that she was taking his case to the courts  
and to the people. Helen Sobell cited the fact that  
eminent law professors, clergymen and senators favored  
Sobell's release as proof of the injustice in his  
conviction and added that the United States Court of  
Appeals in a current decision stated that Ethel  
Rosenberg would have been entitled to a new trial  
were she to have been convicted today. Helen Sobell  
emphasized that she believed Ethel and Julius  
Rosenberg were completely innocent and unjustly  
executed. Helen Sobell finished her statement by  
advising of a February 27 meeting at the Community  
Church in New York City at which the following individuals  
would speak:

Helen Sobell completed her opening statement by stating that she did not have any hope for the release of Morton Sobell.

Stephen Love and Roy Cohn engaged in a spirited debate in which Love stated that he believed Morton Sobell to have been innocent, the sentence of 30 years to be excessive and the conviction to have been won by the government on the basis of anti-communist feeling and sentiment. Love stated that the facts in the case had never been considered either by the Court of Appeals or the United States Supreme Court. Cohn stated that Sobell had been convicted properly and despite the arguments raised by Sobell's attorneys, no evidence or argument had been found which was able to convince either the United States Court of Appeals or the Supreme Court, although defense arguments had been presented to both courts on at least 7 different occasions. Cohn summed up the activities of Morton Sobell as a member of the Communist Party since 1941, his attempts to recruit others into espionage, and his actual delivery of material to Julius Rosenberg. Cohn pointed out the fact that Sobell did not take the stand in his own defense although the opportunity was afforded him, and pointed out his flight to Mexico and attempts to obtain passage to socialist countries, utilizing fictitious names. Cohn summed up Sobell's defense attorneys' arguments as being a phony emotional appeal utilizing the names of distinguished people who were not aware of the facts.
