A. EVIDENCE THAT ORGANIZATION WAS IN EXISTENCE

In February, 1952, witnesses received, through the mail, propaganda material emanating from the National Committee to Secure Justice in the Rosenberg Case, 246 Fifth Avenue, New York 1, N. Y. Each witness received one copy of the 32-page pamphlet entitled "To Secure Justice in the Rosenberg Case" by WILLIAM A. REUBEN. In addition, each witness received one copy of a mimeographed cover letter bearing the signature of JOSEPH BRAININ, the signature also being mimeographed.

Mrs. JANE HODES, 398 Broadway, New Orleans, Louisiana, called on the witness at his place of business in February, 1952. She had with her some pamphlets written by WILLIAM A. REUBEN entitled "To Secure Justice in the Rosenberg Case." Mrs. HODES discussed the ROSENBERG case with the witness. From talking to her and from reading the pamphlet, he believed it entirely possible that the ROSENBERGS had not received complete justice and were possibly being "railroaded" because they were Jewish. He, therefore, gave JANE HODES a donation of \$2.00 to be used in the defense of the ROSENBERGS. She dealt with him about one-

half dozen pamphlets and asked that he pass them out to anyone apparently interested and that he endeavor also to secure donations from any such person. About a week after she left the pamphlets, Mrs. HODES returned to [REDACTED] again. At that time he told her that he had approached a few people about contributing money in behalf of the ROSENBERGS but his suggestions had not been well received and no donations had been secured by him. HODES then stated that she had received \$25.00 for the cause. JANE HODES recontacted the witness on March 21, 1952, when she came [REDACTED] seeking another donation from him for the defense of the ROSENBERGS. On this date the witness initially declined to contribute, stating to Mrs. HODES that he was not sure that contributing to the ROSENBERGS' defense was the proper thing for him to do. Mrs. HODES seemed to feel so bad about the witness' apparent change in attitude that he finally gave her a \$5.00 donation [REDACTED]

JANE HODES on March 21, 1952, related that the appeals court had upheld the conviction and sentence of JULIUS and ETHEL ROSENBERG but the Committee to Secure Justice in the Rosenberg Case was still fighting the conviction and had countered with a mass meeting in New York City. HODES stated that "we" feel the conviction and sentence are unfair and unduly severe and that the case would not have resulted thus "in another political atmosphere."

JANE HODES on April 3, 1952, attended a meeting of an interfaith group known as the Peace Education Committee set up by the New Orleans Meeting, Religious Society of Friends (Quakers). She neither said nor did anything to draw attention to herself until just before the meeting broke up. She then made a statement about ETHEL and JULIUS ROSENBERG and the fact that they had been convicted of espionage in behalf of the Soviet Union and were sentenced to die. She told the group that the ROSENBERGS were "for peace" and that unless the verdict against them was somehow changed, those present and all others in the United States who are "for peace" were in danger of going to the gallows. Mrs. HODES, upon being told that the group did not

know very much about the ROSENBERG case, said that she had just that morning received a letter about the case. She opened her handbag, produced several copies of the booklet, "To Secure Justice in the Rosenberg Case" by WILLIAM A. REUBEN, and gave one of the pamphlets to each of those present.

On the evening of [REDACTED] at the invitation of JANE HODES, a group of about fifteen persons gathered at her home and witnessed a showing of a motion picture film entitled "Peace Will Win" which was produced by the Warsaw Information Bureau. The film was Communist propaganda dealing with the peace conference which started at Sheffield, England, in 1950 and was transferred to Warsaw, Poland. Among those present that evening was a Mr. LIEBERMAN, who was a house guest at the home of Dr. and Mrs. HODES, and LIEBERMAN stated he was from New York City. LIEBERMAN did not have very much to say and the HODESES seemed to be "keeping him under wraps." At the conclusion of the motion picture, LIEBERMAN commented on what a splendid film it was and he commented also on what a struggle the people of Russia and her neighboring nations were waging for peace.

An individual answering the physical description of HENRY LIEBERMAN, as furnished by [REDACTED] secured luggage from the station wagon and proceeded into the HODES residence via the back door. The above-described station wagon was seen at the HODES residence on subsequent dates, April 17 through April 19, 1952. b-7-0

On the evening of [REDACTED] witness attended a meeting at the home of JANE and ROBERT HODES, the purpose of which was the showing of a film based on the Warsaw Peace Conference of 1950 and to introduce a Mr. HENRY LIEBERMAN who spoke in behalf of the National Committee to Secure Justice in the Rosenberg Case. LIEBERMAN was introduced after the showing of the film. He announced that he had taken a month off from his job to travel throughout the country and form local committees in behalf of the ROSENBERGS. LIEBERMAN advanced the claim that the ROSENBERGS were being persecuted for what they thought and not for what they did. He stated that the case concerned all because no one could tell who would be attacked next. b7d

On the night of [REDACTED] witness was among those present at a gathering at the home of JANE and ROBERT HODES, 398 Broadway, New Orleans. A motion picture was shown concerning the Warsaw Peace Conference. After the showing of the film, JANE HODES introduced a Mr. LIEBERMAN who, she indicated, was a guest at the house and who would talk to the group about the ROSENBERG case. LIEBERMAN based his talk on the pamphlet "To Secure Justice in the Rosenberg Case" by WILLIAM A. REUBEN. He told the gathering that the ROSENBERGS felt as he himself felt and a million other American people, saying "We want peace not war and if the ROSENBERGS are going to be put to death for that, it is time that we who are still free do something about it." LIEBERMAN said that he thought a committee should be set up in New Orleans and be in contact with the National Committee to Secure Justice in the Rosenberg Case. ROBERT HODES interrupted at this point and stated that the setting up of a local committee in behalf of the ROSENBERGS would be taken care of later. ROBERT HODES then told the gathering that Mr. LIEBERMAN had been

A. I. Evidence Showing Origin of Organization

On April 17, 1952, a meeting of the SLCSJRC was held at the Italian Fraternal Hall, 626 North Vandeventer, St. Louis, Missouri, at 8:30 p.m. The principal speaker at this meeting was DAVID ALMAN. The meeting was chaired by SOL DERMAN. The informant estimated that some twenty-five or thirty persons were in attendance.

DAVID AIDMAN stated that he and five other friends of the ROSENBERGS had originated the NCSJRC and had met with great success, not only in the United States, but abroad as well. He pointed out that the ROSENBERG mass meetings were being held everywhere along with petitions being sent to the Supreme Court.

2. A. Extent to Which Organization Funds, Resources and Personnel Are Utilized to Promote Objectives of the Communist Party

The specific objective of the SLCSJRC has been to prevent the execution of the ROSENBERGs. The personnel, funds and resources of the organization are directed to this end. As evidenced throughout previous sections in this letter, the CP and CP front organizations in St. Louis have assisted in this objective.

2. B. Extent Which Policy of and Positions Taken by the Organization Do Not Deviate from the Communist Party Line

Daily Worker, April 9, 1951, Page 1 (Editorial)  
"The brutality of Judge Kaufman's death sentence in this so-called 'judicial process' staged amid hysteria with no other evidence but the uncorroborated word of government witnesses is an effort to make people realize what they refuse to realize. That is, that they must view war with the Soviet Union as 'inevitable' or be considered 'potential spies' and 'saboteurs'".

"Ethel and Julius Rosenberg were indicted in 1950 charged with giving atomic secrets to Russia in 1944, when she was our war-time ally. They have maintained that they did not do it. They were sentenced to die in the electric chair. Many Americans believe there is grave and reasonable doubt about their guilt. They were convicted on the unsupported

testimony of David Greenglass, a confessed spy. Now an FBI agent has bestified under oath that some of the evidence was perjured."

"Already there are grave doubts about the fairness of the Rosenberg trial. An FBI Agent has testified under oath that the government knowingly used perjured testimony. Shall we wake up to find the Rosenbergs are innocent - but too late. It would be better to let them live at prison so that if they are not guilty they will have a chance to prove it."

It is to be noted that portions of pamphlets and publications issued by the NCSJRC in New York evidencing adherence to the CP line are not being herein set out inasmuch as instant publications have already been documented and it is presumed that the New York Office already has copies of same.

St. Louis Security Informants have advised the SLCSJRC has emphasized the racial discrimination aspect of the case against the ROSENBERGS and it is the principle contention of this group that the death sentence for the ROSENBERGS is too severe. No appropriate quotation from the "CP Line" file could be found to compare these two features of the St. Louis ROSENBERG Committee campaign.

A. I. Evidence Showing Origin of Organization

On April 17, 1952, a meeting of the SLCSJRC was held at the Italian Fraternal Hall, 626 North Vandeventer, St. Louis, Missouri, at 8:30 p.m. The principal speaker at this meeting was DAVID ALMAN. The meeting was chaired by SOL DERMAN. The informant estimated that some twenty-five or thirty persons were in attendance.

DAVID AIDMAN stated that he and five other friends of the ROSENBERGS had originated the NCSJRC and had met with great success, not only in the United States, but abroad as well. He stated that funds were now being collected to enable this case to be carried to the Supreme Court for the support of the ROSENBERG children, and last but not least, in order to send the wife of MARTIN SOBELL to Europe to speak in France, England, and Italy in behalf of her husband and the ROSENBERGS. He alleged that the Government had never proven that the ROSENBERGS were Communists and stated that he knew they were not because he had lived next door to them for a long time. He alleged that the ROSENBERGS had not been afforded a fair trial for the reason that they were Jewish. AIDMAN stated that the problem at present was to obtain a new trial based on the fact that the trial on which they were convicted was unfair and the verdict thereof was the result of hysteria. He pointed out that the ROSENBERG mass meetings were being held everywhere along with petitions being sent to the Supreme Court.

DOUGLAS MAC LEOD spoke and attempted to show that the trials in Foley Square, as well as other current trials, including the ROSENBERG one, were all in violation of the Constitution as were the Smith Act and the McCarran Act.
