#### Getting Started

To assist you in your investigations, I am enclosing what is called a CD, or compact disc — an amazing little device that effectively storehouses large amounts of information onto a small silver platter.

On this disc, you are provided with recordings of Holmes' and my introductions to the cases. In addition, you have access to all of the resources we had at our disposal during the time of our original inquiries.

In the following steps, I've listed for you the brief instructions you need to make use of the enclosed CD:

- 1. Set up your Sega CD and Genesis™ systems and plug in control pad 1. Turn on your TV or monitor, and then turn on the Genesis.
- 2. Place *Sherlock Holmes* CD A into the disc tray, label side up. Close the tray.
- 3. If the Sega CD logo is on screen, press **Start** to begin. If the Control Panel is on screen, move the cursor to the CD-ROM button, then press **Button A**, **B** or C. The Sega screen will appear, followed by the Title screen.
- 4. Press Start to begin.
- 5. When prompted, insert *Sherlock Holmes* CD B into the disc tray to continue your investigations.

**P.S.** If the CD is already in the machine when you turn it on, the game will begin automatically after a few moments.

Holmes' Table of Contents Begin your investigations at the Table of Contents. To make use of any item, move Holmes' pipe stem to the relevant box on the left and press **Button A**.

#### The Instructions

This item takes you to a list of Holmes' and my tools of the trade. To hear information about any tool, move Holmes' pipe stem over it and press **Button A**. You may also turn to pages 8 to 11 of this report for my rendition of each tool's benefit and use.

#### Holmes' Introduction

Holmes speaks on the subject of detecting and detection methods. For instructions on controlling this cinema-like scene, please see page 5. From this scene you may go on to the People & Places screen, from which you can obtain brief information about important persons and locales. To hear each profile, move Holmes' pipe stem to your choice and press **Button A**.

#### The Cases

Three of Holmes' most puzzling adventures are offered for your examination and solution. Choose any one to begin your investigations. For instructions on controlling the cinema-like scenes in each case, please see page 5.

#### Load and Save

If you must discontinue a case, you may preserve your inquiries, and resume them at a later date. Please refer to page 16 for details.

Using the Video Buttons Cinema-like scenes occur throughout your investigations, while you are traveling, and during Holmes' Introduction. Use the video buttons at the bottom of the screen to control these scenes. Move Holmes' pipe stem to the button you want and press **Button A**.

#### **Top Row Buttons**

- ✓ Start Over: The first button on the left starts the scene from the beginning.
- ✓ Play: The second button from the left resumes a scene after pausing, rewinding or fast forwarding.
- ✓ Pause: The second button from the right pauses the scene; select the button again to resume playback.
- ✓ Exit: During a case, the button to the far right takes you to the Map of London, from which you can choose one of our tools of the trade. During Holmes' Introduction, this button takes you to the People & Places screen.

#### **Second Row Buttons**

- ✓ Rewind: The button on the left speeds backward through the scene.
- ✓ Fast Forward: The button on the right speeds forward through the scene.

**H.R.** Murray's expertise as Head Chemist provides valuable connections between physical evidence and the criminal event.

**Disraeli O'Brian**, head clerk of the Office of Records, is a virtual encyclopedia of state papers and legal records.

Langdale Pike, gossip columnist, is a colorful character who renders full-toned descriptions of the noteworthy of London.

**Porky Shinwell**, proprietor of The Raven and The Rat, caters to patrons whose ears are tuned to the dealings of the underworld.

The **London Library** possesses a remarkable collection of reference works that may prove useful in your investigations.


At **Scotland Yard**, Inspector Lestrade is useful for his acquisition of inaccessible information.

Somerset House holds a sizable assemblage of files on births, deaths and marriages, as well as testaments and wills.

#### Tools of the Trade

Available to you are a number of resources, described in this section and represented on the game screen by small pictures called *icons*.

To requisition a tool, first select the Exit video button during any video scene. When the Map of London appears, move Holmes' pipe so that its stem points to the icon you want. Then press **Button A**.





#### Holmes' Book

Choose this icon to return to the Table of Contents. If you happen to see this book lying on a table or mantle, selecting it then also returns you to the Table of Contents.



#### Notebook

Copy the names of people and places you want to investigate into this handy reminder. To select an item, move Holmes' pipe stem to it and press **Button A**.

- ✓ To choose a person or place in the Notebook, select the name. Then select the icon for Travel, Holmes' Files or the Baker Street Irregulars to learn about that person or place.
- ✓ To page through the Notebook, select its lower-right corner.
- ✓ To copy a name into the Notebook, choose an entry from the Directory (see page 9), then select the Notebook icon. If the entry is already in the Notebook, it will be accessed automatically.
- ✓ To close the Notebook, select its lower-left corner, or choose another tool.



#### Directory

Look in this reference for the people and places of Holmes' London. Or, place your selection in the Notebook for future reference. To select an item, move Holmes' pipe stem to it and press **Button A**.

- ✓ To choose a name in the Directory, select the tab with the first letter of the person's last name, or select the name of your choice. Then select the icon for Travel, Holmes' Files or the Baker Street Irregulars to learn about that person or place.
- ✓ To page forward through the Directory, select the tab at its lower-right edge. To page backward, select the tab at its lower-left edge.
- ✓ To close the Directory, select the gold bar at the top, or choose another tool.



#### Newspaper

Scan *The Times* of London for start-up clues of the case. To select an item, move Holmes' pipe stem to it and press **Button A**.

- Choose the Newspaper icon to see a dated index of relevant issues. Select the box to the right of any date to see the actual issue.
- To turn the pages of an issue, select its upperright corner.
- ✓ To read an article, first select it from the issue. Then press Button A again to enlarge it. Select any one of the four large lenses at the bottom of the article to magnify its sections.
- ✓ To close an article, select the small lens at the lower left.
- ✓ To close an issue, select its upper-left corner.
- ✓ To close the Newspaper list, select the box in the lower-left corner, or choose another tool.
- ✓ Use the printed issues of *The Times* to locate articles in hard copy. Select the issue of your choice and flip through it until you find the article you need.



#### Horse & Carriage

Hop in your horse and carriage to view actual cinema-quality interviews with witnesses, suspects and other leads. Use the video buttons as described on page 5 to control the scenes. Please remember that the Travel icon becomes available only after you choose a name from the Notebook or Directory.



#### Holmes' Files

Pull up background information and notes of interest. You may review a file on almost every name listed in the London Directory. Please remember that the icon for Holmes' Files becomes available only after you choose a name from the Notebook or Directory.



#### **Baker Street Irregulars**

Gather inside information on the people and places of London from Sherlock's special group of street watchers. Please remember that the Baker Street Irregulars icon becomes available only after you choose a name from the Notebook or Directory.

#### Scoring and Trial

As an aspiring detective, you must cultivate three qualities: 1) the power of observation, 2) the power of deduction, and 3) a broad base of precise knowledge.

To test your skills of detection, you will be given an undisclosed number of points for each new clue you uncover. The fewer resources you use, the lower your score will be. Your objective is to gain the most information from the least number of resources.



When you think you've solved the case, select the Trial icon. If you have not collected all the critical clues, you will find yourself back at the Map to continue your investigation. But once you enter the Courtroom, listen carefully to the Judge's questions.

- ✓ To answer a question that requires the name of a person or place, open the Directory or the Notebook and select the name of your choice.
- ✓ To answer a multiple choice question, select your response.
- ✓ To answer before the Judge completes a question, select the Map icon and press **Button A** to skip to the answer menu.
- ✓ To leave the courtroom, press Start. You can continue your investigation and return when you have more clues.

If you answer each question correctly, you can match your score against the master sleuth's. Then, you may choose to view a cinema of Holmes' strategy and solution to the case.

#### Game Saving and Loading

You may be called away during the course of your investigations. At such times, you have the option of filing your case progress and score, and reopening them at a later time.

- ✓ To save a game, make sure that your Sega CD's Internal RAM has been formatted. (This is explained in your Sega CD manual.) Then, go to the Table of Contents Menu and select the game you want to Save. A message will appear automatically telling you that your game is being saved.
- ✓ To load a saved game, select Load from the Table of Contents, and then choose the game you want to resume. If you reset and select a case from the Table of Contents, the system will automatically load the last game you played.

#### Handling Your Compact Disc

- ✓ The Sega CD compact disc is intended for use exclusively on the Sega CD system.
- Avoid bending the compact disc. Do not touch, smudge or scratch its surface.




