Hi Mike,

Yes. Attached are the completed surveys that I've received.

I did some additional research on the custom containers (the photo I sent you) and they don't come like that. They would be plain and would not look like the photo. I've also done research with some other companies to see if there were other options. However, most of those were only wholesalers (sales only) or rentals of office or classrooms.

I've met with Rica and have identified a possible location, but she asked me to identify how much power they would need as the power supply in that location is limited. The company stated that they only supply the plugs and the actual amount of power used would be dependent on what gets plugged in. (perhaps we could implement a LED only policy) I'm not sure if your engineers would like that answer.

Rica took measurements of the area. I'm not sure how many 20' x 8' foot containers would fit into the area.

The other issue to overcome is relating to permitting. I have a call into David Roberts to see if he can help with this. Plus, all those people in the room all said they were there to help. I think I would rather start with David. I think the City Council office should take the lead on that part.

One other option that I am pursuing is the concept of Steel Craft.

I'm going to take them to Eric's empty lot on 6th and Pacific Ave. first, but I don't know if that location will meet their parking requirements. Let me know if you like this idea and if you would like to join us.

I didn't want to circle back with the POC tenants until I had a viable alternative to offer them. Additionally, I'm not sure if any of this would work without a strong food element.
