Lorena,

As stated in the San Pedro Historic Waterfront District Annual Planning Report for 2012:
The PBID will create a plan in 2012 to address the needs of the less fortunate who have challenges securing permanent housing within our district.

Regarding my request for the text of this plan - the document you sent states:

*To effectively address issues that arise from the transient and homeless population in the District boundaries, **the PBID will fund homeless service coordination**. Coordination and referral services that are provided by various social service organizations will improve the effectiveness of the District's services. The District will facilitate the presence of social service agencies dedicated to assisting the homeless.*

In your prior email regarding this issue you told me that homeless services are not a line item in the PBID budget. There is a serious gap between the PBID management plan that states that homeless services will be funded by the PBID, and your recent statement that, "Security officers provide referral service to Harbor Interfaith".

Also, looking at the BID financials for 2008 to 2012, the BID budgeted \$92,849 for homeless services but only spent \$20,000 of that amount, and then relocated the unspent homeless funds into other line items (see documentation below).

I would like an explanation of why this would not be considered a misappropriation of funds, and a violation of your charter with the City of Los Angeles.

The proposed District will fund improvements and activities authorized under the Law. Specifically, **the District will provide services in the following categories:** (a). visitor & tourist ambassador service;
(b). maintenance, sanitation, & beautification;
(c). marketing, promotions, and waterfront special events;
(d). new business attraction for downtown & waterfront;
(e). homeless services coordination;
(f). policy development, district management, and administration.

IV. PROPOSED PBID SERVICE PLAN - 2008 THROUGH 2012
The District will provide the following services to the extent consistent with the provisions of the Law: (a). visitor & tourist ambassador service;
(b). maintenance, sanitation, & beautification; (c). marketing, promotions, &

waterfront special events; (d).
 new business attraction for downtown & waterfront; **(e).
 homeless services coordination;**
 and, (f). policy development, district management, and
 administration. These services
 and a multi-year budget for them are described in greater
 detail below.

E. HOMELESS SERVICES COORDINATION

To effectively address issues that arise from the large transient
 and homeless
 population in the Downtown and waterfront area, **the PBID
 will allocate a portion
 of its budget to funding homeless services coordination
 services.** Coordination
 and referral of services that are provided by various social
 services organizations
 will improve their effectiveness. The PBID will facilitate the
 presence of these
 social services agencies dedicated to assisting the homeless
 such as those
 currently populating the various Port of Los Angeles, public
 agency, and private
 properties located within the PBID area. The PBID may provide
 the needed
 coordination by hiring a coordinator position, or using a
 contractor, or working
 through an independent social service agency.

SUMMARY OF PROPOSED MODIFICATIONS

The District's Owner's Association, the San Pedro Property Owners Alliance, has approved an Annual Planning Report for 2012 which proposes to modify the District's distribution of funds within the District's current budget categories.

Beginning in 2012, the Policy Development, Management and Administrative; Office, Insurance, Accounting; and the **Homeless Services** categories **will be reduced**.

Funds taken from these three budget categories will be added, along with carry over revenue unused from previous years, to the: Maintenance, Sanitation & Beautification (to be renamed: "Cleaning, Sanitation & Beautification; Marketing, Promotions & Special Event; and the New Business Development) categories.

2013 BID Management Plan

The SPHWBID will provide services to individually-assessed parcels within the District. Services will not be provided outside the District boundaries. **The services which will provide special benefit to individually-assessed parcels may include**, but are not limited to:

Pedestrian and tourist ambassador services;
Sanitation, cleaning, and beautification;
Marketing, promotions and waterfront special events;
New business attraction for the district;
Homeless services coordination;
Policy development, District management, and administration.

To effectively address issues that arise from the transient and homeless population in the District boundaries, the PBID will fund homeless service coordination. Coordination and referral services that are provided by various social service organizations will improve the effectiveness of the District's services. **The District will facilitate the presence of social service agencies dedicated to assisting the homeless.**

These services will specially benefit individually-assessed parcels by creating a safer environment and enhancing pedestrians' perceptions of comfort and safety, thereby increasing commerce on those parcels.
