Under restaurants & Cafes please remove: Marina Bar & Grill, Candy Town, Boardwalk Café and Dreyers and remove the entire Shopping and Gifts & Retail section.

You may have to update some of the photos, I'm not sure?

Also, as I mentioned to you, Sampson Way will be closed and the new road open probably the 2<sup>nd</sup> week of October. If it's OK with you, I'm thinking that the red trolley will have to make it's Maritime Museum stop on Harbor right before 6<sup>th</sup> Street (at the bus stop). You'll need to move the trolley signage over to that bus stop and please see the attached drawing for a detailed explanation.
