vi. In addition, if any director shall fail to attend three (3) consecutive regular meetings of the board of directors, without approved leave of absence by the president, then such director shall be deemed to have automatically resigned and the vacancy may be filled for the balance of the unexpired term by an eligible person appointed by the board of directors. Any such automatic resignation shall be announced at the next board meeting and may be reviewed by the board of directors only at the next board meeting, and, if not challenged by a majority of the board then present, the automatic resignation shall be deemed reasonable, final, and not subject to subsequent review.
