Hi Sandra,

LAMC Chapter 11, Article 5, Section 115.05:

It shall be unlawful for any person, other than personnel of law enforcement or governmental agencies, or permittees duly authorized to use the same pursuant to Sec. 103.111 of this Code, to install, use, or operate within the City a loudspeaker or sound amplifying equipment..."

People may not like this answer, and I can understand why, so if it applies I would point out that we are working within the LAMC provisions anyway:

-Between the hours of 7:01AM and 9:59PM in commercial zones.

-Within those hours, the sound can be as loud as needed as long as it can not be heard "in excess" 200 feet from the sound equipment (this is purposefully vague language)

But yea, we're the government, and this event is open to the public and therefore a public benefit. We are at least two removes away from breaking any sort of noise rules.

Hope that helps! Let me know if this man continues to push back.
