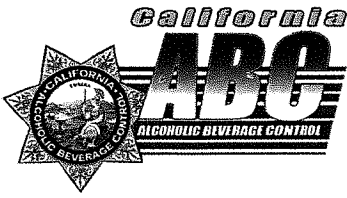

For issuance of a *Daily General License*

Under the Alcoholic Beverage Control Act

PETITION FOR CONDITIONAL LICENSE

WHEREAS, petitioners have filed an application for the issuance of the above-referred to license, for the above-mentioned premises; and,

WHEREAS, issuance of a license without the below described conditions would be contrary to public welfare and morals.

NOW, THEREFORE, the undersigned petitioner(s) do/does hereby petition for a conditional license as follows, to-wit:

01. Alcoholic beverages shall be sold served or consumed only within the barricaded area as noted on attached diagram. In addition, no additional dispensing points shall be permitted. Persons may not take alcoholic beverages from the designated area.
02. Applicant shall provide security personnel to monitor alcoholic beverage dispensing point and the area noted in Condition #1. Said security persons must wear distinctive uniforms so as to readily identify them as security personnel, and shall be present in the area where consumption of alcoholic beverages is taking place at all times that the license privileges are being exercised.
03. The security staff will prevent people from carrying alcoholic beverages outside the designated area as noted in Condition #1.
04. Alcoholic beverages shall only be sold and served in distinctive paper, plastic or styrofoam cups and no other cups may be used for the dispensing of alcoholic beverages. Said containers shall be readily identifiable as containing alcoholic beverages and shall be distinct and different than containers containing non-alcoholic beverage.
05. The petitioner shall cease sales and service of alcoholic beverages one hour prior to end of the day's event.



06. All persons serving or otherwise dispensing alcoholic beverages must be 21 years old or older.
07. No more than two (2) alcoholic beverages may be purchased by any one (1) person at any one (1) time.
08. All persons serving alcoholic beverages can not consume any alcoholic beverages.
09. *Non-alcoholic* beverages must be available to persons in attendance.
10. The petitioner shall sell alcoholic beverages only to persons who have obtained a non-removable bracelet, wristband or stamp identifying the individual as being 21 years of age or older.
Reliance solely on said bracelet or wristband will not relieve any person of responsibility should it be determined that the purchaser and/or consumer is under 21 years of age.

Petitioner acknowledges that failure to comply with the foregoing conditions shall be grounds for the summary revocation of the conditional one day permit(s).

Petitioner stipulates that the Department of Alcoholic Beverage Control may summarily revoke the conditional one day permit(s) should the Department, in its discretion, determine that the public welfare and morals are being impaired and/or a law enforcement problem is being created; and that upon notice of such revocation, petitioner shall immediately surrender the one day permit to the Department and cease all sales and service of alcoholic beverages at the event for which the one day permit was issued.

Petitioner agrees to retain a copy of the petition on the premises at all times and will be prepared to produce it immediately upon the request of any peace officer.
