Dear Commissioners:

Just to let you know that I have been attempting to "Clean Up" the horrific news racks in the Hollywood Media District. They are a nuisance to the public as well as to our Stakeholders. I have attempted to utilize the 3-1-1 reporting system however due to staffing reductions in BSS (investigation) they are unable to enforce in a timely manner. If the news racks are going to remain in the District, at the very least I would expect them to be "clean, with no graffiti and in working condition" - **Definitely not the condition that they are in today.**

Perhaps funding should be looked at if the City wants to retain the news rack program - at the very least make sure that the program is funded for cost recovery. It is unfair to the District and Stakeholders to have these unsightly and distasteful nuisances in the public right of way that are not maintain on a regular basis. In fact its an insult to have the City turn over the responsibility of the commercial sidewalk to the property owners with these nuisances.

Please advise as to enforcement and removal of these blighted boxes as their asset service life has expired!

The problem we have is that newsrack enforcement funding went away several years ago. We use to have a dedicated team to deal with enforcement.

It is now part of our normal enforcement and we address as resources allows unless it is a public safety issue such as a newsrack that is obstructing the sidewalk, hit by a car etc...We will address as soon as possible and keep you posted.

I would like to request a follow up on all these open Service Requests in regards to the damaged/graffitied/abandoned news racks within the Hollywood Media District BID. I have taken quite a bit of my time to identify the new racks that are not in compliance with LAMC Section 42.00(f) - particular subsection (6) Maintenance Specifications - ***not maintained in neat and clean condition and in good repair***. These news rack companies should have already responded to the violations of graffiti and cleaning. They are supposed to remedy the non compliance within 24 hours of notifications but in no event more than 72 hours. It has been closed to 45 days since my initial report - I need assistance in getting these news racks cleaned up or REMOVED in some cases.
