(See SIN/ZM: A closer check of the blackmail and RIC allegations on SCHAUP proved that those ellegations were exaggrated. "MMATP had at one time been involved in a sale of information concerning UNA building program. SCHAPP tried to obtain the information by applying a little pressure to his clients.) Agent said that he did. Case officer then asked that agent telephone MCHAT and ask if there were a possibility for them to maet since he (agent) has still interested in buying some "art" pictures. Same officer than amplaired that after agent arranged a meeting with SCHAUP, case officer himself would go to see SCHAUT as 'br. A. Miller (the name agent used in procuring the "art pictures). Case officer asked if possible that this meeting be arranged at CCHAUT's apartment on 15 or 16 December at 11:00 hours. Case officer and agent would meet on Monday to see if each had been able to make the necessary arrangements. (C.C. Note: Case officer met agent on 14 December at 11:00 hours and learned that agent had been successful in arranging a meeting with SCHAUP for 15 December at 11:00 hours at SCHAUP's apartment. Case officer is contacting SCHAUP as part of an investigation to determine any possible use of SCHAUP in intelligence operations.)
