1. MAY 18 CAPE ARGUS REPORTS RHODESIAN GOVERNMENT REGULATIONS PUBLISHED TODAY AS AMENDMENTS TO THE EMERGENCY POWER (MAINTENANCE

OF LAW AND ORDER) REGULATIONS OF 1970. REGULATIONS AUTHORIZE GOVERNMENT TO EVACUATE, SCREEN, AND RESETTLE SOME AFRICANS LIVING " ALONG THE NORTHERN BORDER." FOLLOWING EVACUATION, COMMISSIONER OF POLICE CAN AUTHORIZE CONFISCATION, SEIZURE OR DESTRUCTION OF PROPERTY THAT MIGHT BE USED BY TERRORISTS. ARGUS STATES REGULATIONS ALSO ANNOUNCE NEW CURFEW POWERS AND CLARIFY DETENTION LAWS. EMBASSY WILL REPORT IF MORE DETAILED INFORMATION BECOMES AVAILABLE.

2. RHODESIAN MINISTRY OF INFORMATION STATEMENT EVENING OF 17 MAY CITED INTIMIDATION OF "TRIBESMEN" ALONG NORTHERN BORDER AND STATED THEY WOULD BE MOVED TO BETTER LAND THAN THEY NOW UNCLASSIFIED
