ENGEL COULD ALSO BE ADVISED THAT PRESIDENT AMIN CALLED IN CHARGE APRIL 4 AND GAVE HIM COPY OF TELEGRAM HE HAD SENT TO PRESIDENT NIXON WHICH INTER ALIA STATED QUOTE THE BUSINESSES OF NON- CITIZENS ASIANS, BRITISH FIRMS AND THE ISRAELI FIRMS WHICH HAVE BEEN TAKEN OVER BY MY GOVERNMENT WILL BE COMPENSATED ACCORDING TO THE FINANCIAL RESOURCES OF UGANDA AND AFTER PROPER VALUATION AND ASSESSMENT. THIS EXERCISE, AS YOU WILL APPRECIATE, WILL NOT BE DONE AT ONCE UNQUOTE. PRESIDENT AMIN REITERATED THESE REMARKS ORALLY TO CHARGE. TEXT OF TELEGRAM WAS PUBLISHED IN VOICE OF UGANDA APRIL 5.
