1. DCM RAISED WITH FOREIGN SECRETARIAT LEGAL ADVISER AMBAS-  
SADOR ROSENZWEIG-DIAZ POSSIBILITY OF VISIT BY DEPARTMENT  
LEGAL ADVISER BETWEEN AUGUST 10-13.

2. ROSENZWEIG-DIAZ EXPLAINED THAT HE IS NOW PUTTING FINAL  
TOUCHES ON A PAPER SETTING FORTH PROPOSED GOM RESPONSES TO  
QUESTIONS RAISED IN OUR AIDE MEMOIRE (BASED ON STATE 157930).  
HE ANTICIPATES COORDINATING THIS PAPER WITH THE ATTORNEY  
GENERAL AND THE UNDERSECRETARY OF GOVERNMENT (GOM'S LEADING  
PENAL EXPERT) NEXT WEEK. ROSENZWEIG-DIAZ POINTED OUT DESIR-  
ABILITY OF CONCLUDING THESE CONSULTATIONS PRIOR TO VISIT  
IN ORDER TO MAKE VISIT OF DEPARTMENT LEGAL ADVISER AS PRO-  
DUCTIVE AS POSSIBLE. ACCORDINGLY, HE CONSIDERS DATES PRO-  
POSED SLIGHTLY PREMATURE AND SUGGESTED WE INQUIRE WHETHER  
LEGAL ADVISER COULD FIND FREE DATES FOR VISIT SOMETIME IN  
SECOND HALF OF AUGUST.

3. DCM SUBSEQUENTLY RAISED WITH UNDERSECRETARY GALLASTEGUI  
ROSENZWEIG-DIAZ'S PROPOSAL FOR A DELAY. GALLASTEGUI SAID  
HE WAS FAMILIAR WITH THE MATTER, HAVING DISCUSSED IT WITH  
ROSENZWEIG-DIAZ IMMEDIATELY AFTER THE LATTER'S CONVERSATION  
WITH DCM. GALLASTEGUI ENDORSED THE SUGGESTION THAT WE TRY  
TO SCHEDULE THE VISIT FOR AT LEAST A WEEK LATER THAN PROPOSED.
