SUBJECT: MOJA PLANS TO DEMONSTRATE AT THE AIRPORT WHEN DR.
KISSINGER ARRIVES

1. MEMBERS OF MOVEMENT FOR JUSTICE IN AFRICA (MOJA) PLAN TO DEMONSTRATE AT ROBERTS INTERNATIONAL AIRPORT ON APRIL 30, 1976, AGAINST SECRETARY UPON HIS ARRIVAL. SHOULD IT NOT BE POSSIBLE TO HOLD THE INTENDED DEMONSTRATION, MEMBERS OF MOJA PLAN TO PASS OUT PAMPHLETS EXPRESSING MOJA'S CONDEMNATION OF DR. KISSINGER'S VISIT TO AFRICA AND ALLEGED U.S.SUPPORT FOR IMPERIALISM IN AFRICA.

2. COMMENT: EMBASSY CONSIDERS IT UNLIKELY THAT MOJA'S PLANS WILL BE ALLOWED TO MATERIALIZE. PRESIDENT TOLBERT IS HIMSELF AN HONORARY MEMBER OF MOJA, AS ARE OTHER DIGNITARIES. GIVEN HIS STRONG IDEAS ON RESPONSIBILITIES OF HOST TOWARD GUEST, SECURITY FORCES CAN BE EXPECTED TO CONTAIN ANY ACTIONS OR OTHER ADVERSE ACTIVITIES DURING SECRETARY'S STAY. GOL HAS SHOWN IN PAST, WHEN STUDENTS WANTED TO DEMONSTRATE, THAT IT HAS THE ASSETS AND WILL TO PREVENT HAPPENING WHAT IT DOES NOT WANT TO HAPPEN.
