1. ANNOUNCEMENT OF IMPENDING NATIONALIZATION OF BRITISH-OWNED BOOKER MCCONNELL ASSETS IN GUYANA WAS MADE SATURDAY FEBRUARY 14 AS ANTICIPATED. GOG ANNONCEMENT AID DISCUSSIONS WILL BEGIN QUOTE SHORTLY UNQUOTE FOR ACQUISITION OF ENTIRE BOOKERS HOLDINGS. THIS INCLUDES BESIDES SUGAR ESTATES AND FACTORIES, COUNTRY'S LARGEST DEPARTMENT STORE AND IMPORT HOUSE, DRUG COMPANY, SUGAR TERMINAL, AS WELL AS FIRMS ENGAGEDIN SHRIMPING, BALATA COLLECTING PRINTING, STOCKFEEDS, LIQUOR DISTILLING, CATTLE RAISING,DAIRY, INSURANCE AND GENERAL INVESTMENT. PERSONS IN GUYANA COMPARED TO ABOUT 35,000 EMPLOYEES IN TOTAL

WORLDWIDE OPERATIONS. WE UNDERSTAND THAT THE COMPANY'S GUYANA HOLDINGS CONSTITUTE ABOUT THIRTY-SEVENPERCENT OF ITS TOTAL ASSETS, I.E. ANINVESTMENT HERE OF OVER US DOLS 60 MILLION. BOOKERS IS ONLY REMAINING LARGE FOREIGN INVESTMENT IN GUYANA, WORTH FAR MORE THAN ALL THE OTHERS PUT TOGETHER.

2. RATHER MILD TONE OF GOG ANNOUNCEMENT GIVES SUPPORT TO SPECULATION THAT GOG WOULD RATHER HAVE DELAYED TAKEOVER TALKS AND CONTINUED INSTEAD WITH CONFISCATORY LEVY. BOOKERS, HOWEVER, CONFRONTEDPM BURNHAM WITH FISH OR CUT BAIT DEMAND, AND THUS GOG'S RELUCTANT DECISION WAS TAKEN AND ANNOUNCED WITHIN A FEW DAYS. ONE RELIABLE COMPANY SOURCE TOLD EMBOFF THAT DISCUSSIONS WILL BEGIN NO LATER THAN MID-MARCH, AND CONFIRMED EARLIER REPORT THAT GOG WISHES TO

SET VESTING OF COMPANY FOR MAY 26 (INDEPENDENCE DAY).

3. FROM ARLY PRESS ITEMS AND OPINIONS OF INDUSTRY OFFICIALS, GOG WILL TRY TO RETAIN ALL BOOKERS KEY PERSONNEL, INCLUDING EXPATRI-ATES IF POSSIBLE. CUBANS, IT IS RUMORED , HAVE INDICATED THEY DO NOT RPT NOT HAVE THE EXPERTISE TO ASSIST MEANINGFULLY IN TYPE OF SUGAR CULTIVATION PECULIAR TO GUYANA. ONE SOURCE SAID CUBANS SUGGESTED GOG KEEP BOOKERS ON MANAGEMENT CONTRACT FOR BOTH FIELD AND FACTORY OPERATIONS, AND FOR MARKETING. CUBANS WE UNDERSTAND HAVE CLOSE COMMERCIAL TIES WITH BOOKER MCCONNELL IN UK BY VIRTUE OF BOOKER'S SUGAR FACTORY EQUIPMENT SALES TO THEM.

4. KEY QUESTION NOW REMAINING IS HOW GOG WILL BE ABLE TO COMPENSATE BOOKER MCCONNELL ADEQUATELY. BY FORCING GOG INTO POSITION OF NATIONALIZATION SOONER RATHER THAN LATER, COMPANY MAINTAINS SLIGHTLY STRONGER NEGOTIATING POSITION. GOG'S MANAGERIAL LABOR FORCE IS SPREAD SO THIN AT PRESENT IT CANNOT LAUNCH SEVERAL OF ITS HIGHER PRIORITY DEVELOPMENT PROJECTS. FOR THE NEXT YEAR, AT MINIMUM, IT WILL NEED ALL OF PRESENT COMPANY STAFF TO MAINTAIN OPERATIONS. MANY OF BOOKERS PERSONNEL HAVE LONG-STANDING TENRURE AND ARE AS LOYAL TO COMPANY AS THEY ARE TO GUYANA, ESPECIALLY THOSE MIDDLE-CLASS WHITE-COLLAR WORKERS AND EXECUTIVES WHO ARE NOT RPT NOT PARTICULARLY ENAMORED OF THE MARXIST-LENINIST-COOPERATIVE SOCIALISM ETHIC.
