28 ASKING THAT A PERMIT BE ISSUED TO THE LA FUNERARIA FUNERAL
AGENCY IN CHIHUAHUA CITY.

2. THE EMBASSY IS REMINDED THAT THIS CASE HAS BEEN STALLED
FOR OVER ONE YEAR BECAUSE OF APPARENT INACTION BY THE
AUTHORITIES IN CHIHUAHUA AND IS THEREFORE URGED TO REQUEST
THE ATTORNEY GENERAL'S OFFICE TO INTERVENE IN THIS MATTER
