SUBJECT: ISRAEL TO SIGN CIVIL AIR AGREEMENT WITH SCANDINAVIAN  
COUNTRIES

1. ISRAELI OFFICIALS ARE NOW IN COPENHAGEN NEGOTIATING  
A CIVIL AIR AGREEMENT BETWEEN ISRAEL AND THE SCANDINAVIAN  
COUNTRIES. IF THE TALKS ARE SUCCESSFUL, THE DANISH MINISTER OF  
TRANSPORT (MATTHIASSEN IF HE CONTINUES IN THAT CAPACITY  
IN THE NEW GOVERNMENT) IS EXPECTED TO COME TO ISRAEL  
NEXT MONTH TO SIGN THE NEW AGREEMENT. SIMILAR AGREEMENTS  
WOULD BE SIGNED LATER WITH THE GOVERNMENTS OF SWEDEN  
AND NORWAY.

2. AT PRESENT ISRAEL HAS NO GOVERNMENT-TO-GOVERNMENT  
AVIATION AGREEMENT WITH THE SCANDINAVIAN COUNTRIES.  
THERE ARE ONLY PROVISIONAL LANDING PERMITS, ALLOWING  
EL AL TO LAND AT COPENHAGEN AND SAS TO  
OPERATE TO ISRAEL. EACH AIRLINE OPERATES ONE FLIGHT  
PER WEEK. THE ISRAELIS ARE SEEKING ADDITIONAL LANDING  
RIGHTS FOR EL AL AT STOCKHOLM AND OSLO AND FEEL CONFIDENT
