Description of Offense: NOTE: [redacted] August, 2002. Victim became involved with the "Moonies" in her native country, in [redacted]. She was brought to the U.S. and along with other recruited members, forced to travel around SW part of the U.S., selling trinkets. They were forbidden to eat or drink anything while selling; they were forbidden from taking bathroom breaks unless given permission to do so by the team leaders. If it was felt that any breach in the rules had occurred, the team leaders were both physically and verbally abusive, screaming at them; sometimes hitting them, and depriving them of food and drink. They were fed only twice a day: once in the morning prior to going out to sell, and at night when they returned from a 12-14 hour workday. Victim became very ill but the leader for the West Coast refused to get her to a doctor. She was made to go to [redacted] to the factory owned by the Church where the trinkets that they sold were made, and forced to work in this factory and to sleep there as well. She became sicker, so was sent to [redacted] to be "cured." The method used consisted of surrounding the ill person and beating them with the hand, while claiming the sick person was possessed by evil spirits that must be beaten out. She was tortured in this way for about 60 days, and then sent back to the U.S. Besides deprivation of food and sleep, the recruits' mail was taken and read; their every movement watched; they were forbidden any contact with anyone not with the Church. Victim was able to make contact with a family in [redacted] where she and others were sent for a big rally. They gave her the name and number of another friend in [redacted]. She was told this person would help her. Once Victim had escaped, she contacted the family in [redacted] and has been living with them.

INVOLUNTARY SERVITUDE/SLAVERY CASE

Hello [REDACTED]

Attached is the material we spoke about regarding the new civil rights case the Bureau is instructing us to open. I am sending it to you to open inasmuch as the claimed illegal activity occurred in the East Bay.

You can use the attached EC as Serial 1 to open the case. You will note it should be opened as a 50 classification (no alpha). I don't recall if you've ever seen a 50 case on your squad before; I doubt it though as I only know of three others we've opened in the past three years (all on my squad). You can read the manual on how to investigate but it amounts to trying to prove the victim's allegations that she was subjected to treatment and conditions which amount to "involuntary servitude" or "slavery" in violation of 18 U.S.C. 1584 or related statutes.

In this case initial investigation should include a lead to Minneapolis to have the victim thoroughly interviewed and some work to verify the existence and use of the two places in [REDACTED] she identifies as places the Moonies held her and forced her to work; that may lead to the identification of subjects and other victims/witnesses who will need to be interviewed down the road. If enough of what the current victim says can be verified and some other cooperative victims/witnesses located, DOJ may agree to prosecution.

Note that the Bureau expects an FD-610 to be submitted soon. There is a macro for this form. ONE COPY OF IT SHOULD ALSO GO TO [REDACTED] in our office. (That's how it gets entered into the Civil Rights Information System.)

I have discussed this matter already with AUSA [REDACTED] (who is, for this week anyway, the Civil Rights person at the USAO). You should also talk to, or have your assigned agent talk to, AUSA [REDACTED] in Oakland. He is the Civil Rights AUSA point of contact for all East Bay civil rights cases. [REDACTED] will probably also be advising AUSA [REDACTED] about this case.)

Thirty and 90 day Civil Rights reports (FD-204/FD-263) will be due on this case just as in Color of Law cases.

Finally, I am attaching for your information copies of Involuntary Servitude materials I got at the last Civil Rights in-service I attended. Perhaps they will be of some use. You or the assigned agent should also feel free to contact the new FBIHQ Civil Rights Unit SSA responsible for West Coast offices, [redacted] [redacted] His phone number is [redacted] He is replacing [redacted] [redacted] who is on his way out here to take over Squad 14E.

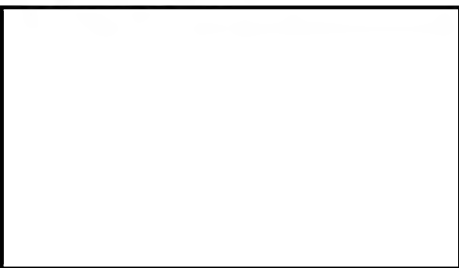

[redacted] advised the "moonies" had a unit across the way from their unit, which he believed was a holding area for the items which they were selling. [redacted] suggested that the agents talk to his wife, [redacted] who had talked to several of the members of the group.

[redacted] noticed that recently there seemed to have been a turnover of people at the "moonies" unit, as if one group had finished their tour of duty and a new group was starting their tour.

On October 17, 2002, [redacted] employee of [redacted] California, was interviewed by Special Agent (SA) [redacted] and SA [redacted] of the Federal Bureau of Investigation. After being advised of the identity the interviewing agents and the nature of the interview, [redacted] provided the following information:

The "moonies" had rented the unit across the way from [redacted] BOB WIRTH RACING, about three to five years ago, according to [redacted] would see groups of people coming and going, directed and under the control of a leader. [redacted] did occasionally talk with some of the individuals, and found out they were breaking up granite and polishing the granite to make into little water fountains which they would then sell. [redacted] would see groups of people being transported to the unit to do the work.

[redacted] advised that previously the "moonies" had rented not only the unit across the way from BOB WIRTH RACING (BWR), but also another unit on the same side as BWR, located several units down from them. One unit seemed to be used for manufacturing the fountains, and the other unit was used for storage. The unit on the same side as BWR was closed down. The unit across the way is now used for storage. [redacted] believes they may have rented another manufacturing location elsewhere because of the expense of the Hayward area.

[redacted] would see trucks being loaded with large shipments of fountains. [redacted] advised the business was called the "FOUNTAINSIDE BUSINESS." [redacted] noticed that they did business regularly with UPS.
