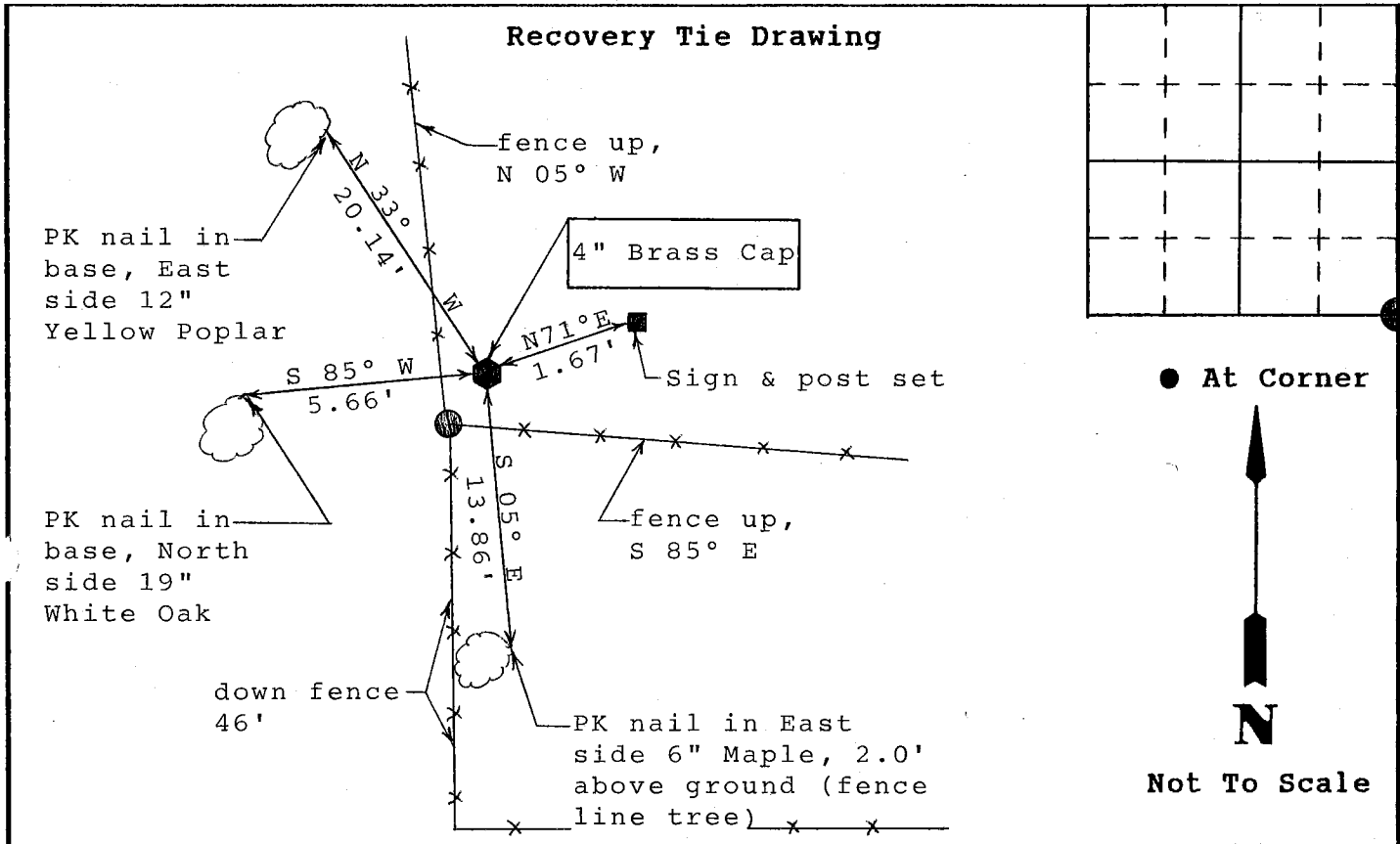

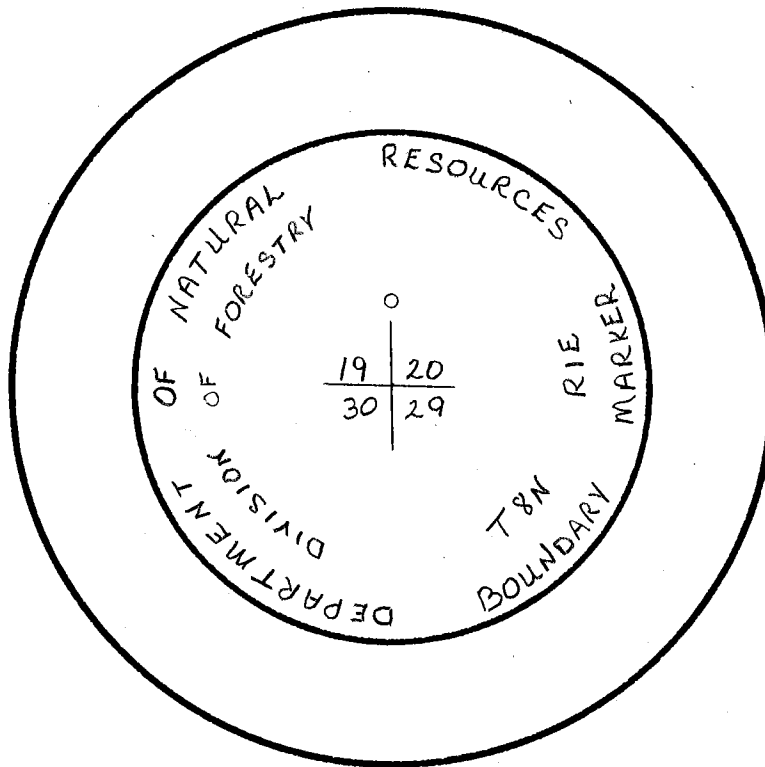

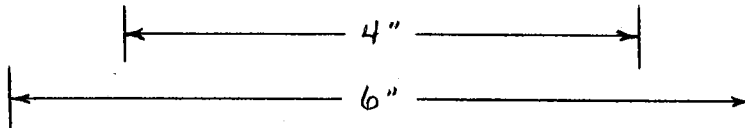

Subsequent survey by Buskirk in 1877-Stone and accessories.

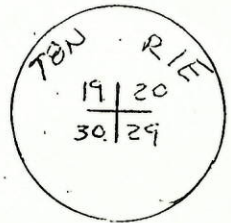
