As you know, the County Assessor did not bill for Venice Beach BID in 2017 since the BID was established late in 2016. Consequently, our department hand-billed for the BID. There is not a report that is generated on a quarterly basis. I've attached a report that was run in May by our billing staff and will send you the October report once it's ready.

Tara,

Any reports I receive for a BID, I forward to the BID director, who can send it to whomever he/she wishes. I think it is likely the monthly transmittals may change, but I don't think the others will. The secured reports come from the County and they are not tied in to the City's financial management system (FMS). The paid reports are put together by our billing folks in excel format, and not part of FMS.

I understand that BIDs are able to receive the secured reports directly from the County, so you might want to contact them.
