Tara, Ms. Murez contacted our office regarding a mixup in her 2018 Venice assessments. They own two parcels and needed to have the assessments revised. After researching, I discovered she was correct. The reason we had to direct bill for 2018 was because one of the parcels (045) had an increased assessment which the County will not do after a parcel has already been billed by them. For 2019, both parcels should only be on the County tax rolls, not the direct roll.

The corrected amounts for 2018:

4286-012-044: \$859.80 4286-012-045: \$1,605.74

Therefore, the 2019 amounts should have the CPI increase added to the above.
