"Is there anything else I can do to make life bearable around here, like a little earthquake or something?" asked J. Evil.

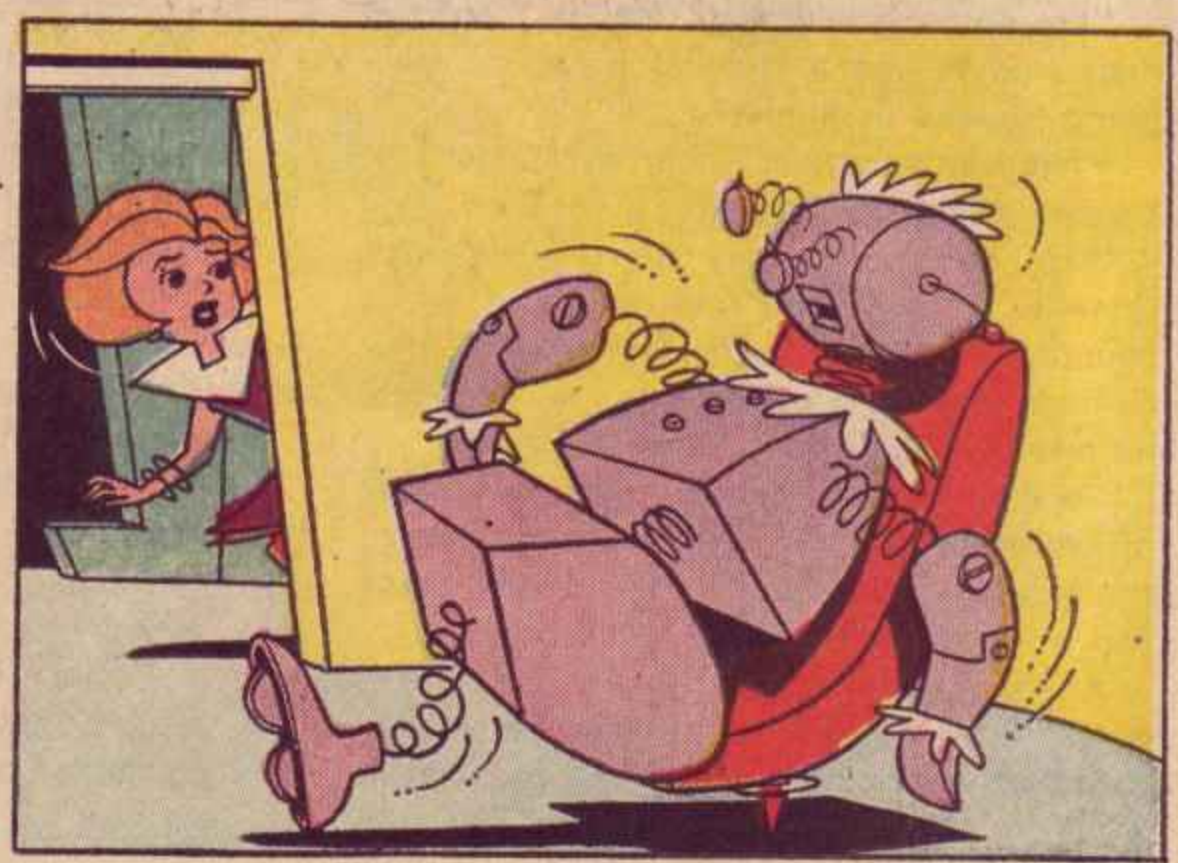
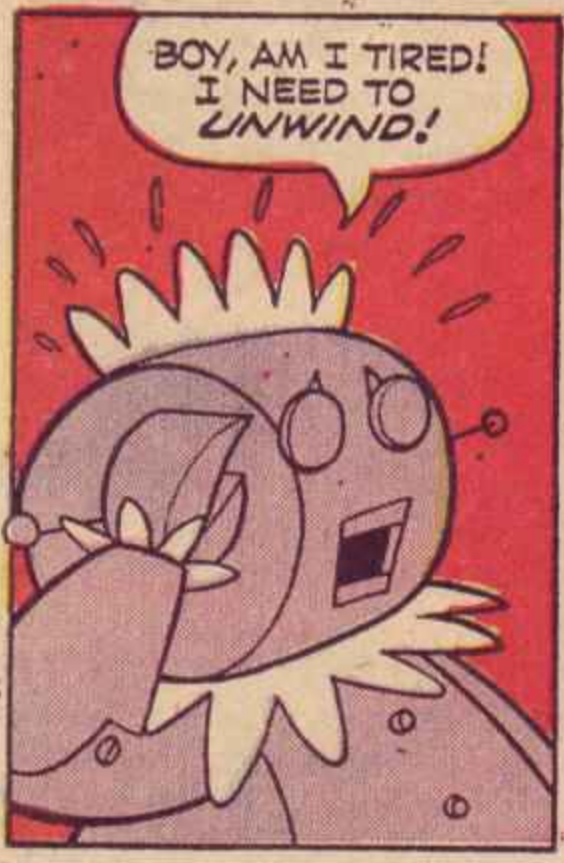
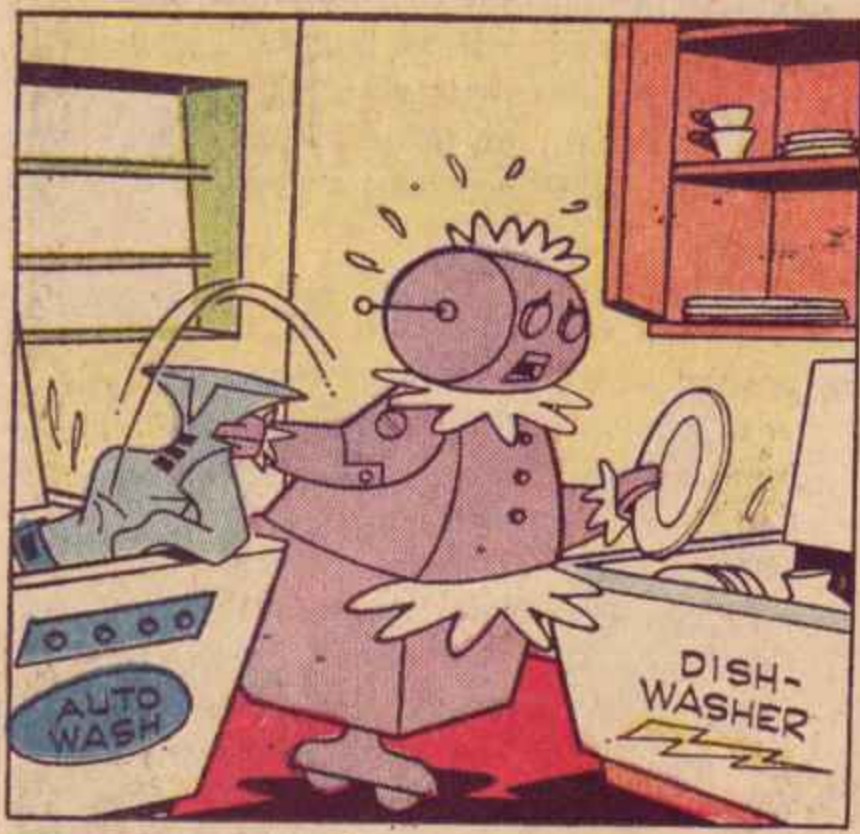
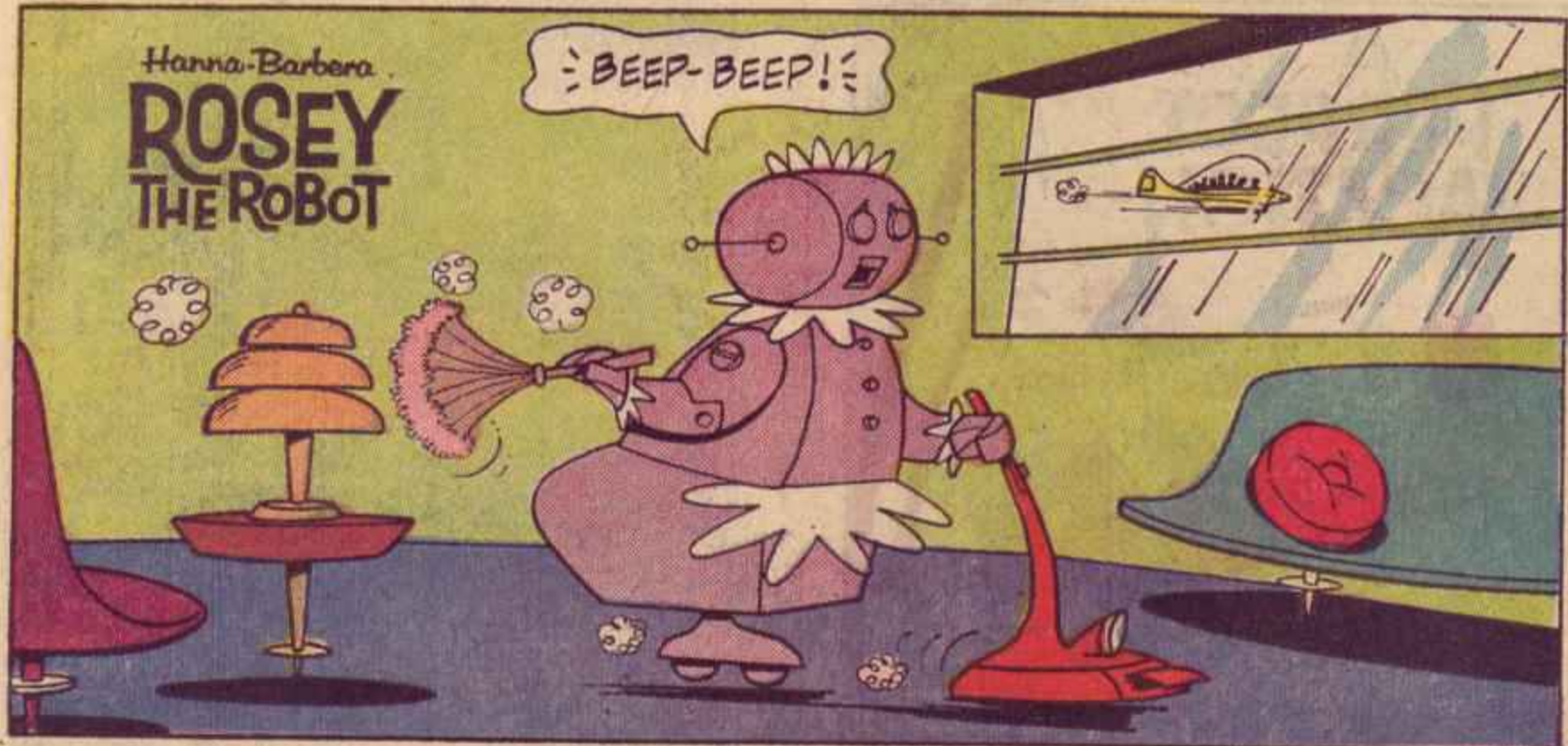
