WASHINGTON LETTER

After a month's unearned holiday, Congress is again in session with practically all its important work yet to be done, and President Harding, refreshed by new golfing and cruising experiences, has returned from his latest vacation.

The tax revision bill as rewritten by the Senate is just reported in that body and will be the subject of long debate while business feverishly waits. The Republican campaign promise to reduce taxes, therefore, has not been kept, and, according to Senator Smoot (Rep., Utah), an authority on taxation, will not and cannot be kept. The tax bill in its present shape, is no more satisfactory than it was as it passed the House and is certain of the opposition of some Republican Senators.

By general consent the tariff bill, through which the Republicans were going to restore prosperity at once, must wait perhaps until the very last. According to the newspaper recognized here as President Harding's mouthpiece, many returning Congressmen are of the opinion it ought to be passed up altogether or at least until the disarmament conference is over. This economic monstrosity, known as the Fordney Tariff bill, has been riddled by House and Senate Republicans as well as Democrats until it will no more hold water than a sieve, and yet enough blind partisans were found in the House to pass it. It is not satisfactory to anyone except the profiteering big manufacturers. Bankers and other business men oppose it and the greatest merchant perhaps in the world, the head of Marshall Field & Co., Chicago, has shown that the "American valuation" clause would destroy what little foreign trade there is left in merchandise.

Among the big measures yet to be acted upon is the war loan funding bill introduced by Senator Penrose, which empowers the Secretary of the Treasury to do anything he pleases with \$10,000,000,000 foreign loans and to be the sole judge of the transactions he may enter into in funding the debt. This, as has been pointed out by Senator McKellar (Dem., Tenn.) and Senator Underwood, the Democratic Senate leader, is an unprecedented and unwarranted grant of power which no one man ought to have or ought to be willing to accept. It is the most sinister and the most dangerous measure ever introduced in any session of Congress and is sure to result in acrimonious debate, but the Republicans are in an arbitrary, stiff-necked mood and ready and willing to employ the steam-roller whenever it becomes necessary to override the minority.

The railroad funding bill, the Panama tolls bill and the maternity bill are all measures which await action and are provocative of debate. The separate peace treaty with Germany, which is still the great division in the votes of both parties, will have precedence probably, and it is predicted that it will be fought as bitterly by the Blitzer enders as was the peace treaty of Versailles.

In the meantime six million persons are idle and the American troops are still on the Rhine.

It would seem, therefore, that we are yet a long ways from normalcy.

THE WOMAN'S CHANCE

The disgraceful orgies of some of our celebrated moving picture stars, which are now being described in newspapers all over the country, will not impress the public with a high standard of female morals in the screen craft.

The present age is distinctly one of opportunity, possibility and responsibility for the woman. Will she make good or prove a failure? If she gravitates to the level of her men companions she will no longer have a just contention over a double standard of morals, and race degeneracy will take on more than double speed and race extinction become a certainty. If she maintains her moral standard and aids and encourages man in his upward struggle, she will save the race.

During the last half century, the double standard of property rights, industrial opportunities, educational advantages, political rights and religious privileges has been crumbling under the irresistible tread of human progress. When none of these rights and privileges were hers, woman was powerless to help bring about a single standard of morals. The possibility and power has now come and the women of the next generation will have to prove themselves equal to their task or accept the responsibility for its failure.

It takes two to play the game of the social vices and evils. Young men usually have sense. They know right from wrong. They respect and admire the woman who bravely defends the truth.—U. S. Public Health Service.

DON'T FORGET

It is unlawful for any person over fifteen years of age to hunt or fish without a license to be procured from the county clerk. Cost of license, to residents, one dollar; to non residents, fifteen dollars.

It is unlawful to hunt on enclosed or improved lands of another without the written consent of the owner or agent.

It is unlawful for any person not a citizen of the United States to hunt, catch or kill any wild game animals, wild game birds or wild game fowl or have in his possession fire arms for such purposes or fish for fish, frogs or turtles.

It is unlawful for any unnaturalized foreign-born resident of the State to own or keep a dog of any kind in this state.

That you cannot hunt the various birds and animals or catch any fish except during the periods which are set out below:

Elk—No person except the owner shall kill any elk in this State for a period of ten years or until 1923.

Deer—No person except the owner shall hunt or kill any deer in this State until October 15, 1923. No person shall hunt or kill deer with dogs in this State at any time.

Wild Turkeys—Lawful to kill same between October 15 and December 1. Unlawful to kill same at night or to kill more than one turkey in one day or four in one season. Persons required to report number killed to Game and Fish Commission.

Ruffed Grouse—Lawful to hunt same between October 15 and December 1, but unlawful to kill more than four in one day or twenty in one year.

Quail or Partridge—Lawful to hunt same between November 1, and December 1, but unlawful to kill more than ten in one day or sixty in one year.

Wild Duck, Goose or Brant—Lawful to hunt same between October 15 and January 1.

Woodcock—Lawful to hunt same between October 15 and November 30. Plover, Oortolan or Sandpiper—Lawful to hunt same between September 16 and December 31.

Sniipe—Lawful to hunt same between October 15 and December 15. Gray, Black, Fox and Red Squirrel—Lawful to hunt same between September 1 and December 1. No person shall kill more than eight squirrels in one day or sixty in one season.

Frogs—Unlawful to hunt frogs between April 1 and June 1.

Rabbits—Lawful to hunt same between October 1, and January 1.

Polecat or Skunk—Unlawful to kill same between February 1 and December 1.

Jack Salmon, Jack Fish or White Salmon—Unlawful to fish for same between April 1 and May 30.

Trout or Landlock Salmon—Unlawful to fish for same between April 1 and May 1.

Bas, Pickerel or Pike—Unlawful to fish for same between April 1 and May 30.
