20th inst. we clip the following :

Last evening on the arrival here of No.
4 on the B. & O. among the passengers
that alighted from the train was an old
man, gray headed and feeble, and poorly
clad. Several parties noticed him, as he
acted rather strangely. Just before the
train started he walked upon the front
platform of the sleeper, crossed over
and got off on the opposite side. He
was told to get aboard, as the train was
about to start, but paid no heed and
walked up along the train, and as it
pulled out past him he made no effort
to get on.

When it had pulled out he asked some
one whether that was his train, and
they told him it was. Without making
any further inquiries he started out
through the B. & O. yards on a slow
walk. He was seen and spoken to by
several parties in the yards, but gave
unintelligible answers. Conductor
Bailey was one of these persons, and
warned him to be careful and get off the
