REV. W. E. YATES LOSES.

Dr. Forbell, Revs. Herod and Binford and Hon. J. S. Thurmond, of Alderson were last week at Hinton and attended a council of Baptist ministers called to consider the case of Rev. W. E. Yates, pastor of the First Baptist Church there. The council found he had departed from the teaching of Baptist doctrine. Rev. Yates had filed a bill in the Summers county circuit court for an injunction to restrain the trustees from preventing him from using the Church. The court refused the injunction, and Mr. Yates took the case to the State Supreme Court on an appeal. No decision from this court as yet.
