[redacted] first appeared on Temple Square in April, 1988. He made frequent visits until August, 1988.

[redacted] has returned as of November 23, 1989, and is currently making frequent visits somewhere on Church Headquarters property. Information we have on file on [redacted] includes:

April 3, 1988: [redacted] was on Temple Square saying he is a latter day prophet sent here to preach the truth to the Mormon Church. The Salt Lake City Police Department was called to help persuade [redacted] to leave Temple Square.

April 4, 1988: [redacted] was on Temple Square on a planter box near the flagpole singing loudly and preaching religion. Again the Salt Lake City Police Department was called.

April 7, 1988: [redacted] as he entered the South Visitors Center, told a security officer he was there to get a \$5.00 collection from the Church. [redacted] also delivered a note to Temple Square Security which made no sense.

April 9, 1988: [redacted] was again on Temple Square prophesying and rambling. The Salt Lake City Police Department was again called to remove him from Temple Square.

April 12, 1988: Responding to a South Visitors Center Book of Mormon Diorama panic alarm, Security found [redacted] crawling from underneath the curtains. [redacted] said he was "looking for the truth and found it behind the curtains." The Salt Lake City Police Department was again called and [redacted] was arrested.

August 28, 1988: [redacted] approached Security at the South Gate of Temple Square. He asked that he no longer be restricted from entering Temple Square. He said he was willing to let us believe our own way even though he knew better. [redacted] said he was moving to Mexico.

November 23, 1989: [redacted] approached two security officers outside the South Gate of Temple Square. He expressed bitterness towards Church Security officers, claiming to have been badly treated in the past. [redacted] indicated he still considers himself a prophet.

November 30, 1989: [redacted] was stopped from entering the North Gate of Temple Square. About two hours later he was again observed outside the North Gate talking to two Salt Lake City police officers. We learned he had called the police, protesting to our not allowing him on Temple Square.

December 4, 1989: [redacted] entered the Church Administration Building asking to deliver his revelations to someone in authority. Investigators met with [redacted] and he again met with [redacted]. [redacted] was again told to make no further efforts to enter Temple Square or the Church Administration Building.

December 7, 1989: [redacted] was on Church property twice selling or distributing some literature titled "The Final Woe - Manifest of Future Destinies." [redacted] left 15 copies of this literature at the Administration Building for the "Brethren." When asked to stop and leave he became agitated. He cursed the security officers and prophesied of further calamities against all who belong to the L.D.S. Church.

December 8, 1989: [redacted] was observed outside the South Gate of Temple Square. He was playing a radio very loudly. [redacted] told Security he was grow to be 800 feet tall.

Because [redacted] is a frequent visitor to Church Headquarters property, specifically Temple Square, the Church Administration Building, and the Church Office Building, also because of the number of times the Salt Lake City Police Department has been called, because [redacted] has demonstrated he will not follow our directions, I feel we should pursue persona-non-grata status for [redacted]
