## WHAT BENEFITS WOULD A DAM

In addition, building a dam would create a 3,000 acre lake, bringing in additional jobs, recreational opportunities and added quality of life.

With the dam, water release in the summerime will guarantee the necessary water levels and flow to sustain and provide for water and sevage treatment again, leading the way to additional commit growth. And brating and recreation in the Greenbier River will then be enjoyed daming the summer months as well.

## WHAT ALTERNATIVES ARE THERE?

None. The Corps of Engineers have studied this problem, and have concluded that a dam is the best solution. Floodwalls, damning



tributaries, buying property and relocating everyone in the flond plain are too expensive or don't meet the needs of the people.

## AREN'T SUPPORTERS OF THE DAM JUST TRYING TO MAKE

MONEY? No. Supporters understand that, for the communities along the Greenbrier River, this is the key to a vibrant and economically strong future.

WHAT ABOUT THE ENVIRONMENTAL IMPACT? The dam will not change the course of the River. It will not adversely affect wildlife or plant life. It will enhance all the positive reasons why people and businesses locate here in the first place, while eliminating the risk they face every time it rains.
