Ever since the Christmas bombing of the home of  
Harry T. Moore, Florida official of the National Association  
for the Advancement of Colored People, which resulted in his  
death, the east coast Communist newspaper "Daily Worker" has  
been appealing for communications to President Truman,  
Attorney General J. Howard McGrath, and Florida Governor  
Fuller Warren demanding a halt to "the genocidal terror in  
Florida." In addition, protests emanating from Communist and  
non-Communist sources have been featured. The December 31  
issue announced that more than 200,000 flyers relating to the  
bombing were issued and circulated by the "Daily Worker"  
publishers.

Elsewhere throughout the country Communists and  
Communist-dominated groups also have been active in  
exploiting the bombing. For example, it has been reliably  
reported that:

The Los Angeles County Communist Party instructed  
each Party member to send protest telegrams to the  
President, the Attorney General, and the Governor  
of Florida.

2. A meeting of the Rose Chernin Defense Committee was held on December 27, 1951, at which time it was decided to send similar telegrams. Chernin, a west coast Communist leader, presently is awaiting trial for violation of the Smith Act. (same as above)

3. The Civil Rights Congress, cited as a Communist organization within the purview of Executive Order 9835, was planning to send a special delegation to Mims, Florida, from New York City for the purpose of attending Moore's funeral. (NY tel 12-29 re CRC; Philadelphia tel 12-31 re CP, USAIO)

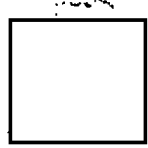

Page 89 of rerep makes reference to a security matter investigation and also reveals the identity of a former informant of the Miami Office. It is desired that this page be rewritten in the proper manner and copies be made available to the Bureau and other Offices receiving copies of this report. This should be handled without delay.

Rerep is a lengthy report and reflects very little organization in its preparation. As an example the results of interview with neighbors are scattered throughout the report rather than being grouped together in a logical manner. Likewise, investigation concerning one specific phase of the investigation is reported in various parts of the report. The report has very little continuity and is extremely hard to analyze to determine if all leads have been covered. Previous lengthy reports in the Carver Village and Jewish Property cases were very well organized and prepared and it is suggested that the form and organization of those reports be followed in future reports prepared in this case. It is also desired that a table of contents and an index be prepared in future voluminous reports in this case.

Three copies of reports are sufficient for Bureau purposes in this case.

It has been reported that suspect EARL J. BROCKLYN, also considered a "renegade", had in his possession a copy of the floor plans of the residence of MOORE. BROCKLYN supposedly had these plans at a Klan meeting at Apopka, Florida, approximately 1½ years ago. [redacted] should be questioned as to whether or not he recalls BROCKLYN having these plans in his possession.

PURPOSE:

To advise that Miami has requested authority for the interview of John M. Coe, a prominent Pensacola, Florida, Attorney, who is listed as a prominent person in the Special Section of the Security Index.

DETAILS:

Information has been developed by the Miami Division that John M. Coe, Attorney, Pensacola, Florida, recently made the statement that he had been retained by an insurance company to investigate the death of victim Moore. It is further reported that the insurance company was in the process of drawing up a policy on Moore's life, however, it is not known whether this policy was in effect at the time of Moore's death. Miami requested authority to have Coe interviewed.

Coe is the subject of a Security Matter-C investigation. The Bureau's file (100-358684) reflects the following information:

John Mareno Coe, U. S. born prominent attorney of Pensacola, Florida, has represented known Communists and racial cases of interest to the Communist Party in various courts throughout the South. [He has associated with known Communist Attorneys and has attended meetings at which Communists were present, such meetings being in connection with cases handled by Coe. He has contributed to the Daily Worker and other Communist organizations.] He was a member of the United States Army for approximately seven months during 1918. He has two sons, one served in the Air Force and the other in the Army during World War II. He has two daughters, both of whom married U. S. Naval Officers. Coe served a short time as Special Assistant to the U. S. Attorney at Pensacola, Florida to handle routine criminal cases shortly after World War I.

On August 5, 1950, Coe was ousted from the Kiwanis Club, Pensacola, Florida. At that time he reportedly said, "I am not a

Communist and I won't join the Communist Party because I won't put that yoke around my neck but I go along with a lot of their policies and believe their philosophy and principles are right but I would never resort to violence against my country." He was then asked, "Then would you say that you are a fellow traveler?" To which he replied, "I believe I can be rightfully defined as such."

The Bureau's investigation has not determined any evidence of actual Communist Party membership on the part of Coe, however, he is listed as a prominent person in the Special Section of the Security Index of the Bureau.

RECOMMENDATION:

That it is necessary and advisable to interview Coe immediately for any information he may possess which may be of value to this and related investigations. A teletype granting such authority is attached.

[redacted] Southern Knights of the KKK, contacted the Tallahassee Resident Agency on 3/18/52 and stated that he wished to report the following information:

He said that in looking over a copy of the 2/18/52 issue of The Daily Worker, he noticed that it contained a statement by [redacted] of the NAACP that nitro-glycerin was used in the murder of the two victims in this case at Mims, Florida. [redacted] said that this was the first time he had heard that nitro-glycerin had been used, however he recalled that he, [redacted], had had a conversation with Victim HARRY T. MOORE in Jacksonville, Florida about two weeks prior to MOORE's death. During this conversation MOORE confided in [redacted] that he, MOORE, feared that his life might be in danger. In this connection MOORE told [redacted] that "there is a lot of nitro-glycerine being used in this state." [redacted] received the impression that MOORE felt he had gone too far in his activities in behalf of the NAACP and the Progressive Voters League. According to [redacted] MOORE indicated to him that he intended to curb his activity in the above organizations, however he stated that he might become active for the Civil Rights Congress.

PURPOSE:

To advise that Bureau Agents attended a meeting at Tallahassee, Florida, on March 3, 1952 in an effort to learn identity of two informants of [redacted] who reportedly have information in this case, and to protect Bureau interests in that the Bureau will be able to control this phase of the investigation. As a result of the conference, additional information furnished by informants obtained and [redacted] is to contact the Birmingham Office today to further cooperate with the FBI and background of his Birmingham informants obtained which should permit the Bureau to identify the informants.

DETAILS:

On February 26, 1952, [redacted] for the Birmingham News, advised the Birmingham Office that [redacted] had gone to Opelika, Alabama, to obtain information concerning reported Klan activities in Alabama. DETAILS:

Reference is made to the Director's request "Find out why we don't have better relations with Alabama Highway Patrol" in regard to information furnished the Birmingham Division by [redacted] Alabama Highway Patrol, in reference to two informants of his who reportedly have information concerning this case.

The Birmingham Division has advised that [redacted] has been with the Alabama Highway Patrol for some period of time working as a patrolman, however, during the past two years he has devoted his time as a plain clothes investigator handling matters not within the primary jurisdiction of the Bureau. As a result, contacts with the Birmingham Office have been extremely limited. [redacted] is described as a "lone wolf" type of individual and appears interested in the solution of this case for reward purposes. Birmingham has also advised that [redacted] actions in this matter are not at all indicative of the very good relations between the FBI and other members of the Alabama Highway Patrol. Birmingham states that officers of the Alabama Highway Patrol are all most cooperative and other representatives of this organization have volunteered to be of assistance whenever possible and have been cordial and helpful.

Birmingham has reported that [redacted] is now cooperating fully and that he did not reveal the identity of his two informants originally because they had been developed as informants by him on a personal basis and the informants had specifically requested that [redacted] not reveal their identity to anyone. This informant, [redacted], has been interviewed by Agents of the Birmingham Division and has expressed his willingness to cooperate with the Bureau. [redacted] then discussed the Ku Klux Klan generally with [redacted] evidenced an admiration for [redacted] and the Klan, and indicated in no uncertain terms that he resented Negroes. Eventually the conversation got around to the Sims, Fla. dynamiting on 12/25/51, and [redacted] mentioned the fact that that case probably never would be solved. At that point [redacted] placed his hand on [redacted] shoulder and said to him, "I could go directly to the man who did it, put my hand on his shoulder just like I now have it on yours, and call him by name." [redacted] did not press [redacted] for further details, mainly because he felt that [redacted] would not tell him, however, he did get the impression that [redacted] is a "dyed-in-the-wool Klansman" and would not cooperate with the Bureau or any other agency in furnishing information pertinent to this case. He pointed out that during his conversation with [redacted] about [redacted] and Klan activities in general, [redacted] frequently used the term "we" in explaining how Klansmen recognize each other and are aware of Klan activities.

It should be pointed out that [ ] is not the "detective complex type", but on the contrary, seems to be a sober and intelligent person who has excellent potentialities as an informant in Klan activities. During the course of the interview with him, he mentioned the fact that one [ ] Apalachicola, works under him, and is a rabid Klansman in that area.

During the interview of June 9, 1952, [ ] stated he desired to cooperate with the Bureau but asked for more time to consider his position, stating that he has, since joining the Klan in July, 1951, become very active in the Klan and gained the confidence of the "inner group". He expressed fear of bodily harm to himself and family as well as the likelihood of [ ] if it should become known he is a Klansman and cooperating with the FBI.

On July 8, 1952, [ ] was recontacted. He stated he desires to cooperate with the Bureau, but only on the basis that he would not be required under any circumstances to testify in connection with this case and, further, that his identity would never be divulged. He was very emphatic in his statements regarding testifying and the maintaining in-violate his identity. [ ] was advised that if he has pertinent information every effort would be made to protect his identity but such assurances could not and would not be given if he is actually involved in the MOORE bombing. He stated he fully understands the Bureau's position in this regard.

[ ] thereafter voluntarily afforded the following information. He has been [ ] of the Orlando Klavern of the Association of Georgia Klans, and CECIL LANGSDALE, Chief of the Klokann Committee, as well as a number of other Klansmen who are noted for their readiness and availability for participation in "rides" and other acts of violence. He has won their confidence and esteem because of his [ ]. Because of this he [ ] of the Klokann Committee. [ ] has strengthened his position and increased his prestige in the eyes of his fellow Klansmen.

He advised that one [ ], a member of the Orlando Klavern of the Association of Georgia Klans, is the individual who appeared at the window of the Creamette and advised the operator he should install another window for serving negroes. In this regard [ ] stated [ ] had [ ] and [ ] had expressed some fear of being recognized by the operator of the Creamette as being the individual who had appeared at the window and made the aforementioned statements a short time before the Creamette was bombed. [redacted] said that [redacted] told him he immediately went to see CECIL LANGSDALE with the idea of using dynamite on the MOORE job. According to [redacted] never stated what type of job they intended to do before deciding to use dynamite, nor had [redacted] ever stated who, if anyone, was on the casing job with him.

He said that after [redacted] had made these statements he and [redacted] were discussing Klan matters in the [redacted] where [redacted] was at that time employed and at that time [redacted] was talking too much and that someone should caution him.

In regard to [redacted] was at one time on the Klokann Committee and was formerly employed by an ice plant in Sanford, Florida, but is now unemployed and residing in Orlando. He stated he is personally of the opinion that [redacted] was not "gassing" when he spoke of casing the MOORE place as he has observed [redacted] to be the type of individual who would do just such a thing. He said that [redacted] at one time had asked the Klokann Committee to bomb the ice plant at Sanford inasmuch as one of the negro employees had acted very "uppity". He said that although he advised [redacted] regarding the remarks made by [redacted] didn't divulge any information at that time, nor has he mentioned the matter further.

[redacted] also advised that after the Agents began making inquiries in Orlando regarding the MOORE bombing, he was contacted by [redacted] who told him that there was a job to be done and they wished his help. According to [redacted], along with [redacted] went in [redacted] to the residence of [redacted] located near [redacted] premises three cases of dynamite. The dynamite was loaded into the [redacted] of [redacted] and thereafter taken to a shack located near [redacted] on the outskirts of [redacted]. [redacted] stated the three cases of dynamite were then unloaded and placed under some lumber in the shack. He said the shack has now been torn down and there is a structure presently being erected on the site of the shack. He also disclaimed any knowledge as to any details regarding the dynamite, where it came from, for what purpose it was being held or whether or not any of the dynamite had been used from the cases. He stated the case he handled was closed and, from the weight of it was undoubtedly filled. He also advised he does not know the type, lot number or any other identifying data regarding the dynamite as he only noted the cases had the word "Explosives" printed on them. He also stated no mention was made of the dynamite by [redacted] or any of the other men, nor has any information come to his attention concerning the dynamite.

During the interview of July 8, 1952, [redacted] was questioned as to whether he himself had ever been involved in any Klan terrorist activities or in any way involved in the MOORE bombing. He said the only "ride" or terrorist incident in which he was involved was the [redacted] and before [redacted]. In regard to this occurrence he identified [redacted] CECIL LANGSDALE, [redacted] as being the other participants. He stated the Oldsmobile of LANGSDALE, the 1946 Ford maroon coupe of [redacted] and [redacted] were used. According to [redacted] the Klansmen in this incident were endeavoring to locate a negro in Winter Garden who had been involved in the cutting of a white man in Orlando and were parked alongside the street and [redacted] passed by in the taxi cab. He stated the cars parked [redacted] took in behind the cab and at that time he did not know why they were following the cab. He said that one of the Klansmen later told him the negro driver of the taxi cab made an unsavory remark as he was passing the cars, stating they were blocking the road.

[redacted] also advised that during the time [redacted] was confined in the hospital in Eustis, Florida, following his wounding by Sheriff WILLIS V. McCALL of Lake County during November, 1951 near Umatilla, Florida, [redacted] and [redacted] drove to Eustis for the specific purpose of locating and killing ALEX AKERMAN, the Orlando attorney who was retained by the NAACP for the defense of the rapists in the Groveland case. [redacted] said that upon arriving in Eustis they were unable to locate AKERMAN but did see Sheriff McCALL and at that time he and [redacted] called McCALL aside and told him the purpose of their trip to Eustis. [redacted] said McCALL advised them to return home and forget about the matter inasmuch as he had control of the situation and "everything was going to come out alright".

According to [redacted] while he, [redacted] were returning to Orlando [redacted] made a statement to the effect there was a "big SOB in the NAACP who lives at Mims and something has got to be done about him". [redacted] appears to be more intelligent and better educated than the average Klansman. He steadfastly maintained that he is in no way interested in a monetary reward for any information he might furnish. In fact, he stated he joined the Klan motivated by a sense of revenge inasmuch as he was a victim of a "ride" by the Klan. He was reluctant to give all the details of the [redacted]

[redacted] He is certain that the group [redacted] were members of the Klan but as of this date he is not certain of their identities and is interested in ascertaining their identities for revenge. He stated he is personally not in agreement with Klan terrorist activities and on a number of occasions he has been instrumental in preventing violence. He said that if he knew the identity of the individuals who did the actual bombing at Mims, Florida, he would divulge such information to the FBI.

During the interviews he has given the impression that even if he does not know the persons who did the actual bombing he has information which might lead to the ascertaining of the identity of such individuals. During the course of interview it was impressed upon [redacted] to be frank in his discussion of Klan activities so that any derogatory information which might be divulged against him, particularly in relation to "rides", might not operate to discredit him in the eyes of the Agents. He thereafter voluntarily furnished the information regarding his participation in the beating of [redacted] and the trip made with other Klansmen to [redacted] Florida. At that time he stated those were the only occasions on which he has participated in any acts of violence in connection with Klan activities.

It is realized that the attitude of this informant is strange. The Agents handling him are particularly alert for any possible chicanery. His story with regard to his entrance into the Klan and the purpose behind it leave some question of doubt. It is known that he is friendly with the Klan members enumerated in this letter and that these members are the type of individuals who would engage in terrorist activities. Extreme caution will be utilized in contacting this informant and for the time being he will be afforded all of the discreetness surrounding the contacting of an informant.

Intensive investigation is being conducted regarding [redacted] his present whereabouts, and the other members mentioned. It is not believed this informant can be "shoved" but will have to be handled diplomatically. If it appears at any time that he is not being truthful the Bureau will be advised immediately and consideration will be given to recommending possible prosecution under the Obstruction of Justice statute.

[redacted] at Orlando, Florida. His character and efficiency ratings are shown as being from Unknown to Excellent. He does not have a record of courts-martial, AWOLs or any other derogatory information. His military occupation was that of an investigator.

From the inception of this investigation, every effort has been made to develop a Confidential Informant who can assist the Bureau in the ultimate objective of this investigation - the solution of the HARRY T. MOORE case. In order to obtain the confidence and cooperation of [redacted] it was necessary to assure him that his identity will be kept inviolate and he would not be called upon to testify at any time regarding Klan activities. However, it was clearly pointed out to him at the very beginning, should it subsequently develop he was actually involved in the MOORE bombing, he will be treated as any other participant. He fully understands this. In this regard, [redacted] has steadfastly maintained from the first time he was contacted that he is absolutely in no manner personally implicated in the MOORE bombing.

It is desired to point out to the Bureau that the information furnished by [redacted] to date has been acquired through numerous interviews with him.

At the very outset the Informant was willing only to volunteer information concerning [redacted] and the moving of three cases of dynamite from [redacted] house near Sanford, Florida. Upon subsequent contact, it was pointed out to [redacted] that it is necessary for the Bureau to know of any Klan terrorist incidents in which he may be involved so that the Bureau can evaluate his information and the Informant's position.

On a subsequent contact, [redacted] furnished information regarding the [redacted] Florida allegedly to [redacted]. He also furnished information as to the identity of the participants in the [redacted] Negro taxi cab driver at Winter Garden, Florida, on January 12, 1952. In the latter incident, [redacted] did not mention the implication of [redacted] but on a subsequent contact, he volunteered the information that [redacted] was involved in the shooting-flogging of [redacted] and it was [redacted] automobile which was used and referred to by [redacted] as one of the cars parked on [redacted]. [redacted] stated that he was reluctant to mention [redacted] name at the outset because of a [redacted] existing between [redacted]. At this time he also advised that CECIL LANGDALE, head of the Klokann Committee of the AGK, has an intense hatred of the Negroes and for some time has been talking of bombing the Negro school which has been constructed near the LANGDALE residence. In this regard, [redacted] advised that LANGDALE has prepared a sketch of the school and has pointed out the places where he believes that dynamite bombs would be effective in bringing the total collapse of the new school.

On later interview, Agents told [redacted] that they felt that he was not divulging all the information which he possesses regarding Klan terrorist activities. [redacted] made a statement to the effect that such could be true.

The following day he contacted the Agents and at that time furnished the complete details regarding the bombing of the Creamette in Orlando, Florida. He had previously furnished information regarding the implication of [redacted] in the bombing of the Creamette. Since affording the information regarding the bombing of the Creamette, [redacted] had stated that all the information to his knowledge regarding Klan terrorist activities has been furnished by him to the Agents.

He has been helpful in furnishing background information on numerous principal Klan members as well as regarding other individuals about whom he has been questioned.

[redacted] has stated that it is his opinion that CECIL LANGDALE, [redacted] may be the individuals who were actually implicated in the MOORE bombing. He has stated that he does not have any specific information at the present upon which to base such a conclusion other than the fact that [redacted] made the statement that he, [redacted], had cased the MOORE house, and upon his return to Orlando had conceived of the idea of using dynamite and had thereafter approached CECIL LANGDALE with this idea. Informant has pointed out that it is his belief that these men may be so implicated inasmuch as he has observed them and the fact that they have already been previously engaged in terrorist activities which to him clearly indicates that they would without hesitation have done the MOORE bombing.

He has stated that he has the confidence of these individuals: he himself, [redacted] CECIL LANGDALE. It is his present intention to endeavor to obtain additional information regarding the remark made by [redacted] by trying to bring into the open between himself and the key individuals as to what participation, if any, they had in the MOORE bombing. As he has stated, and it is clearly understood, such a strategy will require time and the progress will be slow and somewhat tedious.

[redacted] has reiterated on a number of occasions that all the information furnished by him is the truth and he will gladly submit to a lie detector examination regarding any of the information furnished by him to further prove to the Bureau that he is telling the truth about all of his Klan activities and the statement made by [redacted].

At the present time, all persons mentioned by [redacted] as participants in these terrorist activities who have not heretofore been interviewed, have been interviewed with the exception of CECIL LANGDALE and [redacted]. [redacted] will be interviewed in the next few days, and LANGDALE, apparently being a key figure from the information furnished, will be interviewed when it is deemed appropriate. Every effort has been made in the interviews of these individuals to conceal and protect the Informant and at the same time attempt to elicit from them their admission of their own participation. The interviews to date have been completely unproductive.

The Informant has stated that several individuals who have been interviewed by the Agents without results have contacted [redacted], the Exalted Cyclops, advising him of their interview and seeking advice.

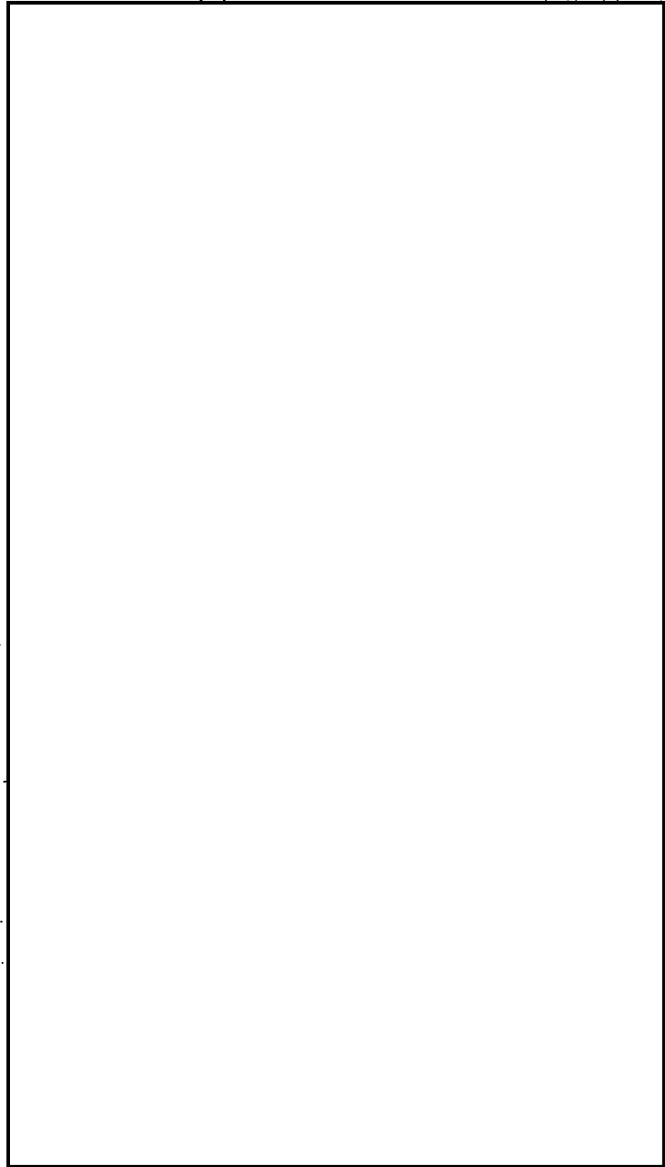

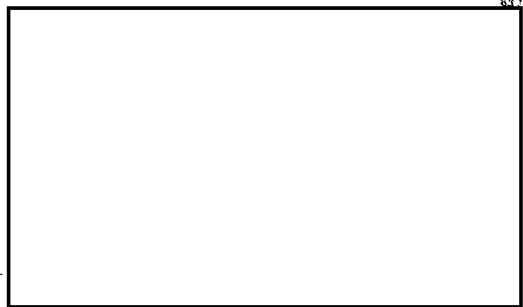

HARRY T. MOORE

SAC Wall called from Miami and advised that the Special Federal Grand Jury hearing testimony relating to the Miami bombing cases will begin inquiring into the death of Harry T. Moore on February 4, 1953. At this time testimony will be heard from [redacted]. The Grand Jury will then recess until February 18, when testimony will resume in the Moore case.

Wall advised that the [redacted] who will be subpoenaed on February 4 are [redacted]. Those [redacted] to appear are [redacted].

Wall stated that, as has been the custom, the subpoenas for the afore-named [redacted] will be served by the Bureau. Wall requested Bureau authorization to make available necessary expense money for the [redacted] to appear at Miami on February 4. He stated that [redacted] of the [redacted] were in the vicinity of Orlando, Florida, while [redacted] is presently at Aiken, South Carolina.

RECOMMENDATION:

It is recommended that the attached [redacted] go forward to Wall, authorizing him to make available necessary expense money, not to exceed \$100 per [redacted], in order that these [redacted] will be in Miami to testify before the Grand Jury on February 4, 1953. Wall suggested the above procedure in order to preserve the surprise effect of the testimony to be furnished by these individuals. It will be noted that in order to obtain payment for testifying before the Grand Jury, it would be necessary for them to sign the official register, which is a public record and, as such, available to all.
