#1. It cannot be determined from the notes if the tests were performed in a scientifically acceptable manner.

#2. The results are not adequately documented in the notes. The notes are not dated, are in pencil instead of ink and use abbreviations difficult to interpret. The technician did not document the recovery of hair from the evidence. The examiner did not document the full range of microscopic characteristics of the suspect's and victim's known hair as he normally does.
