#1. It cannot be determined from the notes if the tests were performed in a scientifically acceptable manner. It appears that the technician performed analysis and comparison of the fibers and duct tape in this case instead of Malone.

#2. The results are not adequately documented in the notes. The notes are not dated, are in pencil instead of ink and use abbreviations difficult to interpret. Documentation of testing performed on the fibers is not marked with the lab number, date or initials. The technician does not document the recovery of hair from the evidence.

#3. The testimony about the significance of the hair match (p. 20) that it would be "almost non-existent" to find somebody else with head and pubic hair like the defendant's is much stronger than the opinion in the lab report that the hair "either originated from HUF, or from another Caucasian individual" whose hairs "exhibit the same individual microscopic characteristics" as the hair from HUF. The report further states "It is pointed out that hair

comparisons do not constitute a basis for positive personal identification". The testimony is also much stronger than this statement in the report.

#4. RQ testifies (pp. 16, 17) that he found three pubic hair and three head hair on item Q12, but his examination notes show "A few" pubic hair and "A few" head hair were found. He also testifies (p. 25) that he examined the duct tape but the bench notes indicate the examination was conducted by the technician.
