#1: With microscopic hair comparison, even with the best notes, there is no way to determine the comparison was performed correctly.

#2: The examination results set forth in the laboratory report are supported by the bench notes, but the documentation is marginally adequate. The notes are not dated or initialed and are in pencil. RQ uses abbreviations to indicate the microscopic characteristics of the hair. These abbreviations are difficult to interpret.

The hair matches were apparently verified by a second hair examiner.
