(1) - Were appropriate scientific tests conducted?

→ Reviewer is unable to determine if an adequate and scientifically acceptable hair comparison was conducted based on the documentation in this exhibit.

→ Abbreviations are used to describe characteristics in hair - many^{cll} some of these abbreviations and their meanings would only be known to Agent Malone (or perhaps his colleagues at the FBI). A minimal number of characteristics is listed for K16, pubic hairs of victim. The characteristics listed are not very different from the characteristics listed for K17, pubic hairs of suspect. Although the examiner (Malone)

lists many more char. fr the suspect's hair, it is not clear to this ^{reviewer, clt} ~~examiner~~ how these pubic hairs from 2 diff. sources differ.

(2) Are the examination^{clt} results supported and adequately documented in the bench notes.

As stated above, the notes do not reflect or document the differences noted in the pubic hairs from the suspect (K17) and the victim (K16).

The notes associated with the Q126 hair indicate (from my interpretation of the notes + abbreviations) that perhaps this was a partial hair. It is at this reviewer interprets the abbreviations in 1 case to read 'base end, bkn (broken)'. If this hair was truly broken this should have been mentioned in the report - this could alter the 'weight' or interpretation/significance of the hair association.

The phrase 'independent microscopic characteristics' is confusing and could also be misleading. This may be just an adopted phrase - repeatedly used but not understood. The notes do not support the use of the term independent.
