2. THE TITLE PAGE OF EACH PUBLICATION SHALL CONTAIN THE FOLLOWING STATEMENT: "COMPILED BY WORKERS OF THE WPA WRITERS' PROGRAM OF THE WORK PROJECTS ADMINISTRATION IN THE STATE OF WEST VIRGINIA."
3. AFTER PUBLICATION, THE MANUSCRIPT SHALL BE RETURNED TO THE SUPERVISOR OF THE WEST VIRGINIA WRITERS' PROJECT.
4. IF APPLICATION FOR COPYRIGHT IS MADE, THE SPONSOR AGREES TO RELINQUISH ALL CLAIMS TO THE COPYRIGHT AT THE EXPIRATION OF FIVE YEARS FROM THE DATE OF PUBLICATION. THE WORDS "WORKERS OF THE WPA WRITERS' PROGRAM OF THE WORK PROJECTS ADMINISTRATION IN THE STATE OF WEST VIRGINIA" SHALL BE INSERTED WHERE "NAME OF AUTHOR OR TRANSLATOR" OCCURS IN THE APPLICATION FOR COPYRIGHT.
