The name of the woman referred to by Winchell is not known to the Bureau. The Assistant Editor on the Foreign Desk referred to by Winchell is probably [REDACTED] of the Foreign News Desk, "New York Times."

Winchell, in his broadcast, 11-20-55 stated that "Over thirty newspaper people have been subpoenaed from the most famous newspaper in the world."

By airtel, 11-4-55, Bureau advised New York, San Francisco, and Washington Field Office of scheduled hearings of Senate Internal Security Subcommittee. Airtel instructed New York to immediately search indices on probable witnesses; to bring cases up to date; to reopen cases on individuals and organizations where necessary to bring up to date; and to submit reports promptly. Winchell Said:

"Albany - The New York State investigation into wire tapping may be made public next month - spicy - a legal tap made by private sleuths in divorce cases in New York."

Comment:

Washington News Service, 11-23-55, carried a story that Prime Minister Eden had appointed Lord Jowitt as one member of a Commission to investigate security in the Foreign Office. Lord William Allen Jowitt is former Attorney General and Solicitor General of England, who authored book entitled "The Strange Case of Alger Hiss" which was completely pro-Hiss.

Winchell Said:

"New York - G-men are rounding up Latin American Reds in the United States. Three Mexicans in New York to buy arms and ammunition were arrested. Many more expected this week."

Comment:

We have no information concerning this matter which probably relates to a case being handled by the Bureau of Customs. As you know, we have no jurisdiction over the illegal exportation of arms, ammunition and implements of war. Such violations are under the jurisdiction of the Bureau of Customs.

Winchell Said:

"J. Edgar Hoover, the Chief of the FBI, has shown powerful strength as the Republican darkhorse. Stale news to those who followed the recent Winchell poll."

Winchell Said:

111. "Chicago - Pat Gillon (or Dillon - phonetic) kidnapper of two women has been captured and admitted rape of one."

Comment:

Calls to Night Supervisor, Investigative Division, and the substantive supervisor of Kidnapping Desk did not disclose any data concerning the capture. Night Supervisor, Investigative Division, instructed Chicago Office to ascertain details. Chicago teletype 10:05 P.M., 12-4-55, reported inquiry disclosed subject Patrick M. Dillon kidnapped two women but no Bureau violation involved.

Winchell Said:

"New York City, U. S. Court House - Senate Internal Security Subcommittee has subpoenaed one of the top editors from New York evening newspaper. This witness will be confronted with a name as an alleged Communist Party member."

Comment:

Memorandum from Mr. Belmont to Mr. Boardman dated 11-28-55 captioned as above reported Bureau previously advised that the Senate Internal Security Subcommittee contemplates holding hearings to investigate alleged Communist infiltration in the "New York Times." Airtel to New York Office dated 11-4-55 instructed New York Office to search indices on probable witnesses to bring case up to date and to submit reports promptly. (62-88217)

The individual referred to by Winchell may possibly be identical with [redacted] of the "New York Post" who was reportedly a member of a Communist group in about 1933 and 1934. (65-58081-102)

Winchell Said:

"A third member of a leading morning paper resigned following a subpoena. He is one of five of the book section 1955 that paper."

"House Committee on Un-American Activities hearings will commence in Chicago on December 13, 1955."

Bureau is cognizant of HCUA hearings scheduled to start 12-13-55 concerning Communist infiltration of the National Labor Relations Board and other Government agencies based on information furnished by [redacted] Bulet dated 11-18-55 to Washington Field Office and other interested offices instructed Bureau be advised of pertinent details obtained from reliable sources concerning hearings.

Winchell Said:

"Wire tapping revelations in New York City have sent income tax men to Los Angeles to check on all private detectives. More (wire tapping) equipment has been sent to Los Angeles area than New York City."

The author has written a very detailed biography of Walter Winchell going back to his birth on April 7, 1897, and his boyhood with "tough groups of Italian, Jewish, and Negro kids" who fought each other with bare fists, milk bottles, and bricks. He gives details of Winchell's life as a tap-dancer and shows how he gradually worked his way from an unknown writer of news items printed on the back of theater programs to the powerful figure he is today in the newspaper world.

The Director and the FBI are mentioned a number of times in the book. These instances are set out below:

Page 56- The author states that despite his substantial income, Winchell was intrigued with the idea of more money, and, in 1930, he accepted a week's engagement as an entertainer in a Chicago theater. At this time, according to the author, Winchell was getting a great deal of his information from members of the underworld and they felt he needed protection on this trip to Chicago. So when he boarded the train he found a "plug-ugly" at his side. When Winchell protested he was told to "Siddown and shaddup!" He says that a few minutes later Winchell discovered that he had a second bodyguard on the train when a young man approached him and said, "Excuse me, Mr. Winchell, I was on my way to report to our office in Chicago when Mr. J. Edgar Hoover suggested that I keep watch over you on this journey."

Page 57-
"At this time, J. Edgar Hoover was already the head of the Federal Bureau of Investigation, but the F.B.I. was not yet glamorous, and only a few people knew of its existence or the identity of its chief. Hoover, however, was already a friend of Winchell's."

Page 58-
"The friendship between Boney Madden and Winchell soon became a matter of widespread gossip, and finally

came to the attention of the now-famous G-man. Hoover sought out Winchell and cautioned him, saying, 'Walter, you shouldn't be seen with men of Madden's type. He's a killer and....'

"I know all about him," Winchell replied. "I know I'm keeping bad company. Why, only yesterday I had luncheon with the Police Commissioner."

Page 69- In speaking of the Lindbergh kidnaping case the author states:

"In 1934, Winchell's spectacular intrusion into the Lindbergh kidnaping case gave the columnist an almost unheard-of amount of publicity....

"On September 12, 1934, this line appeared in the Winchell column: 'The Federal men are convinced that they will break the most interesting crime on record-- the Lindbergh snatch.' Seven days later, Bruno Richard Hauptmann was arrested, charged with kidnaping the Lindbergh baby.

"This one sentence in the Winchell column convinced readers that the columnist had an inside track on F.B.I. information, and Winchell was not one to let his public down."

The author says that Winchell scurried around to discover unknown facts about the crime and finally learned that one rail of the kidnapper's ladder matched a portion of the wood flooring of the attic in Hauptmann's home and Winchell made the most of his scoop when he stepped up to the microphone, but where he received his tip is still a secret.

Page 70-

"On September 19, 1934, five minutes after Hauptmann had been apprehended, Winchell knew about it. But at the request of J. Edgar Hoover, who wanted to give his G-men an opportunity to get certain evidence, Winchell made no announcement of the fact until twenty-four hours later.

"By doing so, America's most news-hungry journalist sacrificed what is most dear to every newspaperman--a scoop. And up to this time, it was the most important one in his career. However, some of the sting was taken out of his disappointment when, many months later, he received the following letter from J. Edgar Hoover:"

December 13, 1955

The letter from Mr. Hoover is then set forth in the book on page 71. It was dated April 17, 1936, and related that Mr. Hoover, while speaking to a group of newspaper editors of America on the previous day had pointed out some of the things newspapers had done to help the FBI and without mentioning Winchell's name told them how a well-known columnist had refrained from printing a truly national and international scoop in the Lindbergh case for twenty-four hours, in order not to harm the investigation. The letter was signed "John."

Pages 72 and 73- The author furnishes the details of how Winchell personally delivered Louis (Lepke) Buchalter to Mr. Hoover through a series of telephone calls and underworld contacts. The actual apprehension is reported in the book in this fashion:

"Following orders, Winchell was at the drugstore at the appointed hour. In a few minutes, a stranger approached him. 'Tell Hoover to be at Twenty-eighth Street and Fifth Avenue between ten-ten and ten-twenty,' he said Winchell telephoned Hoover and, when he returned to the car, the stranger was behind the wheel. Winchell got in and sat down beside him in the front seat. They drove off, ... He stopped at Twenty-eighth Street and Fifth Avenue, got out, and escorted his guest to a black limousine, inside of which sat the head G-man.

"Mr. Hoover," said Winchell, "This is Lepke."

"How do you do, Mr. Buchalter," said the G-man.

"Glad to meet you," said Lepke."

The author said that whether or not Winchell helped to arrange it so developments in Lepke's capture coincided with his newspaper's deadline is, of course, open to question. But coincident or otherwise, Winchell was succeeding in keeping his name on the front pages of the nation's newspapers.

Pages 90 and 91- "Months and months of expose' by Winchell and others made New York an uncomfortable place for Edward James Smythe, and he, too, decided to leave. Peculiarly enough, his decision to depart from New York coincided with FBI curiosity as to his whereabouts. A Washington, D. C., federal grand jury had included Smythe in an indictment, and the authorities were anxious to produce him in court. F.B.I. agents finally picked him up near the Canadian border. 'Wrong-way Smythe,' wrote Winchell, 'What a sense of direction. Traveling toward Canada when he should have aimed for Germany.'"

Page 135- In speaking of the tremendous amount of correspondence received by Winchell the author states: "If a letter should, in his opinion, be brought to the attention of the F.B.I. or other government bureau, he scribbles a note on it, directing his secretary to forward it."

Page 142- Between pages 142 and 143 are several photographs of Winchell showing him as a small newsboy, with members of his family, with Martin Dies, Al Jolson, Damon Runyon and Sherman Billingsley.

Page 215-

"J. Edgar Hoover, head of the F.B.I., is not a source of information, as some people have intimated. Winchell and the G-man are old and good friends, but that is where the matter ends. The two men frequently take dinner together, but if the reporter gets information from Hoover, it is the result of a chance remark during the course of conversation and nothing more. In this regard, it should be noted that Hoover is by nature and experience habitually cautious.

"The friendship between the G-man and the reporter goes back many years, to the time when the Bureau was an unimportant and little-known arm of the federal government. Winchell long ago appointed himself press agent to the investigating agency. Though he was never asked to do so, he embarked on a vigorous campaign for a larger budget for the Bureau and for higher salaries for its personnel....

"For his unflagging efforts, Hoover and every member of his agency were grateful to Winchell. But this attitude gave the reporter no special entry, and he has never received advance tips on Bureau releases. As a matter of fact, it works quite the other way around. As the recipient of thousands of letters annually, many of them containing information important to the investigating agency, Winchell turns over to the F.B.I. a tremendous number of tips, probably more than anyone else in the country.

"While J. Edgar Hoover is not a Winchell tipster, there are many men high in the government who are. Congressmen and various government-agency executives are regular sources of information."

Other items of interest in the book would be the notation on Page XIV of the Introduction, where the author is giving various views expressed by people on Walter Winchell, both pro and con. He quotes Mr. Hoover as writing: "The men in the Government service are cognizant of the tremendous job Walter Winchell is doing in this war." Following this he quotes the late Eleanor (Cissie) Patterson, publisher of the Washington Times-Herald as writing: "Walter Winchell suffers from a chronic state of wild excitement, venom and perpetual motion of the jaw."

On Pages XVII and XVIII of the Introduction the author states: "Walter Winchell is loved and hated, appreciated and resented, encouraged and harassed. He is viewed by some people as a cultured man while others call him a barbarian. One group acclaims his honesty, and another condemns his deceit. Some individuals are convinced he is a benevolent do-gooder, and others swear he is a vicious self-seeker."

The author then quotes different people's opinion to show the widely differing views of Winchell:

"Walter is a cockroach." (Morris Beale, pamphleteer)

"He's a gent's-room journalist." (Westbrook Pegler, columnist)

"He's an unnecessary evil." (A reader, in a letter-to-the-editor column)

"He is a brilliant bore....He is a menace....He is inaccurate... Something should be done about his success--it is revolting...." (St. Clair McKelway, author)

"Thank God for Walter Winchell." (Sterling North, author)

The author is very complimentary about Mr. Winchell's wife, June. He says that Mrs. Winchell is Mr. Winchell's severest critic, "and he considers her to be the only person who is completely honest with him in evaluating his work. She is probably one of the few who dares to tell him exactly what she thinks." (Page 22)

Winchell's real name, according to the author, was Winchel. He is the son of Jacob and Janette Bakst Winchel who had come to America only a few years prior to his birth. (Page 26) "In one town, the electrician inadvertently added an extra "l" to the name Winchel. The added letter seemed to lend weight to the name, and Winchel decided to keep it "Winchell" for good." (Page 34)

December 14, 1955

The author states that Winchell's boyhood was hard and bitter, his acting career dramatic and showy, and these elements are certainly an essential part of Winchell the man and Winchell the commentator.

(Page 37)

On Page 79 the author states that with the appearance of anti-Winchell propoganda in the German press, the reporter knew that he had succeeded in provoking the fight he was looking for. The crusade was becoming worthwhile. "These bastards are vulnerable," Winchell told a friend. "They can't be the supermen they claim. They wouldn't squeal so loud if they were." (Page 80)

The author uses a rather unique expression at the bottom of Page 81 where he says, "Winchell was accumulating enemies as easily as a dog does fleas."

In explaining Winchell's meeting with President Roosevelt the author states that, "One day, Winchell met Joseph P. Keenan, who was then Assistant U. S. Attorney-General, in the Stork Club, and in the course of conversation, Winchell told him of his desire to meet the President. Keenan smiled wisely, and said, "It may happen sooner than you think." A few days later, Mr. Winchell met the President at the White House. (Page 183)

The author goes into great detail to explain the ups and downs Winchell has had with the censors on his TV program and the various fights he has indulged in through his statements on TV and statements in the press which even led to lawsuits and finally Winchell's request to the American Broadcasting Company to cancel his lifetime contract. "The request was granted, and the commentator did his final simulcast for that network on June 26, 1955. A few weeks later, he agreed to do a Sunday-evening-at-six radio broadcast for the Mutual Broadcasting System, to commence on September 11, 1955. (Early in September, however, Winchell filed a seven-million-dollar lawsuit against the American Broadcasting Company, claiming that amount for damages and lost income in connection with his lifetime contract.)" (Page 262)

SYNOPSIS

Weiner has written an interesting, fast-moving biography of Walter Winchell from his birth to the present day. The author relates that: Winchell is the son of Jacob and Janette Bakst Winchel who came to America a few years before his birth on April 7, 1897. He added the second "l" to his name after seeing his name misspelled "Winchell" on a theater marquee. Winchell's boyhood was hard and bitter, acting career dramatic and showy, and these elements are certainly an essential part of Winchell the man and Winchell the commentator. Mr. Hoover and the FBI are mentioned several times in the book. The author mentioned that Mr. Hoover and Mr. Winchell were already friends in 1930 when Winchell, en route to Chicago, found Mr. Hoover had requested a young Agent, also en route there, to "keep watch over" Mr. Winchell on this journey. (p. 57) Mr. Hoover warned Winchell about associating with gangsters like Owney Madden. (p.58) Winchell's part in the Lindbergh case is given. (p.69-71) Winchell's big scoop in turning Lepke Buchalter over to Mr. Hoover is set out on pages 71 through 73. The author says on page 81 that "Winchell was accumulating enemies as easily as a dog does fleas." Several photographs of Winchell are inserted between pages 142 and 143 showing him at different times of his life from boyhood to manhood. One of the most important things in the book from our standpoint is set out on pages 215 and 216 when the author states: "J. Edgar Hoover, head of the F.B. is not a source of information, as some people have intimated." He then goes on to explain in great detail how the friendship started, how Winchell appointed himself press agent to the Bureau and though Mr. Hoover and the Agents were grateful it gave Winchell no special entry, "and he has never received advance tips on Bureau releases.... While J. Edgar Hoover is not a Winchell tipster, there are many men high in the government who are." The author sets forth the many fights Winchell has had with individuals, with his bosses, with censors, the statements which he has made on the air and in the press that have caused him trouble and his request to be let out of his contract with the American Broadcasting Company June 26, 1955. (page 262) The items mentioned in this synopsis have been set forth in detail in the attached six-page memorandum of the facts.

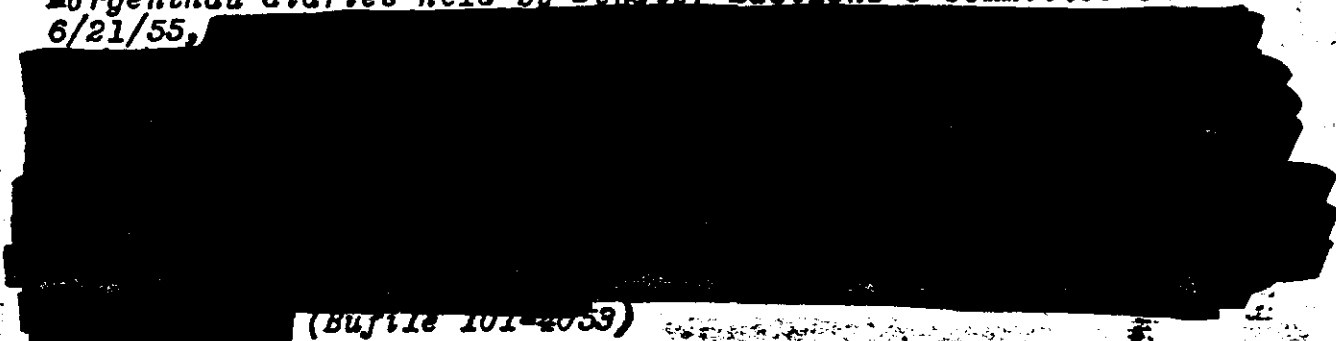

I especially remind the members of the Press Club in Los Angeles that I told them all that several years ago in a speech. I also told it to the editors of the 'New York Times' through my own column in the 'Mirror.' The 'New York Times' publisher wrote me a letter assuring me there was absolutely nothing to it. A big exaggeration, he said.

"Ladies and gentlemen, there were more Government subpoenas handed to people on the 'New York Times' than any other newspaper for this investigation. That newspaper now fears that the Senate probe might impair the free press. It conceded that the press was properly the subject for congressional inquiry. Then, the 'New York Times' scorned the investigation as an inquisition before all the evidence, incidentally, was made public. In this case, the 'New York Times,' which is strenuously opposed to one-man investigations, acted as its own judge, its own jury and chief propagandist. The newspaper then says it believes in redeemable sin. Communism is not merely a sin. It is a crime! Overthrow the United States, for instance--surely the sophisticated 'New York Times' knows that Communism is more than a moral issue. It is a police problem. The fact is, ladies and gentlemen, no newspaper, including the 'New York Times,' is as pure white as it claims. The senate committee is not as black as it is painted by the 'Times.' The controversy involves different shades of grey and pink. No newspaper should fear a lie. It can always retaliate with the truth even when some of the Reds on the staff can slant the news. If a newspaper is too weak to survive an investigation, it is not strong enough to serve as a fortress of democracy. Those who carry the torch of liberty must not be afraid of the light."

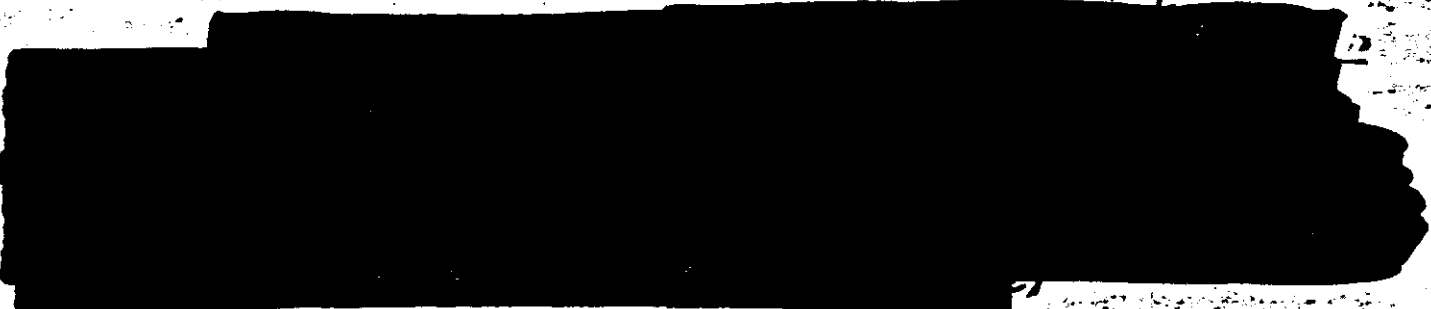

Director has inquired concerning item appearing in above column which questioned "Why is the Dept. of Justice suddenly probing a top investigator for a Senate Committee?"

Not possible to definitely identify individual referred to, but probably refers to Robert Morris, who reportedly is returning to the Committee on the Judiciary, U. S. Senate. Morris was formerly employed as Special Counsel, Subcommittee of the Committee on the Judiciary Investigating the Administration, Operation and Enforcement of the Internal Security Act of 1950 and is presently a judge in the State of New York. Morris was investigated in 1953 in connection with above employment. No request has been received for current investigation; however, on 1-26-56, chief clerk, Senate Judiciary Committee, advised Morris was returning to that committee and chairman would request Bureau to bring 1953 investigation up to date.

While the Commission on Government Security does not fall in category of "Senate Committee," the Bureau on 1-24-56 completed an investigation of former Special Agent Robert A. Collier for the commission. Collier formerly employed by House Judiciary Committee in 1953, House Appropriations Committee in 1954 and the Senate Committee on Government Operations in 1954.

Bureau is currently investigating former Special Agent Charles M. Noone for this Commission. Noone was employed from 1951 to 1953 by the Senate Select Committee on Small Business. This request was received 1-20-56. On 2-1-56, the same date as the news item appeared, the Bureau received a request from the Commission on Government Security to investigate former Special Agent Edward C. Kennelly. Kennelly was employed from March to June, 1952, by the Senate Committee on Agriculture and Forestry; from August, 1952, to January, 1953, by the House Select Committee to Investigate Foundations; and from March, 1953, to January, 1955, by the House Government Operations Committee.



full support to the National Conference on Civil Rights being sponsored

Winchell Said:

"Membership in the Communist Party at Los Angeles is now at an all time high."

Comments:

The statement above by Winchell is erroneous insofar as the membership figures are concerned. It is not an all time high. It is believed that reference in this case to strong membership in Los Angeles in fact concerns information furnished by key informants to the effect that there was less retrenchment in Los Angeles than in other parts of the country. This was due in great part to the strong leadership in the Los Angeles District.

Winchell Said:

"Red leaders in the far northwest are having great trouble getting members to serve as officers. All comrades out there rejected the post of regional treasurer."

Comments:

Latest information reflects Elmer Kistler is the District ^{WASH} Treasurer, District #12 (Seattle). It is believed Winchell's remarks are more suited to the difficulty District #12 is having in filling the position of District Organizer. This position is still unfilled due to trouble in locating a responsible leader to take over as District Organizer. Leadership for this area is controlled at this time by Milford A. Sutherland, Organizational Secretary, which position is actually first assistant to the District Organizer. (Bufile 100-3-20-1290)

Comments:

The Bureau is cognizant of the hearings being held by the US Senate Committee concerning alleged Communist influences in New York newspapers. The New York office was instructed by airtel dated 11-4-55 concerning handling of cases pertaining to individuals who might be witnesses. Public hearings commenced 1-4-56 will resume 2-8-56. On basis of limited data furnished by Winchell no identification or possible identification can be made of the person or persons referred to or the newspapers involved.

Winchell Said:

"Washington, D. C.: The Senate investigating committee is quietly probing the activities of another Interstate Commerce Commissioner. A trucking company is involved."

Comments:

This probably refers to Hugh W. Cross who, although the Interstate Commerce Commission was not directly involved, allegedly injected himself into a contract granted by the railroads in Chicago to a company affiliated with the Keeshin Motor Truck Lines. This contract related to the transfer of baggage between various railroad terminals in Chicago. This was prominently mentioned in the newspapers about two months ago. The Department did not request investigation, it being noted no clear-cut allegation of conflict of interest violation.

Winchell Said:

"The Congress will pass an Adoption Mann Act making it a federal crime to carry a baby across state lines for adoption for a profit. The profit is the essence of the crime."

Comments:

None. For your information.

Winchell Said:

"The Government says it will deport Tokyo Rose as an undesirable alien. She cannot be deported according to experts on constitutional laws."

Tokyo Rose whose true name is Iva Ikuko Toguri ~~X~~ D'AguiNO, was convicted of treason 9-29-49 and sentence 10-6-49 to ten years in prison and \$10,000 fine. She was investigated by the Bureau and our case is presently closed. The Bureau has no knowledge of deportation plans which would be the responsibility of the Immigration and Naturalization Service. "Bernes: The Balkan underground is now convinced that Malenkov's job is a front. His title is Commisar of Electric Production. His real operation, I am told, is Chief of Foreign Intelligence like the late Beria."

Winchell Said:

"It is now definite that the march on Washington to promote civil rights legislation will be staged March 5. The Reds are mobilizing to try and take over that meeting." 1956

Comment:

In his broadcast of 1-29-56 Winchell referred to such march possibly taking place next March. The Bureau is cognizant that the Communist Party is giving full support to the National Conference on Civil Rights being sponsored by the National Association for the Advancement of Colored People. Leaders of the CP, USA, describe the conference as a "March on Washington." The conference is scheduled for March 4 - 5, 1956. Details were set forth in "Current Intelligence Summary" dated 1-18-56.

Winchell Said:

"As a result of the Paul Hughes acquittal in New York last week the Department of Justice will investigate the activities of a very top leader at ADA many times exposed by me."

Comments:

Winchell is possibly referring to [redacted] Americans for Democratic Action, who testified as a Government witness in the perjury trial of Hughes which resulted in Hughes acquittal on 2-3-56. Hughes had been charged with lying to a grand jury investigating Harvey Matusow. Although there were inconsistencies noted in the testimony [redacted] the Department has given no indication it intends to pursue the matter and we have not been requested by the Department to investigate [redacted] (74-1686)
