Winchell Said:

"Washington Post: The House Committee on Un-American Activities will step up its probe of The Fund for the Republic. Investigators are now busy on the case in New York City and on the West Coast."

Comments:

The Bureau is cognizant of the interest of the House Committee on Un-American Activities in The Fund for the Republic. We have been following the matter and taking appropriate action where indicated.

Winchell Said:

"Mr. and Mrs. United States: The significance of the talks between the President and the Prime Minister is not in the newspaper headlines. It is in the files at United States Intelligence. The fact is that the most deadly pattern in all history is repeating itself. The meeting between Mr. Eden and President Eisenhower corresponds exactly to the visit of the British king and queen to Roosevelt in 1939. It is intended to serve notice on the Communists that the two major democracies will stand or fall together. That was the reason behind the royal visit in 1939 - to notify Mr. Hitler that Great Britain and the United States would fight. Hitler did not believe that warning and neither do the Reds in Russia. The ten Communist countries apparently do not satisfy them. They have readied another program along the lines of 'Heads, I win; tails, you lose.'"

"This is it - the Russians want and will get another war in the Middle East. As usual, not one Russian soldier will be involved. Red arms will provide the margin of victory in such a war. It also means the West will be deprived of all the oil fields in the area involved. Best of all from the Communist viewpoint, the United States will be engaged in a national election. To Americans an election means a privilege, but in power politics it means paralysis until it is settled. During our campaign Communists will unleash a violent anti-Semitic campaign. In simple words it is the same old totalitarian swastika masquerading as the hammer and sickle. The President has served notice we will not stand by idly, because a Red Army straddling the Middle East is only a way station on the road to its final objective - 1600 Pennsylvania Avenue, Washington, D. C."

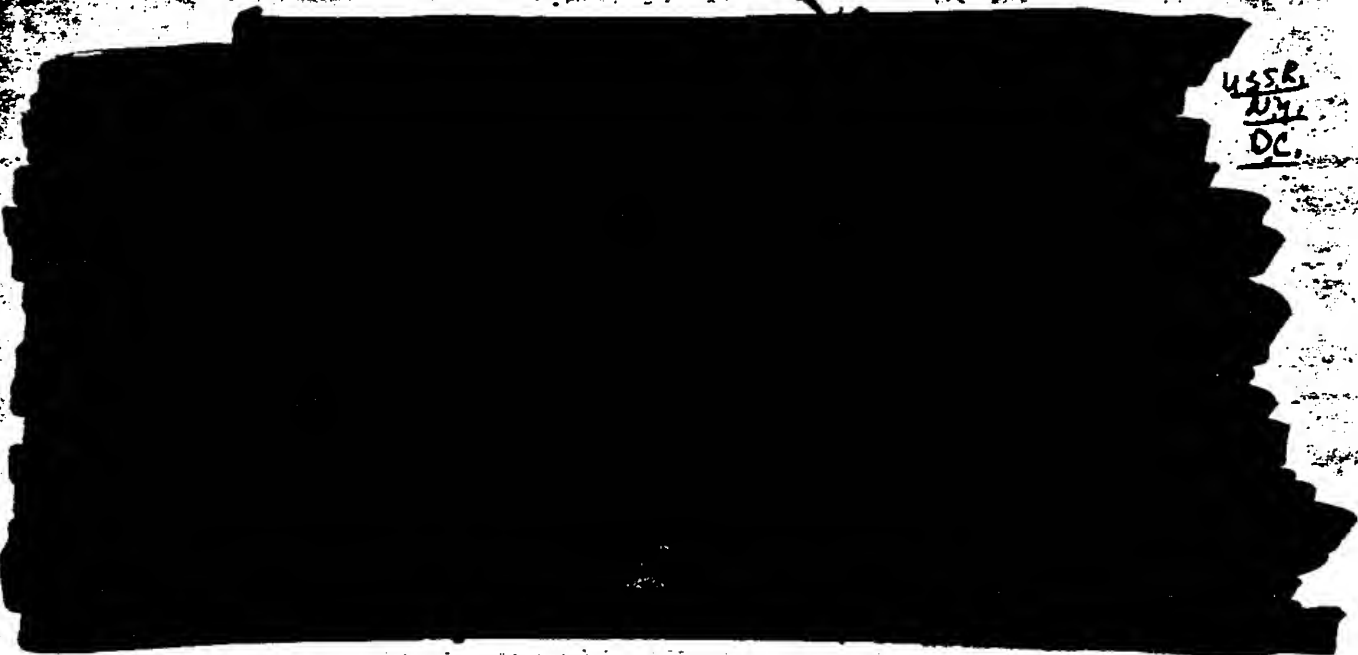

WINCHELL SAID:

"The Communist Party has a new gimmick to fight the Smith Act, which has failed so many of their leaders. All comrades must now sign a statement that they never advocated overthrow of this Government. If a signer later testifies for the Government in Smith Act cases, the Communist Party will use the signed statement to refute his testimony."

COMMENT:

The Bureau is cognizant of this tactic by the Communist Party. The matter has been discussed with the Department and SAC Letter was sent to the Field in November, 1955, instructing that current informants scheduled to testify at security trials or hearings should make such oral admission or signed statement, if requested to do so by the Party, up to the time the trial or hearing begins, but after such time they should refuse. If an informant makes an oral or signed statement, he should immediately submit a report to the Field Office, setting out complete details and should state the admission was made or statement signed, not because it was true, but solely to protect the informant's status.

WINCHELL SAID:

"Washington Post: The U.S. Internal Security Committee has subpoenaed a large group of Americans working for Tass News. This agency feeds news to Russia. They appear this week in executive session. One is an American-born girl from Washington, D. C."

COMMENT:

We were informed previously of intention of Senate Internal Security Subcommittee to subpoena a number of U. S. citizens who have been employed by Tass. The American-born girl from Washington, D. C., apparently is [redacted]

[redacted] when Tass dispensed with services of American employees. Following her release, we considered interviewing [redacted] but decided not to do so. At that time we knew Senate Subcommittee was interested in interviewing her. On 2/6/56, we received information to the effect [redacted] has been subpoenaed.

WINCHELL SAID:

"New York Daily Mirror: Harvey Matusow - he worked both sides of the fence - goes to trial in Federal Court, New York, on the 20th."

COMMENT:

Matusow's trial on perjury indictment in Southern District of New York is scheduled for 2/20/56, but the U.S. Attorney expects it will actually go to trial within one or two weeks after that date.

"New York City: A political scandal, ladies and gentlemen, that received puny attention in the New York papers was the Paul Hughes case. Hughes was acquitted of perjury. The New York World Telegram-Sun was one of the very few newspapers to feature the verdict on the editorial page as well as its opinion. The following slap in the face is from that exciting editorial: "Regardless of the verdict, the Hughes case uncovered for the public a shabby plot to smear Senator Joseph McCarthy. Whether one likes Senator McCarthy or not, the effort to use bogus, derogatory information against him merits only contempt. Another sequel to the Hughes trial must be the flushed faces in the ADA" (that's the Americans for Democratic Action) which, says the World Telegram-Sun editorial, "has made so much righteous to-do about the use of paid informers."

COMMENT:

For your information. Hughes was acquitted on 2/3/56 of perjury. He had been charged with lying to a grand jury investigating Harvey Matusow.

"Broadway: And the fact that America's best known blonde moving picture star is now the darling of the left-wing intelligentsia, several of whom are listed as red frontiers. I do not think she realizes it."

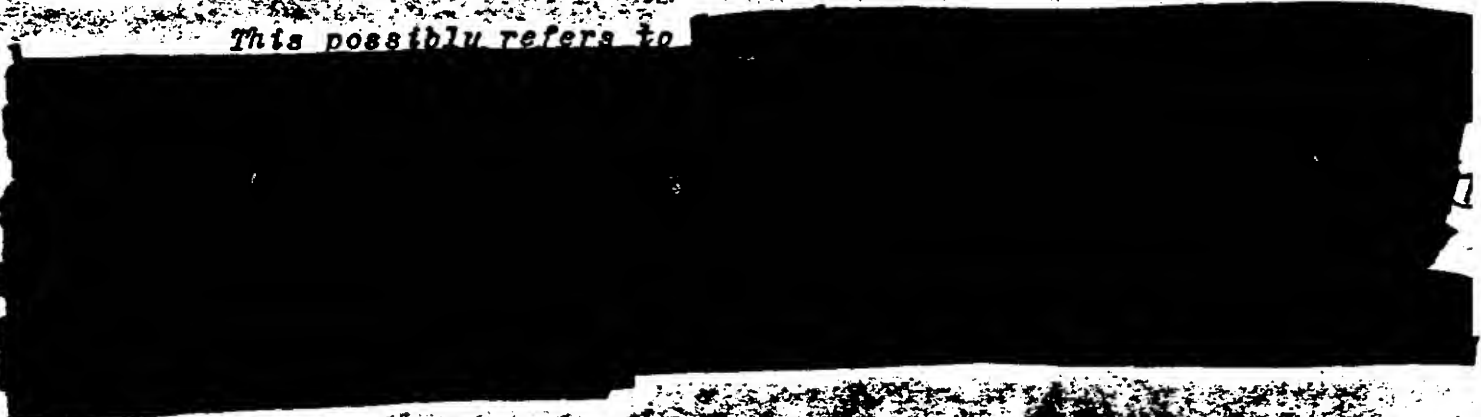

WINCHELL SAID:

"Albany. Two leading New York State officials are quietly being investigated regarding a big banking deal."

COMMENT:

Substantive supervisor on the Federal Reserve Act desk advised that the Bureau has not received any information identifying such State officials or that any violation within Bureau jurisdiction is involved.

WINCHELL SAID:

"Washington. The Senate hearings this week will feature more Red skulduggery. Secret papers found in a foot locker exposing recent Red-Chinese propaganda."

COMMENT:

This apparently refers to William Howard Hinton (105-24018). Recent publicity in local newspapers in Albany and Boston indicate Hinton is to testify this week before Senate Internal Security Subcommittee. Publicity indicates his testimony will pertain to documents found in a foot locker seized by Bureau of Customs in 1953 when Hinton entered U. S. through Canada. The documents were made available to the Senate Subcommittee and Bureau.

Since his return to the U. S. he has made speeches and is currently preparing a book entitled "Iron Oxen" in which he has indicated pro-Chinese Communist attitude. Hinton previously testified before this same Subcommittee in 1954.

WINCHELL SAID:

"Rome. President Gronchi of Italy has changed his leftist learnings amazingly while visiting the U. S. Rome is skeptical. So is Washington. Very."

WINCHELL SAID:

"New York City Thurgood Marshall, the general counsel for the NAACP (National Association for the Advancement of Colored People), will not be in the Alabama fight for (Aatherine) Lucy this week. He was stricken with a virus."

COMMENT:

Aatherine Lucy is the colored girl who enrolled in the University of Alabama, which subsequently caused riots on the campus. She was later expelled because of allegedly false charges made by her in Federal Court against University of Alabama officials. No investigation has been conducted by the Bureau in this matter. However, local developments have been followed.

WINCHELL SAID:

"The North Pole. Russia knows more about our forces in the Arctic than you do. The Moscow radio calls our personnel in that area by name and rank every day. They tauntingly tell them exactly what they have been doing."

COMMENT:

For your information.

WINCHELL SAID:

"A member of a very prominent family in Venezuela claims New York agents for that country's dictator have threatened his life. He is in exile living in Manhattan. He has appealed to the FBI for protection."

COMMENT:

This probably refers to Mariano Araya, prominent member of Venezuelan opposition party, Union Republicana Democratica, who is presently residing in New York City.

WINCHELL SAID:

"John G. Broady, sentenced to Sing Sing Prison for wiretapping a few weeks ago, was suddenly released last night on a writ of reasonable doubt."

COMMENT:

The Bureau conducted a preliminary investigation concerning the New York wiretapping setup in February, 1955, and Broady was a subject. A copy of our preliminary report was furnished to the Criminal Division. The Criminal Division advised that the Bureau should conduct no further investigation since Frank Hogan, District Attorney, New York, was prosecuting Broady under the New York State wiretapping laws. Broady was sentenced to a term of from two to four years on 1/13/56 in New York State Court and the Criminal Division was so advised. Pursuant to Bureau instructions, New York is verifying this information today. The Bureau is to be promptly advised by New York and we will advise the Criminal Division.


WINCHELL SAID:

"Agents for the Treasury are making a full-scale investigation to learn the names of U. S. Customs guards who allegedly attended closed Communist Party meetings in Greenwich Village."

COMMENT:

The "New York Daily News" for 2/23/56 reflected that John J. Huber would testify on 2/27/56 before the Citizens Waterfront Committee in New York City regarding Communist infiltration on the water front. One item mentioned in his proposed testimony was that he had seen Customs guards in uniform at parties given by the Communist Party. Based on this publicity the Treasury Department is checking their files for any information relating to this situation.

WINCHELL SAID:

"Miami, Florida. Honduras is now the headquarters for all Red Agents in Latin-America. The next move will be an attempt to take over that country--after they assassinate former President Carias and President Lozano."

COMMENT:

The Bureau has received no information along this line although Honduras, in recent years, has been one of the leading sanctuaries for Central American exiles. It has also become customary for rival revolutionary leaders to brand each other as Communists and this may have some significance in Winchell's statement.

WINCHELL SAID:

"Hong Kong. A terrific backstage fight is raging in the top Red Chinese command over Moscow's orders to vilify Stalin. General Mao's support Russia. The powerful Red leader, Liu Shao-chi is in open mutiny."

"Washington. The top Capitol rumor tonight--that Abba Eban, the Israeli Ambassador to the U. S., may be recalled."

Autherine Ala.
"Washington. The Communist radio and press are having a field day with the Lucy case. The Reds, however, neglect to report the following facts. No race in the history of man has made greater progress in the last 100 years than the American Negro. The Communist Reds forget to mention that American Negroes distinguish every profession in our country from the Armed Services to medicine and that the free enterprises run by Negroes are the highest in the world at Atlanta, Georgia. The Moscow radio fails to report that in 1901 we had 103 lynchings. But according to the Department of Justice, there have been no lynchings in the last four years. The truth is, ladies and gentlemen, a secret Government report reveals that a very great number of institutions have quietly put into effect the order of the U. S. Supreme Court."

COMMENT:

The lynching figures for 1901 are not entirely correct. Our files and the World Almanac for 1956 reflect 130 lynchings for 1901--25 whites and 105 Negroes. Our files also reflect no lynchings in the last four years.

WINCHELL SAID:

"Washington. Six additional American employees for Tass, the Russian news agency, have been subpoenaed by the Senate Internal Security Committee."

COMMENT:

Mr. L. B. Nichols advised that we are aware that Mr. Robert Morris, Counsel, Senate Internal Security Subcommittee, is continuing his investigations of Tass News Agency. We are reviewing testimony of each and taking appropriate action where necessary.

All of these individuals are considered progressives but are not Communist Party members. The latter two are given little chance for election by the Party.

Newark, New Jersey, and New York City Police Departments have joined forces to locate the would-be-murderer of Saperstein. ("New York Daily News," 3/11/56)

The Bureau in 1954 and 1955 conducted investigation involving the welfare fund of the Wholesale Licensed Alcoholic Beverage Salesmen's Union, Local 20376, aka, Local 2, to determine whether this fund had been legally established under the Labor Management Relations Act (Taft-Hartley Act). Based on the Bureau investigation, the Criminal Division of the Department decided that the fund was legally established and no Federal violation was involved even though information was received that the funds had been misapplied through a conspiracy between the union officials and Louis B. Saperstein, the insurance broker for the fund. Investigation of Saperstein's activities was, therefore, not conducted. (92-942)

"Several newspapers have devoted screaming editorials to the fate of the red newspaper the 'Daily Worker' in New York charged with tax evasion instead of being part of the Russian conspiracy. The breast-beaters picture the padlocking of the propaganda papers as a big threat to the American free press. Well - it is ridiculous to argue that freedom of the press means freedom from taxation. It is equally illogical to contend that the closing of a communist newspaper endangers our free press. You might as well say that our liberty would be imperiled if Pravda in Moscow stopped publication. The truth, ladies and gentlemen, is that the various 'Daily Workers' over here were never really any part of our free press. They have always been a branch of the Kremlin's propaganda machine. The one in New York especially was never really an American newspaper. It has always been a Russian Government voice. The "Daily Worker" was founded in 1924 at the direction of Gregori Zinovia (phonetic). At that time this red leader was also the chief of the Communist Internationale. Moreover, the New York "Daily Worker" was established with the help of Moscow, Russia, which sent over the first \$35,000. The contention by the alarmed editorial writers over here that the survival of our freedom is somehow linked with the survival of communist newspapers is just plain foolish - to put it without profanity. Communism, as they must know, is not merely a political idea. It is a criminal conspiracy in the form of military strategy. For their supporters to complain that the Government's action for taxes is wrong, this is to remind them that American newspapers are the freest in the world and also the most highly taxed. Our newspapers, ladies and gentlemen, pay a tax of 52% and some of us on those same newspapers pay 91."

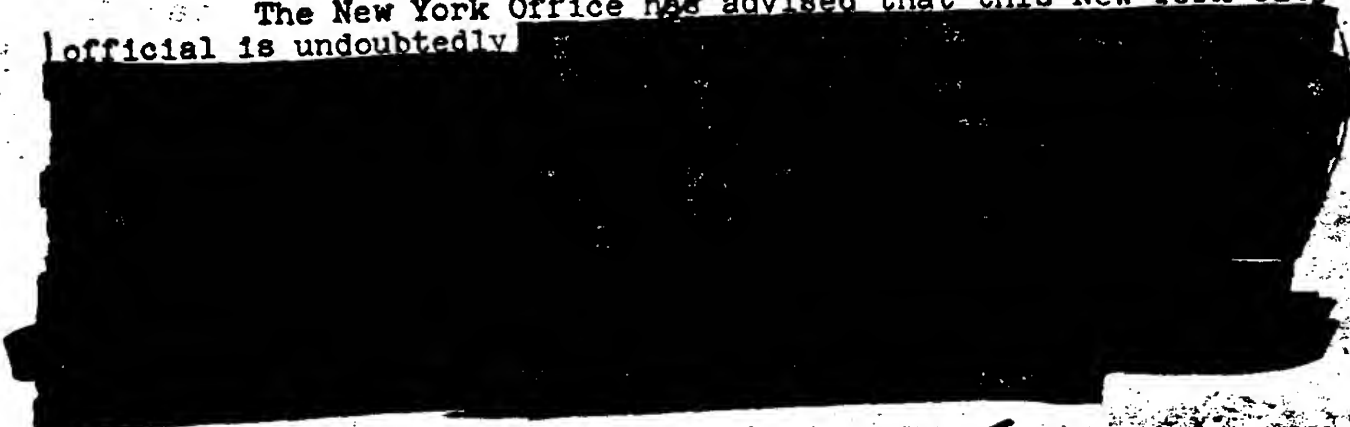



WINCHELL SAID:

"New York City. Governor Harriman visited Victor Riesel today at St. Clare's Hospital. The Governor pledged full cooperation to find his attacker. Victor Riesel's condition is reported very encouraging. The doctors now say his vision will be impaired but he will not be blind. The reward money is about \$40,000.

"The city and the nation were stunned this week when labor writer Victor Riesel of the 'New York Daily Mirror' and my home paper was attacked after one of his broadcasts. Mr. Riesel has been reporting the facts about union racketeers and Reds for a very long time in the 'New York Mirror' and many other newspapers. The vicious attack on him will not stop the crusade of the press for decency any more than a bullet for Abe Lincoln stopped the march for human freedom. Only a degenerate would imagine that acid thrown in a newspaperman's eyes could stop the newspaper ink which tells the devastating truth. The power of the press is only partly in the man who writes the story. The might of the nation, however, is in the many millions of you who read it. The criminals responsible for this cowardly crime only illuminate the truth. If acid thrown near Broadway on 51st Street at three o'clock in the morning could have stopped the American press, it would have been dead long ago, but, since the day Benjamin Franklin started it, every crooked combination has tried without success to break the three invincible links of freedom -- a reporter who will report the truth, the newspaper that will publish it and the public which believes it. The dynamiting of the 'Los Angeles Times' didn't stop those presses. The people of California sent the criminals to jail and Hiram Johnson, the prosecutor, to the U. S. Senate. "Washington Post." Albizu Campos, the fanatic who ordered the attempted assassination in our Congress, is dying in prison in Puerto Rico. He isn't expected to last out the week. He was sentenced to 62 years."

COMMENT:

San Juan advised that on 3/27/56 Pedro Albizu Campos, President of the Nationalist Party of Puerto Rico, suffered an attack later diagnosed as a cerebral thrombosis. Albizu was removed from the penitentiary to the Presbyterian Hospital, Santurce, Puerto Rico, where he is now confined. San Juan advised 4/7/56 that Albizu ceased hiccuping, which was sapping his strength, and his condition appeared to be improved.

advised the San Juan Office on April 8, 1956, that Albizu's physical condition was steadily improving. Albizu's pardon was revoked in September, 1953, by the Governor of Puerto Rico and he is now serving 31 years minimum sentence..

WINCHELL SAID:

"The Ford Foundation's Fund for the Republic is in a tax jam. Pressure is mounting in Congress to revoke their tax exemption. If it is revoked, the organization's \$15,000,000 grant would revert to the Ford Foundation."

Memorandum for Mr. Boardman

COMMENT:

The Fund for the Republic is currently being investigated by the Internal Revenue Service to determine whether it can continue to maintain its tax exempt status or whether this status can be removed if it is ascertained the Fund is engaged in political or propaganda activities. Fulton Lewis, Jr., in a broadcast 3/15/56 said several influential Senators are preparing speeches to be delivered on the floor of the Senate asking Internal Revenue Service to take away the tax exempt status of the Fund for the Republic. The New York Office is following this matter with the Internal Revenue Service.

WINCHELL SAID:

"The American communists have returned to their old security measures of not keeping membership lists. They hope to avoid future tax troubles by having members give the money to fronts which would lend the Communist Party the money."

COMMENT:



This information was furnished to the Attorney General on 4/4/56 and is the subject of Bureau letter 4/3/56 to New York with copies to all offices.

WINCHELL SAID:

"Washington. The Senate Internal Security Committee has subpoenaed another New York City newspaperman for possible communist connections. He's on my paper, the 'New York Daily Mirror.'"
