WINCHELL SAID:

He was invited last night to a reception for Adlai Stevenson at the Biltmore Hotel but did not get to meet Mr. Stevenson. He suspected it was because he had made the statement to Carmine DeSapao, Secretary of New York State, and Campaign Manager Finnegan, when he learned that Mr. Eisenhower had turned over the intelligence reports to Mr. Stevenson, "It made me sick to my stomach." "I only hope Mr. Stevenson will never show any of those Secret U.S. intelligence reports to the former communist who will not get off his team."

COMMENT:

A check with the NYO, logical Bureau supervisors and officials has failed to establish the identity of this individual.

WINCHELL SAID:

Attention: Mr. John Edgar Hoover -- An American woman, named by Congressional committees, as an active member of Red spy rings in New York, purchased recently an \$80,000 home off lower Fifth Avenue, New York City, right on Eleventh Street.

COMMENT:

A check with NYO and logical Bureau supervisors has failed to definitely establish the identity of this woman. However, she has resided in New York City since approximately 1948.

Bob Hurleigh, Washington representative of the Mutual Broadcasting Company, who is very friendly, called me on the afternoon of September 18, 1956, to advise that in connection with the Freedom Fair which is being run by the Treasury Department Walter Winchell is being given a freedom award by the Treasury Department. Hurleigh stated that Winchell wants someone he knows to make the presentation to him and is very anxious to have the Director do it. Hurleigh stated that, if the Director would do it, Mutual would broadcast the entire proceedings at either 7:15 p. m. or 7:45 p. m. on October 18.

The Freedom Fair is being set up in the new parking area of the Hecht Company in Arlington, and the presentation would be made at the site of the Freedom Fair.

I told Bob that I would check on this and let him know. In line with our discussion, I will tell Bob that Winchell had previously discussed this with the Director and the Director felt that, since this is a Treasury function, Secretary Humphrey would be the proper person to make the award.

WINCHELL SAID:

A leading figure in the Johnny Dio case, one of the suspects in the blinding of newspaperman Victor Reisel, is talking; they can't shut him up; this is the first rap (rat) in gang chief Johnny Dio's sinking ship.

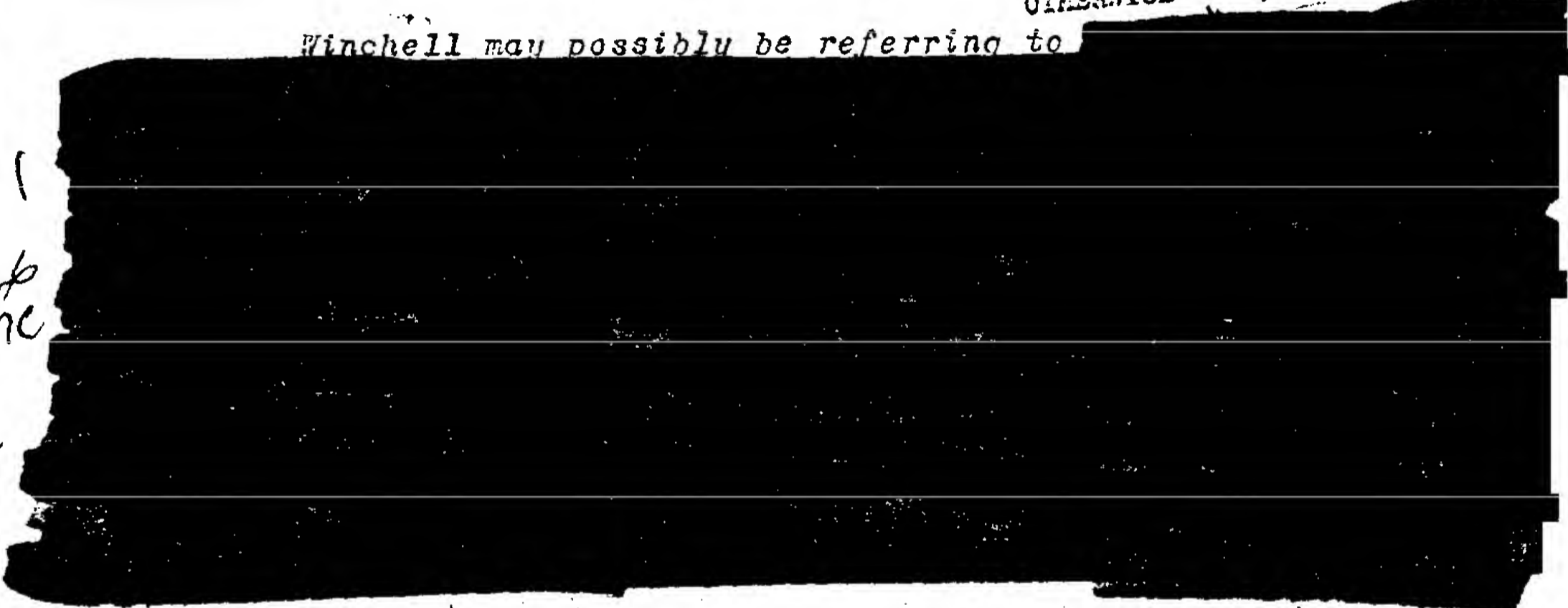

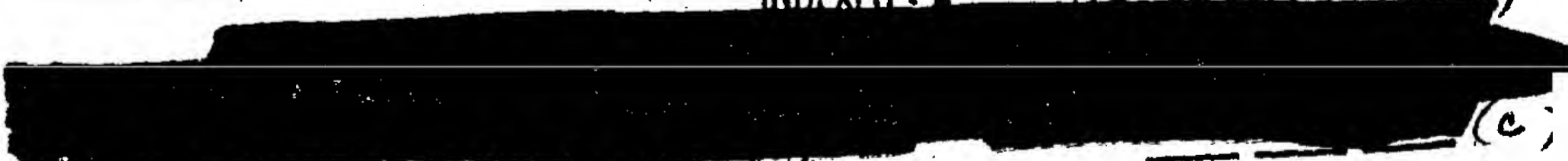

For my skin forces me to use a pick and a shovel eight hours a day to earn a check of any size without the indignity of a broom or the constant exhibition of humility. I can fight with a knife or against. I have and probably shall again soon. My beloved bigots taught me this. You taught me something else that left me today when the civil rights plank folded. PATIENCE. My patience is gone. Patience groomed from childhood with kicks in the pants for "being black" or objecting to having your head rubbed for luck or losing friends because of social pressures and waiting in lines and being ignored and sneered at and all the love affairs that might have been, and losing jobs and being refused apartments, and paying more for less. I am finished with quiet and dignified rebuttals and counting to ten.

WALK CAREFULLY - A Lion Roams Your Streets - Don't brush my sleeve without a smile or a gesture to show that you are sorry. Don't take my place in line or serve me sloppily with a sneer or ogle my girl with a supercilious smile or ignore me at a crowded counter.

WALK CAREFULLY - There is death at your elbow and you put it there. There is at least one lion in the streets, perhaps more. This is not my problem but yours.

WINCHELL SAID:

"Inside the Communist Party in the U.S.A. Ladies and Gentlemen. Last week the Reds at New Haven, Connecticut, moved one of their front headquarters from 23 Temple Street to 6 Church Street, New Haven, Connecticut."

COMMENT:

The premises at 23 Temple Street, New Haven, Connecticut, have been occupied by the Connecticut Volunteers for Civil Rights. This organization was formed by Communist Party members in Connecticut for the purpose of raising funds for the trial of the Connecticut Communist Party leader indicted on 6-4-54 for conspiracy to violate the Smith Act of 1940. A confidential source has advised that a meeting of either a state board or a state committee meeting of the Communist Party of Connecticut [redacted] adopted a proposal to dissolve the Connecticut Volunteers for Civil Rights. On 10-4-56 [redacted] at 23 Temple Street advised that office equipment and other material of the Connecticut Volunteers for Civil Rights was to be removed on 10-6-56. New Haven has also advised that Ettie Ekins, executive secretary of this organization, has moved to Hartford, Connecticut, with her husband, Robert C. Ekins, state secretary of the Communist Party in Connecticut.

COMMENT:

The California Emergency Defense Committee has been cited by the Attorney General pursuant to provisions of Executive Order 10450. A confidential investigative technique of the San Francisco Office has advised that this committee is being discontinued and a new organization called the "Joint Self-Defense Committee" is being formed in its place. It has not yet been determined whether this information pertains only to the San Francisco chapter of the organization or whether it pertains to the organization as a whole operating in the State of California.

WINCHELL SAID:

"In the new shift of west coast Red Party leaders, the Oregon state chairman of the Communist Party has been switched from Portland to Los Angeles. Tee Hee."

COMMENT:

WINCHELL SAID:

"The 'Daily Worker's' Red master minds hoping to erase the stink attached to that name are now trying desperately to think of a new title for that scummy rag. How does that awful American Winchell know our deepest secrets?"

COMMENT:

Information has been received from informants regarding discussions by Communist Party leaders and rank-and-file members in regard to the 'Daily Worker's' decreased circulation. Consideration has been given to a possible name change in hopes of increasing circulation and particularly if the Communist Party should change its name. These discussions have also included changes in the style as well as in the scope of coverage of news in the paper.

WINCHELL SAID:

"Red chiefs from all over the deep South land - all over the South - attended a very secret - a very what - high-level Communist Party conference last weekend right here in my wonderful home town, New York City."

COMMENT:

A confidential informant attended a meeting of the Southern Regional Committee of the Communist Party, USA, starting 10-6-56 in New York City. The agenda consisted of a report on the draft resolution of the Communist Party, the outlook for Southern Communist Party work, and plans for state conventions and conferences. A future meeting of the committee is scheduled for about February, 1957.

"And now to knock all communists on their big fat ankles. A secret meeting of the national committee of the Communist Party has been called for November 11, November 12, in New York City."

"Chicago. Intimates of Adlai Stevenson are urging him to announce that if elected he will make an immediate trip to Moscow. Why Mr. Stevenson?"

WINCHELL SAID:

"Mr. and Mrs. United States.

"The following is privileged fair comment for a newspaperman. For over 20 years I was on FDR's team. You know one of those awful new dealers. Candidate Adlai Stevenson has accused the Eisenhower Administration of being 'soft on communism.' But when Mr. Stevenson was the confidential secretary to Secretary of the Navy Frank Knox, my old boss, Mr. Stevenson was a lot softer, I think. Listen to this. My source is from a report of a senate hearing investigating United States security laws. That hearing started January 8, 1954--that's a little over two years ago. The following, in part, is the testimony before that U. S. Senate probe by Rear Admiral Adolphus Staton. He is the holder of the Navy Cross and the Congressional Medal of Honor. Admiral Staton testified under oath that in 1942 Mr. Stevenson, as the Assistant to the Secretary of the Navy, said among other startling things: 'I don't think we ought to be too hard on the commies.' Mr. Stevenson said that! Ladies and gentlemen, when Admiral Staton, chairman of a committee to kick subversive radio operators off American ships quoting the sworn testimony of war heroes: Admiral Staton, 'Mr. Stevenson summoned me to his office. He said 'Admiral, I don't think you fellows have anything against those people--any of them.' The Admiral also testified that he had about ten radio operators fired for being disloyal to our country. The Admiral said his committee voted unanimously to discharge them; that he had told Mr. Stevenson 'This is emergency legislation. These people are unfit to work in our convoys with naval ships carrying valuable cargoes for the war; that if there was any reasonable doubt, that reasonable doubt should be in favor of Uncle Sam.' To which the Assistant to the Secretary of the Navy Stevenson replied 'Well, Admiral, I don't think we ought to be too hard on the commies.' Oh, my God. I submit all of this to President Eisenhower and his official family for rebuttal to the Democrats' claim that the Republicans are 'soft on reds.' Please remember Mr. Stevenson, who now comforts the enemy with demands for no draft, stopping all nuclear tests, et cetera, made these statements during war time, after Admiral Staton's committee unanimously order that those communists be fired."

"Harlem, New York City. Here is the absolute low-down on why Congressman Adam Clayton Powell, Democrat, came out for President Eisenhower. Mr. Powell knows that the President made over 300 Federal appointments to members of his race. Mr. Truman appointed about 25 in seven years."

"Washington. Congressman Powell's other reason - in 1951 - that was Truman's administration - Mr. and Mrs. Adam Clayton Powell, colored, were requested to leave Washington's hotel, the Congressional Hotel. The Congressman asked President Truman to correct that problem. I understand that Mr. Truman didn't even bother to reply. When Congressman Powell asked Ike to correct it, it was corrected not long after. That's the kind of a guy he is."

"Income Tax Cemetery. Johnny Dio, top suspect in the acid throwing case which blinded newspaperman, racketeer fighter, Victor Reisel, has a brand new headache. Goodbye, Johnny Dio." *N.Y.*

COMMENT:

The Bureau has received no information as to any action contemplated against Dio for violation of income tax laws. On the night Dio was arrested a search conducted incidental to his arrest uncovered considerable information regarding personal income received by him as a result of his activities as a labor consultant. It is possible that the United States Attorney at New York may be using some of this material to move against Dio.

WINCHELL SAID:

"The FBI is going after trouble-maker John Kasper. He reportedly started the race riots in Tennessee. He allegedly lived with a Negress here in New York." *DC.*

Several sources interviewed claimed that Kasper also lived with this girl.

[REDACTED] Kasper's participation in racial disturbances at Clinton, Tennessee, during August of this year received considerable newspaper publicity. As a result of these activities, Kasper was sentenced to a year in jail. Several sources at Clinton have stated that if it had not been for Kasper, there would have been no trouble at Clinton.

WINCHELL SAID:

"The new ~~red~~ line calls for a united socialist front. It will start in Los Angeles on Columbus Day."

COMMENT:

A ~~symposium~~ was held in Chicago, Illinois, on 10-5-56 attended by representatives of several left of center organizations. The purpose of the symposium was to consider formation of a new broad socialist organization which would present a united socialist front. Bert Cochran, Claude Lightfoot, and Reverend A. J. were scheduled to represent the socialists, communists, and *Calif*
Fellowship of Reconciliation, respectively, at this symposium. No information has been received concerning any activity along this line slated for Los Angeles.

The ~~New York State Committee of the American Labor Party~~ which lost its ballot status when it polled only 46,000 votes in 1954, announced its dissolution on 10-7-56. The party reached its peak in 1948 when it cast 509,000 votes for Henry A. Wallace for president. Peter K. Hawley, party chairman, blamed the "repressive atmosphere" of the cold war and the consequent loss of labor support for the party's decline in recent years.

WINCHELL SAID:

"St. Claire's Hospital, New York City. Lenny Morgan, ^{N.Y.} 46, of the New York Journal-American, severely beaten by four teenage punks over a week ago, is still in the hospital. New York City. The communists have stepped into that story. They are passing out handbills praising the four thugs for beating up newspapermen. I sent them to the FBI, John Edgar Hoover. Who is the "Committee Against Crime in the News." Are they communists or aren't they?"

No record has been located of the communist handbills mentioned by Mr. Winchell having been received as yet at the Bureau. This case has been followed through newspaper articles and no active investigation has been conducted.

WINCHELL SAID:

"Federal Pen, Manhattan. Frank Costello, who won his fight against deportation, will be taken to Atlanta Federal Prison this week. Five years for income tax trouble. One confessed red, convicted last week for trying to steal, kidnap, and murder our nation, got only one year." ^{N.Y. - Gu.}

COMMENT:

This may be a reference to Alexander Trachtenberg who was convicted 7-31-56 in the Southern District of New York for conspiring to violate the Smith Act of 1940. Trachtenberg was sentenced on 9-17-56 to one year.

WINCHELL SAID:

"Mr. and Mrs. United States. Murder makes headlines. That's because it is news. The reason it is news is that most people do not commit murder. The same thing is true of juvenile delinquency. The reason J.D. is news is that the overwhelming majority of American youth are leading busy, healthy lives preparing to be useful citizens. Did you know that at least 20 million American youngsters are taking music lessons. You read about some young criminal shot in the dark but nobody ever mentions the thousands of school orchestras rehearsing all day. You read about juvenile delinquents who steal cars and mug citizens but why doesn't anyone play up the million members of the

4-H Club, the ones who get up at dawn to help run American farms. You read about teen-age gang raids on other gangs of candidates for the electric chair. For every one of these bums America has a thousand boy scout troops learning the way the pioneers used to build our wonderful country. The fact is, 2 out of every 3 youngsters in the nation go to Sunday School. But that story is not news to most editors. The bad news is that many judges do not know where to send these young offenders. But the good news is that for every bad boy or girl we have 10 good kids working their way through colleges. God bless them all. The irony of it. The juvenile gangsters call themselves armies. Since 1776 America's best citizens make up our best armies. Over 70 percent of our Armed Forces are manned by juveniles under 21. A newspaperman cannot help but be bitter when he knows that for every hoodlum who gets into trouble we have at least 10,000 honest newsboys such as Andy Williams of Ames, Iowa, who met the President yesterday and I introduced him all over town. I met him on the Perry Como show last night. Helping their families, selling the same newspapers which play up the punks. One lady judge in the Midwest was appalled by my comments last week. WINCHELL SAID:

"Inside the Communist Party. Red leaders are secretly celebrating what they say will be favorable decisions by the highest court in communist cases now pending. The scummy 'Daily Worker' is running articles of the 'interest displayed' by some of the justices in the highest court in the land."

COMMENT:

The Supreme Court has recently heard arguments on four cases involving convictions of communists under the Smith Act of 1940. Two of these cases were conspiracy cases involving Steve Nelson and four other communist officials from Pittsburgh and the case involving William Schneiderman and 13 other communist officials from Los Angeles. Arguments were also heard on two membership cases involving Junius Scales from Charlotte, North Carolina, and Claude Lightfoot from Chicago, Illinois. In the Nelson case the Government had requested the court to return the case to district court at Pittsburgh for a judicial hearing as to the credibility of Government witness [redacted]. The Government had stated it had reason to believe [redacted] may have lied in testimony subsequent to his Pittsburgh testimony. The Supreme Court has returned the entire case to the lower court for retrial.

Information has been received in the Claude Lightfoot case that [redacted] told Eugene Dennis that he feels Lightfoot will get a reversal because the trial judge refused to turn over to the defense a written report of [redacted] who testified against Lightfoot.

No information has been received as to any possible decisions in the cases involving Scales and Schneiderman.

On this date, during the course of another investigation, [redacted] voluntarily furnished the following information concerning WALTER WINCHELL:

[redacted] asserted that WINCHELL, during the last few weeks, has been attempting to gain publicity in the Times Square area. [redacted] opinion that WINCHELL wants this publicity for his TV program.

[redacted] stated that on two occasions, one as recent as 10/25 last, WINCHELL pulled a gun, for which he, WINCHELL, has a permit, on teenage youngsters in the Times Square area. [redacted] continued that on 10/25 last, three teenage youngsters noted WINCHELL sitting in his Cadillac on Broadway. They went over to talk to WINCHELL, and evidently WINCHELL became annoyed and got out of his car and pulled his gun on these individuals. [redacted] stated that WINCHELL lined the youngsters up against a wall and brought them to the 16th Precinct where he, WINCHELL, wanted these individuals arrested but could offer no charge.

[redacted] asserted that WINCHELL is a very lucky man because if one of the youngsters wanted to make a complaint, WINCHELL could have conceivably ended up in jail.

Walter Winchell called from MATS Airport and stated he was about to board the Presidential Press Plane for Miami, Jacksonville and Richmond. He requested that the following very urgent matter be brought to the attention of Mr. Tolson or Mr. Hoover. By way of background he stated three newspaper photographers were previously sent to the hospital in NYC after a vicious attack by 4 teen-agers, juvenile delinquents. He indicated Friday they were held for grand jury. The bail previously set at \$25,000 each for felonious assault and grand larceny was mysteriously, sneakily and quietly reduced to \$1,000 each. The article indicated that the grand jury would hear the matter (no date given) on charges of felonious assault and grand larceny in the theft of a camera. The defendants are: Richard Nelson, age 19, 450 W. 47th Street; Joseph [unclear], age 19, 456 W. 47th Street; Robert Cartino, age 17, 516 W. 50th Street; and Thomas O'Hare, age 17, 452 W. 49th Street, all New York City. The three newspaper representatives were identified as Philip Grettner, age 43, photographer "Daily News"; Ralph Gonzalez, age 21, copy boy "Daily News" and Leonard Morgan, age 46, photographer "Journal American." The latter individual was severely kicked by Nelson while on the ground.

He also sustained additional injuries, to a heart artery. ^{CONDITION} Winchell requested that any information available concerning the above be given to him at any of the 3 airports where he will visit today, namely Miami, Fla., 11:30 A.M.; Jacksonville, Fla., at a later undetermined time; Richmond, Va., some time this evening. He requested that the above be brought to the Director's or Mr. Tolson's attention due to its urgency. Mr. Winchell then wanted to know if the Director heard him call Drew Pearson an SOB over 600 stations last night. He then said, "I didn't say it." He also requested that the Director check his column, page 10, "New York Mirror" wherein the editors would not allow him to call Drew Pearson a "presstitute." He indicated he apologized to the President and Mrs. Eisenhower for a defense of the President and stated this "SOB" tried to kill the President by worrying him." He stated although Drew Pearson is 6'4" and he, Winchell, is only 5'9", he will "throw one at him." He further indicated that District Attorney Hogan, NYC, is very miffed with him and stated the reason would be found in the afore-mentioned Walter Winchell column on page 10 of the New York Mirror. He was advised that the above information would be immediately brought to the attention of the Director or Mr. Tolson.

ACTION:

Bufiles are being checked concerning the four defendants above mentioned. Mr. Holloman's office was called and, in his absence, the above was given to Erma D. Metcalf. Mr. Wick, Records and Communications Division, was also advised. A check is also being made to locate the newspaper articles mentioned herein; namely, the "New York Daily News" item of 10-26-56, page 5, column 1, and the "New York Mirror," Walter Winchell column, page 10 (date not determined)

ADDENDUM:

A check of Bufiles reflects serial 62-26225-35-A is identical with 4 defendants mentioned above. This serial is newspaper clipping from "New York Herald-Tribune" September 26, 1956, page 2, column 1, which sets forth account of assault. No other references in Bufiles. It is noted newspaper article 9-25-56 carries the spelling Robert Cartaino for subject's name [REDACTED]

"I can state with authority, ladies and gentlemen, that Washington received absolute sworn pledges that France and England would not attack Egypt. It was the biggest double-cross of the last one hundred years."

"The administration is furious with French Premier Mollet for stating that he had informed the White House of the French plan to attack. That is at variance with the facts. That's the diplomatic way, my way, of calling Premier Mollet of Paris, France, a liar."

"Candidate Javits in New York telegraphed the following to all GOP county chairmen: 'On Wednesday, the opposition candidate told New York garment workers that we should support Israel, but he wired the President of the United States to avoid involving our forces in the Israel crises.'"

Jacob K. Javits is Attorney General of New York State and candidate for position of U. S. Senator from New York State. Javits voluntarily appeared before the Senate Internal Security Subcommittee on September 5, 1956, to deny rumors that he had been supported by communists and was an associate of communists. No further hearings have been scheduled.

Winchell Said:

"From the Walter Winchell newscast over this network October 14th. In spite of official denials London and Washington are at their bitterest point since Munich. Washington has bluntly told the British that we are at Suez where London was on Korea and Red China."

"Administration leaders now know that a certain commentator's recent low-blow about Eisenhower's alleged relapse in Minneapolis was written, inspired by a top left-winger of the Americans for Democratic Action."

Comments:

This apparently refers to a recent item by Drew Pearson regarding President Eisenhower's health. The Bureau is not conducting any investigation regarding the Americans for Democratic Action.

Winchell Said:

"Mr. and Mrs. United States. Last Monday I was with the Washington Press Corps and the Secret Service in the plane which preceded the President on his one-day 1,800 mile speaking tour of Florida and at Richmond. I saw a very happy President making his speech at the Miami Airport; an hour later at Jacksonville, I also saw our President get that very miserable news just before he talked to the big crowd of patient Americans who waited so long in the rain and chill at Richmond Airport. I saw the President's bottom lip quiver, stifling his tears, his great disappointment at seeing his hopes for peace shattered because some of our best false friends abroad committed a crime in the name of defending law and order. For over two months, ladies and gentlemen, I have given you the details of the massing of British and French forces in the Eastern Mediterranean, including fleet and army movements. I also reported that London and Paris would use force. The uninformed called it more Winchell warmongering. Now, legalistic nonsense is befogging the issues. It is not a question of aggression. It is all a showdown in what they call power politics. Israel and Egypt are mere pawns. For a long time the borders of Israel have been subjected to murderous raids. The brave people of Israel are no more wrong in protecting their families and themselves than the United States Government was when it ordered General Pershing into Mexico to stop the bandit Villa from attacking border towns of New Mexico. The real issue, ladies and gentlemen, is oil. Russia, through Egypt, has choked the windpipes of France and Britain. They slugged back through Israel. The conflict as of now is local, but Egypt, listen to this, Egypt has called for a "jihad" or Arab holy war from Casablanca to Kurachi, India. President Eisenhower took the first calm and courageous step in one of his very great pledges of your lifetime that there will be, he said, no involvement of United States in the current hostilities. And the bitter irony of what our so-called friends abroad have done -- they know full well that without General Eisenhower's leadership and your taxes, Britain and France might have been wiped off the map. And that no matter who wins this war, you, the taxpayer, will feed and clothe them again."
