WINCHELL SAID:

"Washington - The Senate's probe of the Teamsters Union will disclose that many records are missing. The most wanted records - payments to party girls for prounion politicians."

COMMENT:

The facts that Teamsters Union records covering the Pacific northwest area have previously been subpoenaed by the Senate Select Committee on Improper Activities in the Labor and Management Field and that the Teamsters Union has claimed that such records are missing, have appeared previously in the public press. On 2/23/57 Senate investigators publicly announced that testimony from prostitutes and others would be used to show whether some west coast officials of the Teamsters Union had ties with the underworld.

WINCHELL SAID:

"Washington - The President is being supported three-to-one on the Middle East according to the mail to Congress. The support is more than four-to-one according to the White House mail. Congressional leaders expect Mr. Dulles will retire at the first letup in the Middle East tension."

WINCHELL SAID:

"At a reception at Moscow recently for Khrushchev, he dropped the following tip to American communists: 'God grant,' he said, 'that every communist should be able to fight like Stalin.' That is why American Red leaders voted to return to the Stalin Party line at their recent convention in New York City."

COMMENT:

Despite the fact that the communist and legitimate press reported that at its recent national convention the Communist Party, USA, ostensibly proclaimed its independence from Moscow, the above reported comment of Khrushchev as well as recent editorial comments in Pravda approving the results of the Communist Party, USA, national convention, clearly indicate that the Communist Party, USA, is still subservient to the dictates of Moscow.

WINCHELL SAID:

D.C.

"Israeli underground hero Menachem Beigin will arrive here on the 28th. He will meet with Senator Knowland and other Congressional leaders on March 4th and 5th. The press will be barred. All of the talks will be off the record."

COMMENT:

We have received information re Beigin's impending arrival in the United States. He is the leader of the extreme right-wing political party in Israel, the Tenuat Hacherut, which is the successor to the Irgun, the Israeli underground group. ~~X~~ Appropriate sources have been alerted to Beigin's arrival, and if he undertakes any activity indicating that active investigation is necessary, we will undertake it. (u)

WINCHELL SAID:

"Washington - The Department of Justice will accuse a top labor official of wiring a Federal Grand Jury room."

We have received no such information. However, the United States Attorney, Southern District of New York, is currently presenting evidence to a Federal Grand Jury re a possible violation of the so-called Federal Wire Tapping Statute by James R. Hoffa, 9th Vice President of the International Teamsters Union and subject of Bufile 139-267, and [REDACTED] professional New York wire tapper. In connection with this hearing, information has been developed to the effect that in 1953 at Hoffa's request, [REDACTED] furnished Hoffa's subordinates with miniature recording devices which they wore in connection with their appearance before a local grand jury investigating labor racketeering in Detroit, Michigan. This may be what Winchell had reference to.

WINCHELL SAID:

"A Reporters Report to the People - Washington - Arthur Miller a prize-winning playwright and the husband of a well-known movie star was indicted this week for refusing to tell Congress the names of persons he met at communist meetings. Mr. Miller's pro-Red leanings are stale news to you listeners. I was the first to make them public. The law may not be clear but the ethics are. The highest court in the land has ruled that a man may have many loyalties but one of them must be the highest of all - loyalty to this nation. Naming the Red comrades is not being a tattletale. It is identifying a rattlesnake which intends to destroy us all. In this fight there is only one man in the United States who has the right to be anonymous, the unknown soldier."

COMMENT:

Arthur Asher Miller [REDACTED] playwright and husband of movie actress, Marilyn Monroe, was indicted for contempt of congress by a Federal Grand Jury at Washington, D. C., on 2/18/57.

Miller was reportedly a member of the Communist Party in the 1940s and affiliated with numerous communist-dominated organizations during the period from 1946 to 1950. He is not on the Security Index.

WINCHELL SAID:

"Hollywood - The California Senate investigation of private detectives and tipsters for the scandal magazines may jail many of them under the criminal libel code. Several trained lawyers for moving picture stars now suing scandal publications in the East are assisting the State of California. When the case goes to trial the names of persons who sold out their friends, sometimes for a mere \$200, will be made known. One of them is already known by her initials 'C. K.' She is the ex-wife of a television favorite. If her own life story were offered for sale, no scandal magazine could possibly publish it."

WINCHELL SAID:

"Washington - The next star witness for a Congressional Committee will be a prominent member of the Christian Science Monitor, a former undercover leftist. He will testify for the Government."

COMMENT:

We are not aware of the identity of this individual. It is recommended that Mr. Nichols's Office attempt to determine his identity.

WINCHELL SAID:

"Washington - One of the generals in the Hungarian Army is flying to the United States. He will bring the plans of the Reds for satellite nations. He reports on Tuesday, next."

COMMENT:

While we are not aware of the specific identity of this individual, General Bela Kiraly has previously been in the United States as a refugee, has testified before the United Nations and has furnished information to the Department of State. He may be the individual referred to by Winchell.

Kiraly, a professional soldier, fought against the Russians in World War II. After the war he joined the Communist Party, rose to the rank of Major-General and became commander of the general staff college of the Hungarian Army. In 1951 he was imprisoned for opposing political pressures on the military forces and was expelled from the Party. He was released from jail on parole September 5, 1956, just seven weeks before the Revolution. He served as commander of the Budapest forces during the Revolution, and fled Hungary in November, 1956, after the Russians crushed the Revolutionary forces.

WINCHELL SAID:

"Leavenworth - Gus <sup>KANS</sup> Hall, the former national secretary of the Communist Party, will be released from Federal Prison March 30th after a five-year term."

COMMENT:

We are aware of this information.

The original indictment of Hall in 1948 consisted of two counts, (1) conspiracy to violate the Smith Act, and (2) membership in the Communist Party with knowledge that it advocated the use of force and violence. Hall was tried and convicted only on the conspiracy count. A detainer was filed against him at Leavenworth under the membership count of the indictment and it is anticipated that he will be rearrested upon his release March 30 under that count of the indictment. The Department has been advised of Hall's impending release.\*

WINCHELL SAID:

"The Senate has received devastating evidence concerning a tie-up between big labor and a Las Vegas syndicate. It will be the hot potato of the year in Washington."

COMMENT:

We have received no such information. Winchell's statement probably relates to inquiries by the Senate Select Committee on Improper Activities in the Labor or Management Field. This committee will conduct hearings in Washington, D. C., beginning February 25, 1957. Committee Chairman Senator John McClellan has publicly announced that the committee is interested in evidence indicating that hoodlums have infiltrated the trade union field.

WINCHELL SAID:

"The Senate Internal Security Committee has subpoenaed a Communist Party chief to tell the inside story on the recent trouble in Moscow. I think this man may be Eugene <sup>DC</sup> Dennis."

\*On basis of Hall's conviction for conspiracy to violate the Smith Act and for contempt of court he was sentenced to five years on the conspiracy count and three years on the contempt count, terms to run consecutively. He began serving these sentences 10/9/51 and completes service of these sentences, less good time, on 3/30/57.

COMMENT:

The Senate Internal Security Committee will conduct hearings in Washington, D. C., on Wednesday and Thursday, February 20 and 21, 1957. Dennis is scheduled to testify before the committee during these hearings. The purpose of the committee in subpoenaing Dennis, however, is to question him relative to the change in the Party line resulting from the recent national convention of the Communist Party.

WINCHELL SAID:

"Pittsburgh Courier - The one thing that puzzled the Reds at their first convention in ten years was the absence of Paul Robeson, once the most militant comrade."

COMMENT:

No information has been received indicating that the Communist Party was distressed over Robeson's absence from the convention. [REDACTED]

WINCHELL SAID:

"Tips to the Papers - Variety - United States Senator Warren Magnuson's Subcommittee will resume its investigation of television networks on March 6th. The probe will include an investigation of ratings." DC

WINCHELL SAID

"Washington - The U. S. Senate Labor Committee's next target will be John O'Rourke, New York City's powerful teamster leader. He will take the stand in Washington in ten days."

COMMENT

John O'Rourke is the head of the Teamsters Joint Council in New York City. The Senate Select Committee on Improper Activities in the Labor or Management Field is making inquiry relative to O'Rourke's taking over of the Teamsters Joint Council. This committee has indicated to the Bureau that it will be some time before this matter is sufficiently investigated to appropriately hold hearings in this regard.

WINCHELL SAID

"Washington - The internal spy ring trial in the United States will reveal important operations in Denmark and Sweden. Another triumph for the FBI."

COMMENT

Winchell is probably referring to the forthcoming trial of Jack Soble, his wife, Myra Soble and Jacob Alban. They were arrested by the Bureau in New York City on January 25, 1957, for conspiracy to commit espionage and subsequently indicted. There are no Danish or Swedish angles to this case.

WINCHELL SAID

"The Distilleries Workers Union and the Laundry Workers will soon have their laundry washed in public by Senate probers. Federal Attorney Paul Williams has subpoenas out by the way for a garment union local."

COMMENT:

In 1956, the Subcommittee on Welfare and Pension Funds of the Senate Labor and Public Welfare Committee investigated the embezzlement of health and welfare funds of the Distilleries Workers Union and the Laundry Workers Union. The Department held that the Bureau had no jurisdiction relative to the embezzlement of these funds.

A Federal Grand Jury in New York City has been hearing evidence for the past several months with respect to possible labor violations in the garment industry. The Bureau is conducting investigation of possible violations of the Labor Management Relations Act of 1947 and of the Anti-Racketeering Statute at the request of the U. S. Attorney in New York City predicated upon a review of the books and records of businesses in the garment industry which books and records were subpoenaed by the Federal Grand Jury.

WINCHELL SAID

"Former Police Commissioner Wallander of New York City and civilian defense experts have been summoned to testify before the House Committee on Government Operation."

COMMENT

For your information.

WINCHELL SAID

"David Beck, fugitive from a subpoena isn't afraid of the 5th Amendment as he is of an underworld six-shooter."

COMMENT

The press has recently reported that David Beck, head of the Teamsters Union, is in Europe and the Senate Select Committee on Improper Activities in the Labor or Management Field has been unable to subpoena him.

WINCHELL SAID

"Inside the Communist Party: Communists met secretly in Washington, D. C., on February the 19th, at a home on Ogden Street, Northwest. They met with a committee trying to get atomic spy, Morton Sobell, out of Alcatraz. He is doing 30 years there for his part in the spy ring that sent the Rosenbergs to the chair at Sing Sing. Mrs. Sobell, his wife, was the principal speaker."

"Red leaders are pumping new blood into the 20th Century Book Shop in Berkeley, California--one of the top outlets on the west coast for their propaganda."

1. This deals with the apprehension of burglary suspects by the New York City Police Department and evolves around a police officer, whose wife has just had a baby and whose personal courage is being tested in a gun battle. Walter Winchell, as roving reporter, is on the scene and reports the gun battle first hand. There is considerable violence but law enforcement is shown in an excellent fashion.

2. The second script deals with a mad man who murders his girl friend, kills a police officer and is later killed in self defense by a minister. The minister sits in judgment on himself and he ends up by leaving his parish and going to a prison where he becomes the chaplain. This is a very tense drama and is rather violent.

# A NEWSPAPERMAN'S SCRAPBOOK

By Ted Thackrey, Ledger Managing Editor

## Walter Winchell's \$13,000,000 Item

WALTER WINCHELL, whose formal schooling was terminated in the sixth grade when he left school at 13, is coming to Lakeland Friday night as the principal guest of honor of Florida Southern College. When he leaves Lakeland he will be, for the first time in his life, Dr. Walter Winchell, wearing the highest honor that can be conferred upon him by any educational institution. Curiously enough, it is a distinction which has been offered him under other circumstances by other colleges and universities, and one which he has previously declined, sometimes almost brusquely, for he sensed that in some way there were golden strings attached; that the institution in its own dignified but stilted manner might be less concerned with his qualification to receive the honor than with his enormous ability to publicize the institution in exchange for the accolade. As a man who has been made wary through the years of being conned by press agents, whether in white tie, black tie or shirt-sleeves, he wasn't having any. In declining he simply re-established a hard won point — space in his column is not for sale . . . not for money, marbles, nor unearned honors. This time the circumstances differ, and Winchell, in a more humble mood than I have known him, is, for all his humility, aware of the difference. This is an earned degree, a recognition of merit offered, and accepted, in good faith. It arises primarily from a brief broadcast and a paragraph written in a Winchell column eleven years ago — a paragraph that has resulted, thus far, in raising more than \$13,000,000, all of which is in the fight to conquer cancer.

IT WOULD BE presumptuous for me to claim Walter Winchell as a friend, and it would be outrageous to term him an enemy. He is simply a man I have known, off and on, entirely through our mutual profession — I am pleased to note that he styles himself in Who's Who as simply a newspaperman — since back in the late 1920's when I first went to New York to edit the Telegram and Walter was the sensation of the metropolis as columnist and drama critic for the New York Mirror.

I ONCE WENT through a long night watch with him which ended with his usual dawn bout with the typewriter, using a rapid hunt-and-peck system to pound out each fresh line or comment, each newly minted phrase, an addition to the American slanguage — for which he has coined more phrases than any living man. Yet it is not for his contribution to letters, but his contribution to the humanities, Florida Southern College honors him this week, and justly so.

For it was Winchell who sparked establishment of one of the greatest present day foes of cancer — the Runyon Memorial Cancer Fund — though many joined him early and many more have since done yeoman service in that cause. One of its outstanding features — and one of which he is justly proud — is that not one cent of the fund has gone to pay any expenses incurred in conjunction with raising the fund — not to Winchell, nor to anyone else. The \$13,000,000 raised thus far has gone for what it was intended — research to fight cancer.

WINCHELL VIEWS himself first, last and always as simply a reporter — Arthur Brisbane once called him America's greatest reporter, and certainly he has had more news beats read by a wider audience than any journalist of our time. Much of his story is nearly as well known as some of the colorful words and phrases he has coined over the years — infanticiding; Chicago-gorilla; blessed event; blessed hevent and blessed shevent; trumor, and the like. Born in 1898, at 13 he was a theater usher, and before he was fourteen joined with Eddie Cantor, Georgie Jessel, and three others to tour with Gus Edwards' famous Newsboy Sextette. He is one of those rare Metropolitans — a native of New York City. He graduated into his own show. He was a hooper, a comedian . . . and filled with insatiable curiosity and the gift of expression. Among his first coined words was the title of the gossipy bulletin he posted on the bulletin board during his vaudeville career to keep other performers informed — and giggling. He called it "The Daily Newsense."

WINCHELL QUIT show business for Variety and then columned for the New York Graphic, leaving the MacFadden sponsored tabloid in 1929 for the New York Mirror — a newspaper home he has never left. As drama editor and critic, he began to spice his column with Broadway and international gossip, personalized, fresh. Until he had more than 165 newspapers, a reading audience of more than 25,000,000 daily — and he could truthfully say, as he has — "others print the news. I make it public."

WINCHELL'S NEWSBEATS have been fabulous. Once he printed a tip (from Texas Guinan) that Vincent Coll was scheduled to be murdered. Coll, himself dubbed the Mad Dog Killer, was rubbed out exactly five hours AFTER Winchell's column hit the streets. That was in 1922. J. Edgar Hoover became his admirer and friend when Winchell discovered that Bruno Hauptmann was about to be picked up as the Lindbergh baby kidnaper — and sat on his sensational scoop for 24 hours after telling Hoover about it, so as not to interfere with the arrest.

One of his more sensational news beats was the first report of the attempted assassination of President-elect Franklin D. Roosevelt in Miami

on Feb. 15, 1933 — two weeks before the inauguration.

As the bronzed and smiling president was driven along the boulevard at the close of a gala holiday, Joseph (Giuseppe) Zangara, a mentally unbalanced zealot stood on a box and fired at the car from 20 feet away. A woman jerked his arm as he fired, deflecting his aim. He emptied the pistol. Five were seriously injured, but the president elect was unscratched. (Maybe Anton J. Cermack of Chicago, riding beside Roosevelt, was fatally wounded.)

Winchell, in Miami at the time, was on the air less than five minutes after the event.

In 1939 when Louis (Lepke) Buchhalter a chief gangland executioner, was No. 1 on the FBI wanted list with a price of \$50,000 on his head, the mobster surrendered — to Winchell, who was frankly acting as Hoover's intermediary.

Early—in 1932 before most newsmen or commentators were aware of Hitler as more than a messy nuisance in Munich beer halls, Winchell was blasting the Nazi (and Fascist) organizations as international hooligans, mobsters, thugs, and bums. His pounding away did much to make America conscious of the nature and character of rising dictatorships throughout the world.

HE CRUSADED endlessly—for people and causes. From the benefit funds for police and firemen, for higher pay and greater recognition for teachers—for recognition of talent overlooked by other critics. His favorable mentions alone against the field perked up the dying "Hellzapoppin" and kept it running for 1,000 nights on Broadway; More recently, his encouragement—via the column—boosted Roberta Sherwood from a \$50 a week to a \$5,000 a week singer.

He enthused over Senator McCarthy when other liberals—and Winchell is a liberal by his own definition—were less enthusiastic, and demanded to know "But who else is fighting Communazis? Name one other."

With it all, he remained the curious, excited reporter, covering the police beat in preference to all others, watching for signal 30 on the short wave radio (Signal 30—crime of violence) listening for a 5-alarm fire.

DAMON RUNYON, who created fictional Broadway characters from the ones he met in real life on the main stem—and whose characters were often copied in turn by the characters who were their originals—was his bosom companion on many of the night-beat cruises, riding with Winchell in the special car, with special plates, radio, badges and pistol permits.

When Runyon was stricken by cancer of the throat, he refused to give up, continuing his rounds, communicating with his friends by pencil and pad.

One night, after an evening of "chasing the burglars" Winchell, Runyon and others commented on a black-bordered ad which had run regularly in Variety once a year for 30 years as a memorial to the memory of Paul Armstrong by Ben Piazza, whom Armstrong had once befriended.

"You can keep the things of bronze and stone, give me one man to remember me once a year," Runyon scribbled on his note-pad, passing it to Winchell. Runyon, described by a London critic as "the Dickens of our time" died on Dec. 10, 1946.

The following Sunday Winchell appealed over the microphones to friends and listeners for "a dollar, nickle, dime or quarter" in Runyon's memory—perhaps enough, he hoped, to endow a bed in a cancer hospital. He followed it with an item in his column. Other columnists and broadcasters joined in the appeal.

WHEN I TALKED with Winchell by phone last week he reminded me that the astonishing growth of the Damon Runyon Memorial Fund for Cancer Research was as surprising to him as to anyone.

"We didn't know whether we'd get \$50 or \$50,000," he said. "We just said if anybody wanted to contribute we'd make sure none of the money went for 'administrative expenses'—that it would go into research for fighting cancer. Which it has."

The fund began with pennies, nickles, dimes and occasional dollars. A boys baseball team in the Bronx gave a benefit game; some Virginia children sold rides on their horses and sent a total of \$24.87; and from a thug named Scalise serving time in the penitentiary came \$139.90 collected for the good cause.

The foundation now has a home at 730 Fifth Ave., and grants are screened by John H. Teeter, a former aide to Thomas K. Finletter and an honored guest of the college this week in his own right; but Winchell still countersigns the checks, and is a trustee along with Arthur Godfrey and others.

ALL ADMINISTRATIVE expense in connection with the fund is met by a separate foundation . . . the Winchell Foundation.

WHAT MAKES WINCHELL tick? The noted night-beat reporter whose favorite drink is a hot chocolate or a chocolate soda—but who loves to dance the mamba, the samba, or any smart step—with Elizabeth Taylor — with whom he has danced it — or your grandmother, if she's pert and lively.

His own explanation is—and he says it without pretension or smirk—that he is simply a reporter, one of those mortals "who must follow the truth wherever it may lead, whomever it may hurt, and however unpleasant it may be to see and hear."

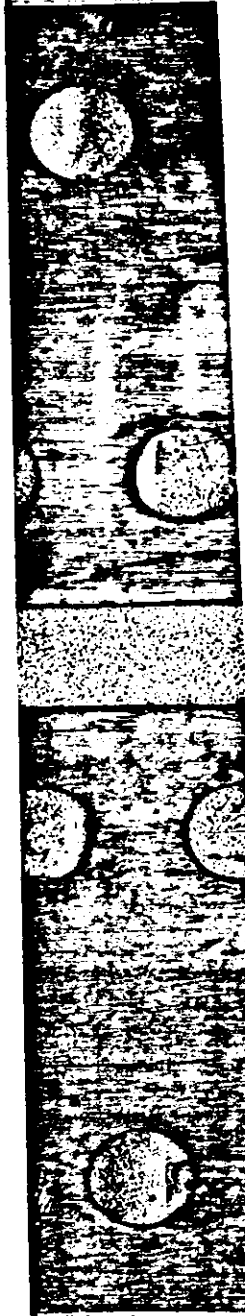

SUBJECT:

ASAC Allan Gillies of Miami phoned at 6:10 PM and advised that Walter Winchell had just called him from the Roney Plaza Hotel barbershop advising that he could not speak too freely but he wanted a message immediately delivered to the Director. Winchell stated he had been contacted in Miami by emissaries of Fidel Castro Cuba (Cuban revolutionary leader) who wants Winchell to go to the mountains in Cuba (Castro's headquarters) as soon as possible to get their side of the story. Winchell told ASAC Gillies the emissaries were most persistent that Walter Cronkheit of the Columbia Broadcasting System was with him during one of the contacts and wanted to go to Cuba also but the Cuban emissary stated that they trusted Winchell only. Winchell then stated since he is a U. S. Naval officer he wondered if the State Department or the Navy would object and he wanted to get the Director's personal views on that point. Winchell stated he could be reached by phone at the Roney Plaza Hotel. ASAC Gillies advised Winchell his message would be passed on to the Director.

I don't see how we can be advising Winchell on this point nor do I understand why he doesn't contact the Navy since he claims to be an officer in the Navy nor why he doesn't contact the State Department. I think we should call ASAC Gillies back and tell him the Director frankly is not in a position to give him any advice but the matter is entirely up to Winchell himself as to whether or not he should go and that it might be well for Winchell to contact his sources at Navy and State.

SUBJECT:

In accordance with the Director's concurrence with my recommendation on my memorandum of March 20, concerning Walter Winchell, Mr. McGuire contacted ASAC Allan Gillies of Miami, at 9:50 a. m. today, instructing Gillies to call Winchell on the telephone and to tell him the Director had been advised of his message and that the Director frankly did not feel he was in a position to give Winchell any advice but the matter was entirely up to Mr. Winchell himself as to whether or not he should go to Cuba, also that it might be well for Winchell to contact his sources at Navy and State.

Mr. Gillies advised that, at 8:10 p. m., last night, March 20, Winchell again called Gillies referring to his earlier call, advising that the Cuban contact man was named Alberto (last name unknown). Winchell suggested an FBI Agent from the Miami Office be present last night at 11:45 p. m., at the Eden Roc Hotel where Winchell was having a party for eight persons, including Alberto, at which time Winchell was going to give Alberto his answer. (Gillies advised that since this was merely a suggestion, rather than a request, the Miami Office took no action.) According to Gillies, Winchell then advised that his permanent address would no longer be the Beverly Hills Hotel but would be the Ambassador Hotel in Los Angeles.

Winchell stated today, March 21, he was going to receive some honor from a fraternity at the University of Miami and that he would leave Miami, at 4:30 p. m., Monday, March 24, flying to Chicago via Eastern Airlines for the Sugar Ray Robinson - Carmine Basilio fight. His address in Chicago will be the Hotel Ambassador East, where he will remain Monday, Tuesday, and Wednesday of next week, leaving Chicago at 3:00 p. m., next Wednesday, via TWA for New York City in order to be in attendance with Frank Sinatra when Sinatra gets the Man of the Year Award for his work with the Boys' Town of Italy organization. Winchell, on Thursday, will leave New York City for Palm Springs, California, where he will M. C. show for the Police Benevolent Association.

[redacted] advised that the Cuban emissary, a refugee from Batista's regime, was named Alberto (last name unknown) and that Alberto was to meet Winchell at 4:00 p. m. today, Friday, March 21, at the Roney Plaza Hotel in Miami. [redacted] was furnishing this information for such value as it might have.

ASAC Gillies advised that the Miami Office was taking no action on any of the above, other than advising the Bureau. He was told all he needed to do was to call Winchell back immediately and to furnish the answer from the Director as indicated earlier in this memorandum.

Next month, for example, she will open the first Federal Legislature of the West Indies, in the Port of Spain, Trinidad. In July, she is planning a goodwill tour of Canada. These may be jolly events... A lovely young lady, however, deserves—and needs—something more. Without love, a castle for a Princess is only a comfortable dungeon. A Princess is a woman and she can only be happy as a Princess when she is fulfilled as a woman. This incurable romantic hopes the love story has a happy ending. It would be perfect timing now. It's Spring, y'know.

*W. C. Handy, the creator of "The St. Louis Blues," is now composing music for a great horn-tooter popularly known as Gabriel. Handy was a talented, dignified, fine man. His "St. Louis Blues," a genuine jazz classic, brilliantly captures the bitter-sweet torment of a sad dream. It is Handy's legacy—and monument.*

Some years ago, Handy was asked about the qualifications essential to a successful composer. He explained: "A man who writes music must learn to listen—with his heart."

*Fate and heartbreak played major roles in the meeting of Mike Todd and Elizabeth Taylor. The failure of her marriage with Mike Wilding afflicted Miss Taylor with an acute case of melancholia... Father Long, an English clergyman vacationing in Hollywood, invited the star to a small party in the hope of chasing her blues. One member of the party decided: "I'll maneuver Mike and Liz so that they sit next to each other. Mike will cheer her up." Before the evening was over, Mike had her laughing for the first time in weeks. Unhappily, the laughs had brief echoes.*

And so, something that began with fate and heartbreak—ended the same way.

*Joanna Woodward's triumph as an Oscar-queen is a story of irony. When she arrived in New York from Louisiana to become an actress, she enrolled at a dramatic school. The first day in school, Miss Woodward was asked to stand and give her name and address. When the class heard her cornpone accent, One and All were convulsed. Miss Woodward has noted: "I managed to lose the accent after six months of hard work."*

In "Three Faces of Eve," the movie that enabled her to gain an Academy Award, she portrayed a Southern Belle with a thick Dixie drawl. Incidentally, the Oscar-winning actress is quoted in a current mag: "I don't want to be an actress."

*Natalie Wood, who sketches a lovely screen portrait in "Marjorie Morningstar," is destined to become a major twinkler. She is only 19—but the climb has been long and arduous. She began as a child performer and has been tolling in the Hollywood salt mines for 15 years. In common with all sparklers, Miss Wood knows that the secret of success is that form of tyranny known as hard work. She is a dedicated actress—most actresses are. A reporter once inquired: "What do you do for fun?"*

"Mainly," Miss Wood responded, "I work."

*Several years ago, Sugar Ray Robinson declared: "I was depressed when everybody was telling me to quit. I can't tell you what a feeling that is. I need a dollar. If I accomplish fame, fortune will follow"... He has gained fame and fortune. In doing that, he has also secured certain qualities which many of the famous lack—and money cannot buy: Respect and dignity. What makes Sugar Ray a great champion is not only his ability as a pugilist. It is the fact that he acts like a champion—outside the ring.*

Alec Guinness has added an Oscar to his collection of monetary and artistic trophies. Not many performers have matched his triumphs. Nevertheless, an actor is an actor... Despite all the gold and glory, the star is haunted by a defeat. Some years ago he starred in "Hamlet" and it was a flop. He hasn't forgotten the setback. His great ambition is to click as The Melancholy Dane.

Sinatra's success has been the subject for numerous essays. His greatest click, however, has been as a human being. Judy Garland once told about the time she was hospitalized in Boston: "I don't want to sound bitter, but a lot of people forget you when something like that happens." Frank didn't forget. He sent Judy roses and called her every day. When he came to New York for a recording date he hired a private plane, loaded it with gifts and flew up to spend the day with her.

By far, the most popular of the Oscar champs was Red Buttons, who is not related to Blue Zipper. After winning the award, Buttons told reporters: "This is more than winning a prize. This should serve as an inspiration to every guy who has been written off in this business." Buttons, of course, was referring to his own brief, rocket-like teevee career.

It demonstrates again that failure is not defeat. If you refuse to surrender to failure—you only gain a little experience. Failure is always temporary. And so is success.

Last week Mayor Wagner appointed the Rev. Dr. Gardner C. Taylor to the N.Y. City Board of Education... In April, 1957, Dr. Taylor conducted the funeral service of a member of the national committee of the Communist Party in his church (The Concord Baptist Church of Brooklyn)... In the course of the sermon, Dr. Taylor described the deceased (Edward E. Strong) as "one who dreamed and worked for the new world every good person desires"... Paul Robeson sang at the service and five members of the Communist Party were among the pallbearers... The above reflects the new line of the Communist Party—to use the Christian church for the burial of one of its leading members.

The FBI has a dossier on one of Walter Reuther's top lawyers. It probably would make interesting reading to the general public but our readers are familiar with most of it. The man also guides Adlai Stevenson on and off the microphones. In fact, many of Adlai's speeches are written or edited by brilliant literary and newspaper people with "former commie records." All of this we have often tried to tell intimates of Adlai to warn him about, but the defeated Presidential candidate is a terrific Tut-Tut man.

In *Newsweek*, Bing offered the most accurate estimate of Perry's teevee success: "Perry is a good, steady boy surrounded by good advisors. Sometimes a guy gets to be a star and he wants to write the show, stage it, produce it, cast it—the whole bit. The show suffers. A good show like Perry's is the product of many brains—and Perry has the brains to know it."

In other words, success is not an island. It is bounded by an ocean of helping hands.

SUBJECT: WALTER WINCHELL'S COLUMN  
"NEW YORK MIRROR" DATED  
APRIL 3, 1958

SYNOPSIS:

Walter Winchell, in a newspaper article in the "New York Mirror" dated April 3, 1958, stated in part that the FBI has a dossier on one of Walter Reuther's top lawyers. Further, that this man also guides Adlai Stevenson on and off the microphone. Winchell commented further by stating that Adlai Stevenson had numerous ghost writers with "former commie records." The Director inquired what is Winchell referring to. Winchell did not identify the persons he was discussing. Neither do our files reflect positive identification of such person or persons. It is possible, however, that Winchell may be referring to the following persons, who could fit the description set forth by Winchell: Joseph Rauh, Jr., represented the United Automobile Workers (UAW) at recent Senate Rackets Committee hearings. Rauh has been actively associated with the Americans for Democratic Action (ADA), which endorsed Stevenson in 1952 and 1956. He is a D.C. attorney who is well known to the Bureau. Walter Reuther, president of UAW, was also active in ADA and in 1957 was a vice-chairman of ADA. Our records reveal that some of the ghost writers for Stevenson were set forth in a "New York Times" article in September, 1956. These were John R. Hersey, Arthur Schlesinger, Jr., and John Kenneth Galbraith. In addition, Senator McCarthy, in 1952, mentioned Schlesinger as a Stevenson writer and also named James Wechsler. These individuals have been critical of the Bureau and its programs and have been affiliated or otherwise associated with either the Communist Party or cited organizations.

DETAILS:

Walter Winchell, in his column dated April 8, 1958, mentioned that the FBI had a dossier on one of Walter Reuther's top lawyers and that this man also guides Adlai Stevenson on and off the microphones. Winchell added that many of Stevenson's speeches are written or edited by brilliant literary and newspaper people with "former commie records." The Director inquired: "What is H.W. referring to? H."

Joseph L. Rauh, Jr., Washington, D.C., attorney and former national chairman of the Americans for Democratic Action (ADA), represented the United Automobile Workers (UAW), of which Reuther is president, before the Senate Rackets Committee recently. Reuther is a vice-chairman of ADA. There are numerous references to Rauh in Bureau files. He is a staunch advocate of civil liberties and in the past has been extremely critical of the FBI and the use of wire tapping. He has been the author of articles condemning the Government Loyalty Program. He wrote a favorable review of Max Lowenthal's book, "The Federal Bureau of Investigation." He has acted as an attorney for the Independent Socialist League, which has been cited by the Attorney General under Executive Order 10450. In February, 1952, he was disclosed as an individual connected with the Office For Emergency Management who had leaked confidential information to a newspaperman, which information subsequently appeared in the newspaper, "PM." [REDACTED]

Although Bureau files do not indicate that Rauh has been a writer for Stevenson, it is noted that in all probability he is the individual referred to by Winchell, in view of the fact that he not only represented the UAW at the Senate hearings but was also extremely active in the ADA during 1952 and 1956, at which time the ADA endorsed Stevenson as the Democratic candidate for President. [REDACTED]

Further, there is no indication [REDACTED] that any other attorney was present as a representative of the UAW or Reuther during the recent Senate hearings.

As to possible writers of Stevenson's speeches, Bureau files indicate that "The New York Times," issue of September 24, 1956, contained the names of John R. Hersey, Arthur Schlesinger, Jr., and John Kenneth Galbraith as purported "ghost writers" for Stevenson. It is noted that Senator Joseph McCarthy (deceased), in a talk at Chicago, Illinois, in October, 1952, also mentioned Schlesinger as a Stevenson writer and in addition named James A. Wechsler.

Concerning these individuals, Bureau files indicate that John R. Hersey is a newspaperman, correspondent, and novelist and was a supporter of the convicted Reds in Hollywood.

Arthur Schlesinger, Jr., a history professor at Harvard University, in addition to being described as a speech writer for Stevenson during his campaigns, has written and spoken on behalf of maintaining civil liberties, has denounced the House Committee on Un-American Activities, and has criticized the FBI's use of informants. He has been described by Archibald B. Roosevelt, son of former President Theodore Roosevelt, as being well known for his socialistic views and his extensive left-wing background. (94-40154-32)

John Kenneth Galbraith, a Harvard economics professor, was born in Canada and is a naturalized United States citizen.

**BIOGRAPHICAL DATA: MATT CVETIC (pronounced SVETICK)**

**Born: Pittsburgh, Pa., March 4, 1909**

**Education: St. Mary's Elementary School, Pittsburgh, Pa.; Curry Business College, Pittsburgh; St. Vincent College, Latrobe, Pa.; International School of Criminology.**

**Pertinent Employment: United States Department of Labor, United States Department of Justice, Federal Bureau of Investigation.**

**Undercover Activities: In 1941 the FBI requested Cvetic to join the Communist Party for the purpose of securing intelligence information for the United States Government. Cvetic successfully infiltrated the Party and in the ensuing nine years attended more than 3000 meetings with Soviet agents, Secret Police and American Communists. During the nine years he worked as an Undercover Agent, Cvetic reported regularly to the FBI.**

**Scope of activity: After being recruited into the Communist Party, Cvetic was assigned to the Party's Professional Branch. This Communist unit was composed of Reds in the Scientific, Legal, Educational, Medical, Governmental and Social, Health and Welfare fields. Later he was assigned to the Communist's organizational, educational, and financial committees. Cvetic helped to direct most of the Reds' major fronts in the middle and late 40s. In 1949 he helped organize the Labor Youth League, the youth arm of the Communist International. Cvetic's nine year pose brought him in contact with hundreds of Soviet Agents and American Communists. His knowledge of the Reds' conspiratorial methods and techniques was acquired, thereby, firsthand.**

**Personal: Cvetic is one of 12 children. His mother and father came to the United States from Austria in the late 1800s. For security reasons, Matt was not permitted to tell his family or friends of his true FBI role. His mother died in October, 1949, believing her son, Matt, had betrayed her adopted country. His father died on Memorial Day, 1950, three months after Cvetic's real FBI role was made known through his testimony before a Congressional Committee.**

**Review: Matt Cvetic authored a series of articles in the Saturday Evening Post titled "I Was a Communist for the FBI." A motion picture, starring Frank Lovejoy as Matt Cvetic, was produced, as was a radio series with Dana Andrews playing Cvetic's role. Mr. Cvetic is presently working on a new manuscript, "Escape to Nowhere," which will reveal, for the first time, the complete story behind his 17-year fight against the Red conspirators.**

Andrew Mellon (Sec'y of the U. S. Treasury in the 20's) always snapped down people by mentioning his rule number 6... When asked what it was, Mr. Mellon replied: 'Don't take yourself too seriously.'

From my childhood (when I went to school with George Jessel and Jack Welner, now an agent out here) I violated that rule. I took myself very seriously because I had to eat... I have been criticized as being aggressive and I suppose I am... I met the world and all corners at catchweights on the Harlem and other New York streets as a newsboy... First, by delivering papers for the Harlem Home News and later the N. Y. Evening Journal—and at subway corners I peddled the Saturday Evening Post... The only thing in my corner (when I was 12) was the corner lamp post... Any tenderness I may have developed is entirely due to the cold iron and steel in that lamp post.

A lot of people are going to psychiatrists these days to find out what they want. From my childhood (with the Gus Edwards' School Days act when I was 13) I knew what I didn't want... I didn't want to be cold, I didn't want to be hungry, homeless or anonymous... And by the grace of God (and my wife June for 35 years) I am none of these... The rest, I figure, is surplus.

The Caliph had his magic carpet, but it never took him where my press pass takes me. I wouldn't trade it for a million (1938) dollars because I have already traded it for 37 years of an exciting newspaper career.

I have seen and met the high and the low. The mighty and the fallen. And I might add—that this is one of the few times I find that I am the fall guy... However, it is not only a great privilege, but perhaps a great advantage, to be the fall guy of you Saints and Sinners... I mean, that on the judgment day when St. Peter breaks up this very proud organization—into its constituent members (some to go to Heaven and some to hades) I am going to respectfully request St. Pete (out of my deep affection for all of you) to cover both stories... And on that fateful day, if character witnesses are needed, I shall cheerfully step forward and tell tonight's master of ceremonies (who so thoroughly reviewed my life) to go to hell.

Thanks again for the fun, the laughs, the tear-in-the-throat and the mercy.

*There is blood on the moon of the Caribees...* The best Intelligence reports indicate that by the time the blossoms are out in your backyard, between 10,000 and 20,000 men will be dead in Cuba... Leaving between 25,000 and 40,000 more homeless and helpless war orphans... To the extent that Batista and Castro are willing to fight it out with innocent lives, they are wrong. So desperately, morally wrong that even the God they profess to follow would find His Mercy tested to forgive such a sin against children.

*It is said that Cuba's internal affairs* are a matter of her concern only. But surely the other 20 Republics have some interest in the Peace of the Hemisphere... Every man's home is his castle, but the community has an interest if he is murdering his wife there.

*The Havana headlines on Good Friday—of all days—were appalling.* The Cuban gov't has not only declared martial law; it has issued a license to murder. It is now a capital crime to strike... A workman in Cuba today has a bayonet in his back—because neither side knows which way he would cast his vote in a free election.

*The Cuban crisis is the supreme test of Western Hemisphere solidarity.* A civil war in Cuba is as much of an assistance to Moscow as a general war in the Middle East... The leaders of the Western Hemisphere must act to prevent it... Each side in Cuba protests its love of liberty. If they really mean it, then let them plead their causes before the Organization of American States... In the meantime, this writer is pleading—while there is still time—for the lives of the thousands and thousands of men who are about to die—and the rights of their orphans to a home.

*Congress of the United States, House of Representatives, Washington, D.C. Dear Mr. Winchell:* Your recent column entitled, 'The Deadly Department of Defense,' which appeared on March 29, 1958, is one of the most significant articles published in the American press within recent years. It is of the utmost importance to the welfare of our country and alerts us to a clear and present danger regarding our defense. I thought it so vital that I had it entered into the Congressional Record by unanimous consent. It has aroused tremendous favorable interest among a great number of my colleagues, who have indicated they will give the matter involved their immediate attention, particularly that portion dealing with the unconstitutional deprecation of the Marine Corps personnel by the Dept of Defense. As you indicated, person or persons unknown in the Defense Department, despite the mandate and appropriation of the Congress to keep the Marine Corps at its full strength, have constantly whittled away at it, placing us in a most unbelievable defenseless position.

*As a first step to remedy this deplorable situation, I introduced a bill on March 20, 1958, H.R. 11541, which would make it illegal for any government department to withhold or impound moneys otherwise appropriated by the Congress from being promptly used or applied for the purpose designated in the Act appropriating same. Other Congressmen are now introducing similar bills.*

*The early passage of this legislation will bring to a halt the abortive attempt to deplete our present day minute men, our first line of defense, the United States Marine Corps.*

~~George~~ Jean Nathan, acknowledged as both the dean and the sage of drama critics, was—in a much larger sense—an actor on the vast stage of New York life... He was, indeed, a critic. Not because he sought flaws, but because he loved perfection... He was generous in noting the effort, but merciless in naming the shortcomings... It was because he was such a master of authenticity that he could instantly detect and lance phonies... All that he asked of the performing acts was that they be true to themselves.

Nathan could be as tender as Peter Pan and as robust as a stevedore, and he applauded each in its proper phase. But he would not tolerate Peter Pan acting like a stevedore, nor a stevedore, like Peter Pan... Thus, for instance, he and I were practically the only critics who applauded "Hellzapoppin!" It was as low-brow as an ape, but, we both agreed, apes are very funny.

With H. L. Mencken, George Jean Nathan left a deep imprint on American culture. It would be silly to say that he wasn't barbed in his words... In fact, he would resent the implication that he didn't know how to sharpen them... It would be equally inaccurate to say that his heart was one which loved all humanity, because he regarded mediocrity as a sleazy form of living death—and didn't hesitate to say so.

Of George Jean Nathan's life much will be said and more will be written... As one of his good friends, I can say the most important thing about it: He loved living it... Further, he had the happy faculty—and the great good luck—to like the people he respected. He had the affection of those whom he liked, and he had the respect of those whom he respected. And not much more can be said for any man.

He was among the first of the dramatic critics to show me guidance when I was a frightened cub first-nighter... He once said that he never believed in answering an attack and added: "Wait until you have a label that stands out—and then stick it on!"... But I could never follow that wise counsel—and now and then some of my opponents (all of them heavyweights) did it to me.

George once said that H. L. Mencken, his confederate on the American Mercury magazine, asked him: "Do you know this Winchell fellow?"... Nathan said: "I see him at the first nights. Why?" And Mr. Mencken replied: "Well, I think we ought to get to know him a little better. We are all in the same libel business—but Winchell seems to know where to stop."

When we were critics together, we both had to make deadlines and had only a fleeting glimpse of the stage over our shoulders as the curtain went down. We already had our verdicts, though we did not consult before writing them... By the same token, George Jean Nathan's last curtain is down. It was a great and important show.

## Excited Man About Town

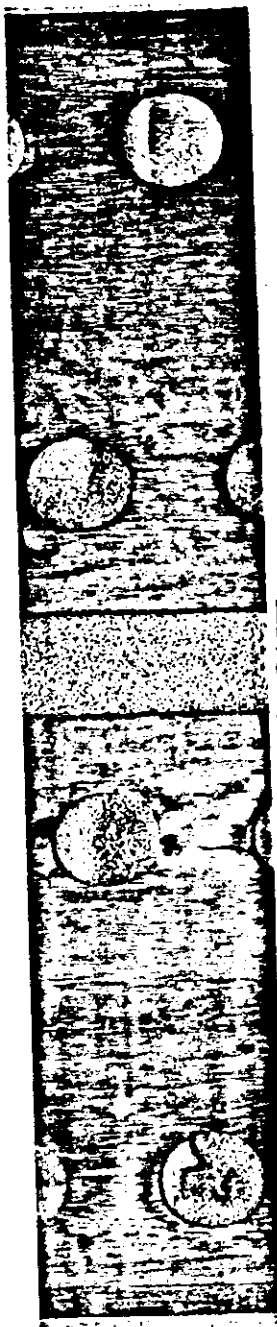
I have another bit of information regarding Buddy Clark's death, but can't vouch for its authenticity, or even remember the name of the man, a pilot, who gave it to me. *C.I.I.*

When I was an airline hostess in Alaska I met an airman who told me he was the pilot who, employed by a small charter line, took the flight in which Buddy was killed. Evidently the plane was small, and had only a few persons on board including ~~including~~ <sup>a woman</sup> an agent, and one or two others. The pilot said that Buddy was killed because he would not fasten his safety belt, and that an autopsy showed that he was killed by a heart attack brought on by terror.

The pilot reports that the small airline was then dissolved in short order, and that everyone disappeared in ~~in~~ different directions in order to be unavailable for the suits brought by Mrs. Clark. He, himself, joined the Air Force, since servicemen may not be sued easily. He was sent to Elmendorf Air Base. All this was in 1951.

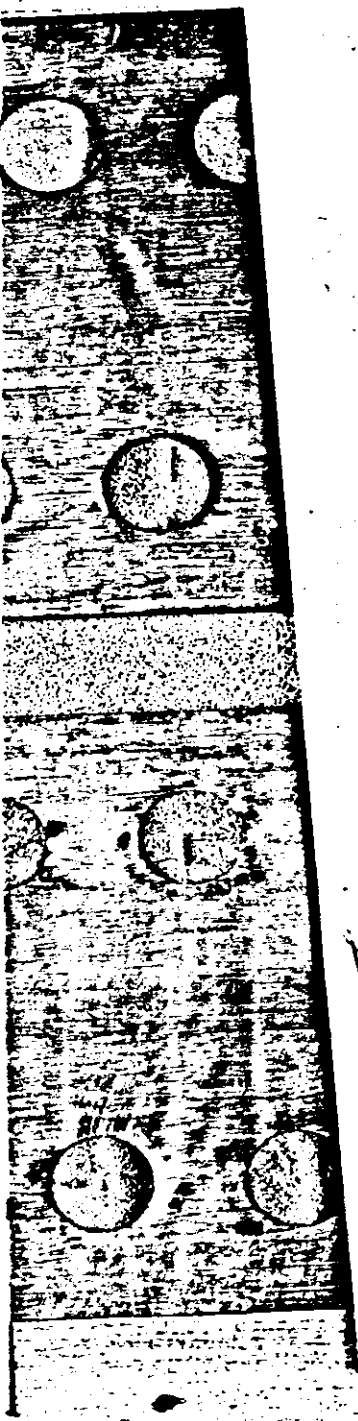

Steve Crane was then a partner of that Hollywood restaurant. He was a bystander to the fight. Lana Turner turned me down cold when I tried to trap her into party membership. She warned me that if I didn't mend my ways, I would wind up in jail. She was so right.

"One more thing. Karl (deleted by WW) killed Serge Rubinstein. He was being blackmailed by the Communist Party of which he was a member. They killed him because he refused to continue paying blackmail. The ante kept increasing as his wealth increased. Forgive me, Walter, I haven't the courage to tell you who I am. Even my confinement here is not under the name you know me by. As Ben Bernie used to say of you: 'Walter will go far, I hope so' . . . Or as Sime (of Variety) would say: 'I'll pay the check.' A Fairy Red Show at Brussels

The How and why!

The American Art Exhibition at the Brussels Fair is a national calamity, as well as an international disgrace!

For many years, the Artists Equity Association, a Red agitation vehicle, has campaigned for legislation in Washington that would put the traditional American artist into a cultural straight jacket.

The Communist Party has given its cultural directive in a publication entitled "Let Us Grasp the Weapon of Culture." Its author, V.O. Jerome, Educational Director of the Communist party and a member of its central committee, now serving a long term in Atlanta, after being convicted under the Smith Act of conspiring to teach and advocate the overthrow of this government by force and violence, is leading the fight to get the above legislation approved. The next of this despicable article -- "Therefore the question arises of establishing leading bodies in this field -- commissions, committees, etc, and assignments of leading comrades on National, State, county, and section levels....we must go forward to the people with the message of peace, of freedom, of Socialist humanism."

This is the Red directive to use art to infiltrate, to organize, and to do it as Socialist humanism, under the banners of peace and freedom as the entering wedge to a nationwide W.P.A. of art, to be eventually under the control of infiltrated art groups. This is thought control.

The bills before both houses of Congress for establishing a Federal Advisory Commission on the Arts was turned down by President Truman. The bills were originally hatched by Lloyd Goodrich, of the Whitney Museum of American Art, and have been steadfastly supported by the Red-dominated Artists Equity Association.
