EMYLEE LYNNE MILLER: EXCERPTIONS

- Her first contact with the C of S was in January of 1960. (pl,1)
- She worked at P.C.D.C. during the summers of 1966 and 1967. (p.1,2)
- In 1970 and 1971 she worked for the Defense Nuclear Agency in Arlington Virginia. (p. 1, (3))
- In February of 1971 she was on a staff contract with P.C.D.C. (p. 1,3)
- From 1971 to 1974 she worked as a secretary for the Defense Communications Agency (DCA). (p. 1,3)
- In March of 1974 she signed a 2 1/2 year staff contract with P.C.D.C. and began work in April. (p. 2,1)
- In August of 1974 she quit work at P.C.D.C. and returned to her job at the DCA. (p. 2,2)
- In October of 1974 she met with officials of the DCA and gave them information about Scientology and LRH. This data was entered into their files. (p. 2,3)
- In January of 1976 the AG LDC contacted Miller in an attempt to persuade her to release the documents. Miller refused to cooperate. (p. 2,4)
- On January 26 she reported the incident to officials at DCA and wrote an affidavit which was critical of the Church and the AG Legal. (p. 2,5)
- On June 7 she returned to course in the P.C.D.C academy and signed a statement repudiating her remarks in the January 26-affidavit. She also stipulated that it was ok with her if the C of S were allowed to see her data in DCA files. (p. 3,1)
- During a Sec-Check she underwent at P.C.D.C. she told that 2 years ago she had an affair with a married lawyer in Virginia. (p. 3,2)
- On June 19 she signed a more complete and notarized affidavit Dead Agenting her remarks in the January 26 affidavit. (p. 4,1)
- On June 29 she was visited by Paul Figley of the Justice department and virtually interrogated on why she changed her mind on the Scientology issue. (p.4,2)
- In August of 1976 Lynne left the D.C. area and went to Hawaii. She was thought to have been transferred to the DCA offices there, but in fact, she is on a 30 day leave-without-pay, while she looks for another job. (p. 5,1)

Security department, and John Whealen, counsel to the DCA. She was prompted to sign an affidavit recounting the contents of the conversation, which affidavit made it appear that the Church was trying to use excessive force and legal threats to coerce her into cooperation with the Church.

At a critical point in the litigation with the DCA over the release of these documents this affidavit was introduced by the DCA lawyers, thus putting C of S in bad light.

March 8. The AGL DC wrote to Terry Birkell of Seymour & Patton and our lawyer in the DCA case, to tell him that he had talked with Nathan Dodell, the government attorney, who was upset because Moxon had found his "confidential witness".

June. Early part of June. Lynne's father died and the Dist Sec from P.C.D.C. performed the funeral services. At that point Lynne realized that she wanted to get back into the group, so she just came in for courses.

Rick Moxon discovered that she was on course and pulled her off until the matter of her damaging affidavit was resolved. This time she was much more cooperative.

June 7: She signed an affidavit Denying her affidavit of January 26. In effect, it pointed out that any disagreements that she had with Scientology, or Mr. Moxon, as a representative of the Church were only momentary, and that she had no objections to the church obtaining the files on Scientology in the DCA that she had been responsible for.

June 12-19. She had a sec = check.

June 12. Sec Check. On the question of having done things that she could be blackmailed for she said that 2 years ago she was dating and having a love affair with some married lawyer in Virginia. On one occasion he took pictures of the both of them in the nude with a delayed action shutter camera. This was done in his office in the Mosley Building in Fairfax Circle, Vienna, Virginia. His name is Dick Byrd.

June 13. Sec Check. On the question of undisclosed psych history she said that 8-10 years ago her father tried to hypnotise her and give her post-hypnotic suggestions in an effort to handle a problem of over eating and being over weight. She said it did not w

June 19. Sec Check. The following are bits of data on people that Lynne had been associated with in the DCA and Scientology.

- Debbie Brown: a friend and former co-worker, told Lynne in a phone conversation in Mid June that she was "concerned" about her getting back into Scientology again, and told her that if she "needed any help to come to her" (referring to getting in trouble with Scientology).

Martha Gluck: she is a secretary in the same office as Lynne and is very antagonistic to Scientology.

John T. Whealen: counsel for the DCA. He has given her the impression that he would like to infiltrate Scientology and irradiate it through the FOI Court cases.

Mr. Lawrence: Chief of the Security department. He gave Lynne much validation when she wrote the affidavit of January 25 and implied that such action would keep her out of trouble.

Her father, Claude: Himself an old time Scientologist told her to be careful of working on staff here because she would get "sucked up" by the org.

Her ex-fiance, Roy Donovan: He is afraid of Scientology and his antagonism is the reason the 2 D was broken up before they got married.

June 19. She signed a more complete and notarized affidavit repudiating the incriminations she had made against Scientology in the Affidavit of January 25.

June 28. She worked through the Ethics Conditions from Enemy up to Non existence.

June 29. The AGL reported that Lynne had told him that she had been visited by Paul Figley of the Justice department and had been interrogated as to why she had gone back on that original affidavit. She said that they left angry because she had been a "turncoat".
