Mike Sommer, through investigation, has been found to have been responsible for actions which led directly and indirectly to the decline of Detroit D and F Org from the period of late 1979 to his dismissal in March 1981.

Mike participated in and condoned financial irregularities. Examples of these are illegal discounts given in many circumstances on free-loader payments, tapes, meters and services some directly by Mike and others by his staff, debiting people's accounts for books without their permission, and then receiving commissions on this; having people write and counting as income postulate checks and depositing checks known to not be covered by actual cash. During the period from August 1979 to February 1980, per report from the then AGI, there was \$51,623 in bounced and postulate checks invoiced as GI that came from at least 21 public people and 2 staff members.

Also the debiting of pre-payments was so large in many cases, the org GI would not cover (i.e. pay the booksales money into the HCO Book Account) and there would be no or minus CGI. In one instance, Mike and Paul Maisano each got about \$1200 book commissions while the rest of the staff got no pay for several weeks as the GI went to pay the book account the actual cash to cover the prepayments.

Mike also allowed and participated in out 2L amongst the senior executives. Mike at one time actually lived with and had a baby by one staff member while still being legally married to another staff member who he had a previous child by who was also living with another staff member.

This kind of out 2L was participated in by almost every senior exec in the org during the time Mike was EL.

Mike's parents got very enturbulated by this and attributed it to Scientology.

This is also adultery which is a crime per state law.

Mike himself continuously drank in spite of numerous handlings on his drinking and allowed heavy drinking amongst the senior execs.

Mike was found to report and allow others to report false stats. but only the postulate checks but also PLC, VSD, GBS, FSMC are examples of false stats for periods during his being ED.

Mike also allowed and participated in continuous and extreme joker and degrader activities including third party of other staff members.

Mike kept a little clique around him amongst which were other execs, the reg and the AGF, most of whom are now blown or routed off. Joking and degrading were continuously carried on amongst all of these.

Samples of his third party were calling people SP's and jotting notes on despatches "----- is an SP. Please handle."

At the same time Mike protected those who were out ethics as they were the "best producers" even though these "best producers" were responsible for a flaccid and declining stat scene.

During the move Mike allowed a decline to occur which later had the appearance of being from the move but instead was attributable to standard actions, such as Liv 6 flying, to drop out plus criminal out ethics, such as has already been mentioned in this declare, and overspending (eg. AGF Doug Mossing, now blown, spending \$20,000 on a phone system for the org). Whereas these were actually bringing about a constantly deteriorating scene, the agreement was growing covertly and overtly that the move was responsible, as this in itself was a wrong why it worsened the scene.

Anyone who attempted to correct Mike would be attacked. This included especially HCO and Qual terminals e.g. the Qual Sec who did a B of I on the org that uncovered many of Mike's crimes was called an SP. The HAS who attempted to remove a criminal reg Mike was protecting got attacked and removed. These are 2 examples of his attempts to protect the criminality then occurring.

Mike continuously violated KEEPING SCIENTOLOGY WORKING and thereby squirreled by allowing out tech to be present in the academy and HGC. Specific instances were continuously using a Class IV auditor for higher level auditing she was untrained on; allowing WIAC to go out in Basic Courses and the Academy. Also there is at least one report of Mike intimidating a staff member to "not upset" a student auditor so he could complete. The staff member thereby was afraid to report that the session was actually terrible.
