# ALABAMA BAPTIST STATE CONVENTION, SEVENTY-SIXTH SESSION—1897.

The Alabama Baptist State Convention assembled in its seventy-sixth session with the Ruhama Baptist Church, at East Lake, Alabama, on Wednesday, December 15, 1897, at 10 o'clock A. M. (the meeting having been postponed from November 12, see item 14), W. C. Cleveland, President, presiding, and Wm. A. Davis acting as secretary.

- 2. I. A. White led the devotional exercises.
- 3. Delegates were enrolled as their names appear at end of minutes, which list includes all whose names were reported during the session.

- 5. The President briefly addressed the Convention,
- 6. The Program as prepared and printed by the committee was reported by W. A. Hobson, Chairman, and adopted, after amendment.
- 7. The address of welcome to East Lake was delivered by W. A. Hobson and response for the Convention was made by L. O. Dawson.
- 8. Visitors were introduced to the Convention as their names appear with roll of delegates, the list embracing all whowere introduced at any time during the convention.
  - J. L. Thompson, President of the Board, read REPORT OF THE STATE BOARD OF MISSIONS.

Up to the first of September the prospects of the Board were very encouraging. This being the beginning of the money gathering season, it was thought that by the close of the Associational period the financial condition of the Board would be very much better than at the same date of last year; but just at this juncture the excitement produced by the appearance of yellow fever on the coast, caused business to become

HOWARD COLLEC LIBRARY greatly demoralized in the central and southern parts of the State. This brought with it the enactment of the rigid quarantine which so completely obstructed the thoroughfares of traffic that it was utterly impossible for the Corresponding Secretary and evangelists to attend many of the associational gatherings. The result was that the portion of the State from which we have heretofore received the larger part of our revenue suffered worse than any other section. Following this came the low price of cotton, which tended to still further depress and demoralize our people. We are sad to say that your Board has another proof of the fact that religious institutions and enterprises are the first to feel the effects of monetary depression. O, that God's people would learn that retrenchment should begin first at some other place than the house of God.

The financial exhibit of last conventional year shows a debt on the mission department alone of \$661.12. During the year just past we have not been able to reduce this, but on the contrary the debt has grown to more than twice that amount. It must also be borne in mind that two years ago the Board began its work with a debt of \$1652.66, which had been previously incurred, and which would have been greatly reduced but for the insuperable difficulties which have confronted us during the past year. This does mot include the indebtedness to the Greensboro Church. The receipts for all purposes for the year ending the first of December were \$18,218.54, which is \$251,64 less than the average for the last ton years preceding this. However, the expendatures of the Board bave been increased; and beside this, very much of the total amount reported represents only a nominal relation to the board, as for instance, where associations appoint their own missionantes, provide the funds to pay them, and receive the indorsement of the Board, simply reporting their work to the Corresponding Secretary. In such cases the money does not pass through the hands of the Board. The funds are kept in the Association, while our secretary and the authorities of the associations exchange receipts. This is perfectly legitimate and right, yet it does not represent the actual receipts and expenditures. Such moneys cannot be utilized in the payment of our debts, or an prosecuting the actual work of the Board.

It is painfully sad to us to mention that the reports of this year and kest show a falling off in contributions to both Home and Foreign Missions. The attention of our pastors is called to this fact, and we urge upon them the importance of pressing these objects upon the hearts and consciences of their people.

 These figures admonish us in language that cannot be misunderstood that extraordinary sacrifices must be made on the part of the friends of our work, while every effort possible must be made to curtail the running expenses of the Board. It is our opinion that such a plan can be effected as will result in reducing our expenses at least \$1000 below what they have been during the past year.

It is with pleasure that we note the interest that has been manifested in the Board's work by the good women of Alabama. Early in the year the Corresponding Secretary held a conference with the Central Committee at Birnfingham, in which this committee promised to put our State work on the list of objects to which they would contribute regularly. To this and special appeals have been sent out from the Central Committee. During the year just closed the Ladies' Missionary Societies of the State have contributed \$833.43 to the work of the Board.

During the early part of the year the Home Mission Board appropriated \$1000 to our work—\$500 unconditionally, and the other \$500 on the condition that the gifts to that Board from Alabama amounted to \$4,000 by the first of next May. This came to us at the time of our greatest need, and we would fall short of our obligations to the Home Board should we fail to make grateful mention of this contribution. The attention of the pastons throughout the State is called to the importance of making earnest efforts to comply with this condition.

#### THE COLORED PEOPLE.

At the convention in Selma in 1895, a plan of co-operative work among the colored people was recommended by the Board and adopted by the convention. This work under the plan then inaugurated has been supported by the Home Mission Society of New York, the Home Mission Board at Atlanta, and the white and colored conventions of Alabama. The undertaking of this work was an experiment on the part of this convention. After a trial of two years, which is ample time to test its success, we are reluctantly driven to the conclusion that this work should be discontinued so far as it relates to our convention, provided that this does not interfere with any agreement made between our Secretary and the Secretary of the Home Mission Board and Home Mission Society. We are satisfied that the benefits received are not commensurate with the amount expended. This is all the more important when the embarrassing financial condition of the Board is taken into consideration.

#### THE BOOK DEPARTMENT.

At a meeting of the Board in July of last year, a plan was submitted by the Corresponding Secretary to dispose of the book business. The plan was adopted and our stock of books, etc., was transferred to Brother J. B. Collier, he taking it on consignment, and receiving 10 per cent on the sales of the same. Much of the old stock is still on hand, with no flattering prospect of being disposed of for some time to come. While this department is in better condition than last year, the Board does not consider it wise to continue the present management. We therefore suggest that the Board be instructed to close out the entire stock, by sale or donation, as early as practicable, and that this be done in such manner as to conserve the best interest of the Board. We see no other solution of this most perplexing problem.

#### SUGGESTIONS AS TO THE FUTURE POLICY OF THE BOARD.

On account of the francial depression of the country, and the present indebtedness of the Board, we recommend

- 1. That the services of Office Secretary be dispensed with, and that the duties of said office be committed to the Corresponding Secretary of the Board.
- 2. That the salary of the Corresponding Secretary be \$1500 for the coming year, with traveling expenses not to exceed \$300.
- 3. That the publication of the State Mission Journal be discontinued, and that the Board be instructed by the convention to try to make some arrangement looking to the securing of a State Mission Department in the columns of the Alabama Baptist. We have reason to believe that such an arrangement can be made as will be satisfactory to the constituency of this convention and the editor of the Alabama Baptist.
- 4. That the State Board of Missions discentinue the handling of Sunday School literature, and that the indebtedness of this Board to the Sunday School Board and the American Baptist Publication Society be settled as soon as possible and in the most feasible way, and, if necessary, the Board be authorized to execute papers for the same.
- 5. That institute work, if continued by this convention, be committed to another Board, and that all funds designated for this work be sent directly to the treasurer of such board.
- 6. That the Corresponding Secretary of the State Board of Missions be instructed not to receive funds for any other objects than those for which the Board was organized, and that he return all funds sent to him to the parties sending the same. This has reference to funds for the Orphanage, Ministerial Education, Howard College and the Judson Institute. This recommendation contemplates the simplifying of our bookkeeping and thus making it less expensive.
- 7. That beneaforth the work of this Board be mainly in the interest of missions, and that all other efforts be made subsidiary thereto.

If these suggestions are adopted, it will effect a saving to the Board of \$1000 during the year, which can be applied to the liquidation of our indebtedness.

The time of the following members of the Board expires with this session: Jonathan Haralson, W. B. Davidson, M. F. Brooks, J. P. Wood, S. A. Adams, N. C. Underwood, J. J. Taylor.

In submitting this report it is meet to call attention to the arduous duties that have burdened the mind and heart of our Corresponding Secretary during this most trying of all the years of the Board's existence. No man can appreciate this more readily than those who have been most intimately associated with him.

#### REPORT OF BOARD OF TRUSTEES OF HOWARD COLLEGE.

To the Alabama Baptist State Convention-Greeting:

Dear Brethren: We are thankful to be able to report the prosperous and hopeful condition of your beloved institution located here at East Lake. At your last annual meeting in Huntsville the fate of the college, which has been of so great blessing to our cause and to the intellectual progress generally of our State, was uncertain and in suspense. It seemed at one time that the institution would be sold for debt. It was a slow and difficult matter to raise money sufficient to reduce the indebtedness to a point at which your Trustees felt the institution would be safe Suit was brought in the United States Court to foreclose the mortgage of some \$38,500, held by the Philadelphia creditors. Rather than have the property thrown upon their hands, however, the mortgagees proposed to the Trustees that if they would pay \$10,000 cash and pay the fees of their agents, they would rebond for \$20,000 for five years at 5 per cent interest. This proposition was accepted.

The Board employed Rev. M. M. Wood as Financial Secretary. Brother Wood has labored faithfully and accomplished a good and much needed work. He has visited many associations and churches, solicited

students, collected notes which were due and attended diligently to all matters committed to his hands.

Hon. W. C. Ward, who for so long has served on this board, and to whom the Baptists of Alabama will always be deeply indebted, on account of pressing duties, presents his resignation as a member of the Board of Trustees.

At the close of the session in last June, Prof. A. D. Smith having formed other business connections when it seemed the college would inevitably have to go to the block, and decliming re-election, Prof. F. M. Roof was elected chairman of the faculty. The scholarship, educational enthusiasm, industry and devotedness to his chosen profession were never doubted; but the friends of the institution did not know as to his executive and administrative gifts. But it gives us pleasure to state that the affairs of the college were never in better shape financially and otherwise, and that all salaries to the present month have been promptly met in full.

At the full meeting of the Board last June, Prof. Edwin H. Foster, then teaching English with great prestige in Waco, Tex., was elected to the Chair of English, which he is filling with signal ability.

Prof. Edgar P. Hogam, one of our own graduates of recent years, was elected to the Chair of Natural Sciences, in which he is giving the most emanent satisfaction. In addition, he is also Commandant of the Cadet Corps.

The present session of Howard College opened September 21, and will close June 8.

The recent smallpox and yellow fever epidemics naturally reduced the attendance for the first term; yet, in the face of all this, the College has enrolled up to this time 131 students, just one less than the number enrolled for the same period last year; and there are bright prospects for a largely increased attendance after Christmas.

#### MINISTERIAL STUDENTS.

Of the 32 ministerial students on the College roster, 22 are actively engaged in preaching, 11 regularly and 11 occasionally. Many places of destitution are supplied with the preaching of the Word by them.

#### GENERAL IMPROVEMENTS.

Since the opening of the present session, a bath room has been fitted up and amply provided with hot and cold baths for the students; the water supply has been improved in quality, quantity and pressure by extending the main and digging a reservoir at a point where a lasting spring of pure water issues from the mountain side. A gymnasium fund has been started, and now amounts to about \$150, and if the friends of the College can be interested in this matter we shall soon have a first-class gymnasium. The campus also has been improved.

#### IMPROVEMENTS IN THE COURSE OF STUDY.

Several improvements have been made in the course of study. Botany has been added to the department of Natural Sciences; the course in English is comprehensive, progressive and interesting; the French and German courses have each been extended to two years; the course in Ancient Languages is one of the best in the South; several new and improved text-books have supplanted the old editions in the department of Mathematics; the department of Philosophy has been extended to a two years' course, and includes Psychology, Neurology, Ethics, Pedagogy and Evidences' of Christianity.

The students are interested, and are doing excellent work in all departments.

The chairman of the faculty is making strenuous efforts to establish a department of Civil and Mechanical Engineering at the beginning of the second term, but is hampered by lack of funds. He thinks a well-equipped professor for the department can be secured for the second half of the present year for about \$600, and that after this year the department will be more than self-supporting by reason of the additional students it will attract to the College. We should rejoice if this convention devise some means by which the necessary amount can be contributed, that the department may be established.

The entire floating indebtedness of the College for the erection of the dormitories, heater, etc., is \$13,612. So that the entire debt is \$33,612. This, against the floating rumons that the entire debt was over twice this amount; and against this \$13,000 of floating indebtedness we have notes now in our possession given by brethren. These notes were formerly hypothecated to the Philadelphia Trust Company, but upon the satisfactory settlement and readjustment of the bonded indebtedness, as the trustees stipulated they were returned to us. As now the entire amount of these notes will go to the College, we earnestly recommend, where it can be done, that these notes be paid.

At as early a date as possible the institution should be relieved of debt, and steps taken looking to adequately endowing the College.

The Board of Trustees would recommend that every Baptist church in Alabama be, and is, urged by the Alabama Baptist State Convention to appoint at once a committee of five, to be known as the Howard College Committee, the duties of which committee shall be to assist the College faculty in securing students, and in such other ways as may seem helpful, the name of the chairman of said committee to be sent to the college.

The trustees of Howard College offer to the Baptist High Schools and Institutes of Alabama the following

#### PLAN OF AFFILIATION.

1. That these schools adopt the curriculum of study of Howard College,

using the same text-books as far as their course extends, and that the presidents and principals of these schools will use their influence to send pupils to the Howard after they have finished their course in these schools.

- 2. That Howard College agrees to receive any student of these schools into its classes upon a certificate of the president or principal of the school from whence he comes as to his advancement without examination.
- 3. That the president or principal of the school (or proper authorities) wishing to affiliate with Howard College in the manner stated, notify the president of Howard College of his acceptance of this plan, and when so notified, such school shall be placed upon the roll as one of the affiliated schools of Howard College. This plan of affiliation will also apply to all other preparatory and high schools, not Baptist, in the State that may wish to thus affiliate with Howard College.

#### REPORT OF THE BOARD OF MINISTERIAL EDUCATION.

The Board of Ministerial Education, in submitting this their first report, might recite the difficulties by which they have been confronted during a year of unusual calamities, in which all of our denominational interests have suffered, but these are facts familiar, as well as painful, to us all.

#### THE MINISTERIAL STUDENTS IN HOWARD COLLEGE,

- 1. THOSE OF LAST SESSION.—There were thirty ministerial students at Howard College dast session. Nine of these were self-supporting, ten paid a part of their expenses, while eleven were entirely dependent upon denominational support. There were five married students last session.
- 2. THE PRESENT SESSION.—We have thirty-two ministerial students this session, with the prospect of more the second term. Fourteen of these are self-supporting, five are paying part of their expenses, and thirteen are asking for full support. Nine are in the Freshman class, six in the Sophomore, seven in the Junior, seven in the Senior and three in the preparatory. There are six married students this session. Quite a number of the students are actively engaged in preaching. They preach on an average about eight hundred sermons during the session. At present eleven are preaching regularly, and eleven occasionally.

Last session there were eight students in the Semfnary from Alabama; this session there are twelve.

# REQUISITES TO ENTERING HOWARD COLLEGE AS A BENEFICIARY OF THE BOARD.

- 1. MORAL.—In addition to being a member in good standing of a Missionary Baptist Church, the beneficiary must bring the undersement of life church, expressing their belief that he is called of God to preach the gospel.
- 2. FINANCIAL.—The object of the Board is to help only those who need help; therefore it refuses to contribute anything to a student who has resources of his own. The Board very earnestly asks that the church and Association giving endorsement of a brother, signify, at the same time, their purpose to render him financial and to the extent of his necessities or their ability.
- 3. EDUCATIONAL.—The Board at its last session decided to require all beneficiaries, hereafter, to be prepared for the Freshman class before entering Howard College.

#### REMARKS.

The Board of Ministerial Education requests the convention to appoint a committee to confer with them, and as many of the Board of Trustees of Howard College as may be in attendance upon the convention, looking to a wise and definite financial policy, the same to be reported at this session of the convention, and if approved by the convention, be made a part of this report.

# 12. J. B. Lovelace, President of Board of Trustees, REPORT OF BOARD OF TRUSTEES OF THE JUDSON INSTITUTE.

The fifty-minth annual session of the Judson ended June 4, 1897. The Trustees and the denomination throughout the State have much cause for rejoicing and gratitude over the prosperous year, and the most encouraging outlook for the future.

During the session 133 pupils were enrolled, of whom 90 were boarders. Fourteen teachers, representing all the departments of a finished education, were employed. Two officers of the Home Department, with the President, had the oversight of the home life of the boarders.

It is fitting in the beginning of this report that we make mention of the signal blessing of God upon the institution. The work done in all departments was of a high grade and exceedingly gratifying, and during the session a deep religious influence pervaded the school, and the reputation of the Judson in the education and development of Christian womanhood was sustained to an unusual degree.

The President, Rev. Robert G. Patrick, D. D., has proved bimself in every respect the right man in the right place. More than the usual number of problems have presented themselves during the past year, but his consecrated tact and wisdom enabled him to solve successfully all of them, and everything is moving along smoothly under his administration, with the prospects for the future brighter than they have been for many years.

#### THE DEBT PAID.

It is with profound gratitude that we report the interest bearing bonded indebtedness all cancelled. This was made possible by the generosity of Brother J. C. Bush of Mobile, who agreed to funnish \$8000 (\$4000 of which was a gift in the name of his wife, one of the Judson's most accomplished and devoted graduates, and \$4000 as a loan without interest) on condition that the whole debt be paid in a specified time. President Patrick immediately took the field and called upon the Baptists of the State for help, who responded nobly and promptly. We make mention also of the liberality of the bondholders, who met us in the

spirit of equity, and generously conceded a portion of the debt,, and of the services without remuneration of Drs. George B. Eager and A. J. Dickinson and other brethren, who nobly seconded the efforts of the President.

It is our pleasure to report that by the excellent business management of Dr. Patrick the floating debt has also been about liquidated.

#### BETTER FACILITIES.

One result of the lifting of the debt was that the Judson was enabled immediately to furnish better facilities. The property, which has necessarily been neglected for several years, was repaired and put in first-class condition, and some improvements were made. New carpets were bought for all the sleeping rooms and new table wave for the Dining Department. In addition quite a number of new high grade planes have been added to the music department. The Library has also shared in the general good fortune, and a number of new books have been bought. But there is great need of some friend or friends who will furnish the means for making other needed additions to the already excellent Library.

#### INCREASED NUMBER OF PUPILS.

These increased facilities have had their weight in increasing the number of pupils. Already there have been enrolled 150 pupils, of whom 110 are boarding pupils, a number greater than for several years past, and others are expected soon. But for the yellow fever epidemic, which shut out the Mississippi, Louisiana and some of the Alabama patronage, the Judson would have been taxed to accommodate all who would probably have come. As it is, it is cause for gratitude that the institution has such a large boarding patronage, greater, perhaps, than that of any other female school in the State, which charges a reasonable rate for tuition and board, and that all sections of Alabama are so generally represented.

#### INCREASED TEACHING FORCE.

The large attendance has compelled the Trustees to make additions to the already large and excellent faculty. Especially full was the music department, necessitating another teacher for the voice and plane. We believe there are very few places that offer so many and so great advantages as the Judson does just now. It is especially gratifying to note the high order of work done and the never failing devotion of the pupils to the Judson. A slight evidence of this was the presentation recently by the history class of 48 volumes of history to the Library. Indeed, the success of our school is due, to a great extent, to the devotion of those who are or have been her pupils.

At present the pupils and Alummae are endeavoring to raise \$5000 to be known as the Averett Memorial Fund, in memory of the late belowed President, S. W. Averett, the interest of which is to be used to educate

poor and worthy girls. They have already met with a gratifying measure of success, having on hand or in pledges about one thousand dollars, and we commend this movement to the sympathy and support of our brethren.

#### HEALTH GOOD.

We are pleased to report the health of the school good. In the beginning of this session there were five cases of sickness—all contracted elsewhere—but we are glad to report that the pupils of the school are at present all well.

#### OUR BAPTIST SCHOOL.

We would call attention to the fact that this is our Baptist school for girls and young women, and deserves the hearty support of every Baptist in the State. It is pre-embrently a Christian school; the Bible is taught regularly and systematically by the pastor of the Siloam church, Rev. Paul V. Bomar, and the aim is that every pupil who goes out from the Judson shall be a cultivated Christian woman.

## 13. John W. Stewart, Financial Secretary, read

#### REPORT OF BOARD OF TRUSTEES OF ORPHANS HOME.

Our last report embraced the operations of the "Home" up to the 1st of November, 1896, and the present report covers our work from that time until the 1st of December, 1897, making the period of time thirteen instead of twelve months. Since our last report we have received five (5) boys and eight (8) girls, making a total of thirteen.

Since the "Home" was established we have received into it 35 boys and 39 girls, and have let out by apprenticeship 2 boys, returned to their people 5 boys and 4 girls, let out by adoption 10 boys and 12 girls, and we now have in the home 18 boys and 23 girls.

These children come from 19 counties, as follows: Barbour 2, Butler 3, Conecul 2, Escambia 11, Lee 3, Marengo 4, Montgomery 2, Bibb 2, Chambers 1, Covington 8, Jefferson 8, Limestone 1, Monroe 4, Pike 2, Russell 1, Talladega 8, Tallapoosa 2, Tuskaloosa 3, Walker 6.

The internal management as indicated in our last report is still pursued. Our effort is to cultivate the refinement and mutual love of a well regulated Christian home, to suspire a spirit of mutual helpfulness and self-reliance, as a basis upon which to build true character. With this end in view the boys are required to do farm work, look after the stock and such other heavy work as may be unsuitable for the girls. The girls are required to look after the housework, cooking, mending and such other duties as come properly within their sphere. With very little outside help the boys have made this year a good crop of corn and hay, and

HOWARD COLLEGE LIBRARY will kill about 1500 pounds of pork. Besides this, they have raised a fine lot of poultry, and sufficient vegetables for the use of the "Home."

The children are all in school, the small ones being taught in the "Home" by one of the larger girls under the direction of the matron. The larger children are sent to the public school, where tuition is free, the matriculation and incidental fees being from \$5 to \$10 per annum for each pupil.

All the children are required to attend Church and Sunday School. The health of the children has been excellent for the past year.

We are making some much needed improvements, which, when finished, will give us eleven additional rooms, and add much to the comfort of the old rooms. We have endeavored to make these improvements as we felt able, and to avoid going in debt beyond our ability to pay when due. We are now in great need of funds to enable us to finish up the work in progress, as well as to meet our daily expenses for such food as we have to buy.

Since our last report we received \$500 through the bequest of the late Amos Chapman, a former citizen of Michigan, but a citizen of Conecub county at the time of his death. Mr. Chapman was a noble-hearted man, who was impressed with the work of our "Home" and its needs, and though not a member of any church, was a believer in that practical religion which manifests itself in good works.

His bequest was of some lands situated in Baldwin county, to some of which the title was involved, and his relatives in the North began a contest of his will as against our bequest. After looking into the matter we concluded to accept a compromise of \$800 rather than become involved in a long Edigation. With this money we were enabled to do much of the needed improvements on our buildings. It is our purpose to finish up the work by the 10th of next March, and be free from debt, when we wish to dedicate the "Home." We appeal to our noble hearted brethren and sisters to help us to accomplish this, the great desire of our hearts.

We are profoundly grateful to God for His wonderful goodness and overruling providence, and to all those who have added us from time to time in the prosecution of this labor of love.

Resolved, by the Board of Directors of the Ababama Baptist State Convention, That the said meeting of the convention be and is hereby post-poned until such date as may hereafter be fixed by this Board.

2. That the Secretary convey this action of this Board to the Baptist Church at East Lake, Ala., and publish the same in the Alabama Baptist and other newspapers.

At a subsequent meeting held on November 14 it was

Resolved. That the Alabama Baptist State Convention, heretofore postponed on account of the prevalence of yellow fever in this State, be held with the Baptist Church at East Lake, Ala., commencing on Wednesday. December 15, 1897, at 10 o'clock a. m.

#### REPORT ON STATE BOARD'S REPORT.

We, your committee to whom was referred all of the report of the State Board of Missions, except recommendation 5 on institute work therein, beg leave to submit the following amendments and additions:

1. In regard to the matter of \$3200 referred to in said report as an indebtedness to the Greensboro Church, it is the sense of this convention as a body corporate to recognize this indebtedness as a moral obligation upon the Baptists of Alabama, but to assume no legal liability whatever relative to the same. The Baptists of the State are urged to contribute to the authorized representatives of the Greensboro church that this obligation of thirty years' standing may be discharged and Baptist influence strongly established in this important community.

- 2. In recommendation 6 the third and fourth lines shall have the following clause stricken out: "And that he return all funds sent to him to the parties sending the same." Immediately after Judson Institute in next to the last line of section 6 insert—"all of which funds should be sent directly to the Boards of the respective interests named."
- 3. That as suggestion 8 of said report, the following be inserted: "The Board is instructed to print and circulate as soon as possible a circular letter explaining what funds are to be sent to the State Board of Missions and where funds for other interests fostered by us shall be sent."

With the above amendments and suggestions your committee advises the adoption of the recommendations in the report.

- 3. We recommend that said Board be located at Opelika and cousist of seven brethren, to be appointed by this convention.
- 4. We recommend that the work committed to this Board be done without involving this convention in any debt whatever.

#### REPORT ON WOMAN'S WORK.

We find, on investigation, that there is a general awakening among the women of the South to the responsibility resting upon them to ald in advancing the Master's kingdom.

Increased activity and interest are manifested on every hand. The time has come when Baptist women are rising up on the right and on the left, and saying. "What shall I render unto the Lord for all His benefits toward me?" It is gratifying to note the permanent work that has been done by the Christian women of our State since the appointment of a State central committee eight years ago.

They are not only multiplying societies among themselves, to establish and strengthen the misstonary conviction, but they are organizing societies among the children and young people as well. Twenty-nine new mission societies and bands have been formed during the past year. Mrs. T. A. Hamilton, we are happy to say, has returned to the State, and has taken charge of the Sunbeams, which makes the outlook for the children more promising.

During its existence the Woman's Missionary Union has achieved great results. In 1888, the first year of the Society, \$14,316 were raised for foreign missions, and \$6,723 were raised for home missions. Last year they raised for these two boards \$53,407. The last report shows the work among the women to be on the increase. They work in perfect harmony with the churches and as auxiliaries of the Southern Baptist convention.

Your committee cannot close this report without referring to the labors and death of Sister I. C. Brown. Several years ago the convention hailed with much satisfaction her appointment to the position of corresponding secretary. Her qualities of head and heart emmently fitted her for the position.

We cannot refrain from putting on record our entire satisfaction with her work, and our sorrow at losing her, together with the prayer that her mantle may fall upon the shoulders of her worthy daughter, who has been selected to fill the vacancy.

Let us thank God for this movement, for this aid which He has so graciously vouchsafed to us, and give them our earnest sympathy and cooperation. The Union earnestly pleads for a Christmas offering from every woman and child in the State to foreign missions.

#### REPORT ON FINANCIAL PLAN FOR MINISTERIAL BOARD.

The committee appointed to confer with the Board of Ministerial Education and the Trustees of Howard College, in conference with said

Board and Trustees, submit the following as a line of policy in reference to the duties of the Board of Ministerial Education:

- 1. That no one shall be received as a beneficiary of the Board who does not come well recommended by his church, and even then to be subject to the judgment and discretion of the Board.
- 2. That no one be received as a beneficiary who cannot enter as high as the Freshman class.
- 3. That the faculty make the six weeks' reports of the ministerial students to the Board of Ministerial Education, and in case the student is not making a satisfactory record in his studies, and cannot be induced to do so, he forfeits his right to support from the Board.
- 4. That we deem it to be the wisest and best p'an for the contributions which may be made for ministerial education to be gratuitous gifts to the beneficiaries, with the understanding that all be required to execute their notes payable to the Board of Ministerial Education, or their successors in office, with legal interest if at any time during life they should abandon the work of the ministry.

R. M. HUNTER, Chairman.

The convention refused to adopt an amendment proposed by A. J. Dickinson in these words:

That the Board of Ministerial Education send its students to any school which in their judgment may be best and satisfactory in each case, and that it is the sense of this convention that the Board and Howard College are separate and independent, and that Howard is in no sense to be burdened by any deficits of this Board.

The report of the committee was then adopted after discussion of the report and the general subject of Ministerial Education, by W. A. Hobson, A. J. Dickinson, Josephus Shackelford and W. R. Ivey, the third and fourth sections of the report having been amended to read as printed in the body of the report.

#### REPORT ON HOME MISSIONS.

Through home mission work is to come our salvation from many perils seriously threatening us, both as a nation and denomination, as well as

our development in the principles and graces of Christianity. The blighting evils with which we are threatened by the presence of people of different races and nationalities, each struggling for supremacy; by the rapid influx of foreign immigrants, many of whom are hostile to all law and order, and threatening to turn liberty into license, cannot be overestimated. But it becomes us as Baptists, imbued with the Word of God, to view home mission work from a different, a higher, an evangelistic standpoint, and study and support home missions, because through that work is to come the salvation from sin of millions of souls in our land.

The work done, while not a tithe of that which remains to be done, has been gratifying. The blessing of God has rested upon it far beyond our deserts. The Board reports the work done during the last Southern convention year as follows:

These facts, and the additional fact that the board, while beginning the year with a debt of \$13,700, closed it practically out of debt, make a very gratifying exhibit of the work.

The work to be done, however, demands a large increase of laborers and a correspondingly large increase of contributions from the churches. The amount the Board received last year from all sources (\$103.848) might be well spent in Texas alone, and not more than meet the real demands of that great mission field. What, then, is this sum to the work needed to be done among the negroes, among our rapidly increasing forcign population, among the sturdy mountaineers of Virginia, North Carolina, Tennessee, South Carolina, Georgia and Alabama, Florida and Louisiana, Arkansas, Indian Territory, Oklahoma, and in the rapidly

growing cities and towns all over our Southland? The indications of the early establishment of Cuba's independence point to vastly increased demands from that most fruitful mission field in the near future.

The resources with which we are to meet these growing needs are the million and a quarter of Baptists in our Southern Z'on. As yet, however, our vast mine of denominational wealth and power is being worked only on the surface. What great things the Lord will do for us, and through us, and in us, when all our resources shall be made available, who can tell?

## 37. A. B. Campbell read

#### REPORT ON FOREIGN MISSIONS.

Your committee notes some highly gratifying facts in connection with foreign missions. The number of converts, their excellent character, the decrease of obstacles political, social and religious, the increasing devotion of missionaries to their work, notwithstanding the hardships and perils they have to encounter; the growing interest of nearly all Christian denominations in the work, the increasing number of well qualified applicants for appointment to every part of the field, not excepting the most beaughted and hostile; the increasing amount of the contributions; the growing conviction among Christians that commerce, education and other human enterprises are to be prosecuted chiefly for the propagation of the gospel among the nations; the Lord's promise of His presence with us to the end of the world—these and other considerations are extremely inspiring. We allude to them with unspeakable pleasure.

On the other hand, there are less pleasing features, of which we ought to take cognizance in the hope of bringing about a better condition of things in the churches. The Foreign Mission Board of the Southern Baptist Convention is sectionally hindered in its operations by insufficiency of funds. While nearly all idolatrous countries, with their millions of population, are open to the missionary, and godly men and women are eager to enter and take possession in the name of the Lord, the Board is unable to obtain the means necessary for the work. Even some of our very best missionaries, who have done priceless service in time past, now in this country on a visit, are unable to return because the Board cannot afford them a support.

Nor is the constituency of the Alabama Baptist Convention without repreach in this matter. The net contributions to foreign missions from the one hundred and eighteen thousand white Baptists of this State for the twelve months ending last May aggregate only six thousand one hundred and seven dollars and sixty-three cents, making a little over five cents per member. Of these there are, in round numbers, one thousand ordained ministers, so that the contributions are a little over six dollars for every ordained minister in our ranks.

Much of this amount was not earned and laid aside for this cause by the contributors from a deliberate purpose born of abiding love to God and His kingdom, but was designed for some more earthy, selfish use, and was finally appropriated to missions under the influence of special sermons, warm public appeals, direct, urgent, personal solicitations of committees, and under pressure of other means employed by the more ardent advocates of the cause in the belief that if the owners were left to their habitual disposition, the money would never find its way into the treasury of any foreign mission organization. Just how much comes under this description we cannot tell, but that portion of the fund is no expression of missionary zeal on the part of the givers.

Furthermore, this scant amount, largely obtained by such means, came from the few, and those few the same persons in the main who pay the pastor's salary and other expenses of the local church and Sabbath school, contribute to indigent ministers, the Orphans' Home, Howard and Judson Colleges, ministerial education, associational missions, State missions, home missions, and whatever else is undertaken by the churches for the glory of God and the good of mankind. We believe that a large majority of our members contribute nothing for foreign missions, not even one cent a year, and thousands not one cent in a lifetime. We are pensuaded this is true, not chiefly of the poorest of our people, but likewise of those in comfortable circumstances, and of some who are prominent among their neighbors for wealth.

Of the contributions that are made a large portion is not given till the

year is far advanced. This delay obliges the Board to borrow money to pay the salaries of missionantes at the close of every month, thus necessitating an additional expense for interest, which, during the last year, for instance, aggregated \$2.160.34. From May 1st of this year to October 15th, a period of five and a half months, the entire receipts from Alabama for foreign missions were \$380.23, a statement which shows that here again the Baptists of Alabama are at fault like our brethren of other States.

We beg leave to emphasize that we cite these particulars, not in a censorfous spirit, but altogether to awaken inquiry as to what reforms are needed, and how they are to be effected.

If it be true that the financial burden of our operations, local and general, is borne chiefly by the few, and not for the reason that the many are less able, but are only less willing, it is obvious that the thing needed is an improved disposition, not with reference to foreign missions merely, but with reference to all Christian work that havolves pecuniary sacrifice. In this report, however, we treat the matter in its bearings on foreign missions.

How can we enlist our people heartily in this department of Christian activity? Not without an improvement of their Christian character in general. And not unless the Holy Spirit accompany our efforts with His gracious influence. But what measures may we employ to this end?

First, our efforts should be addressed to ministers, as well as to other members of the churches, for the ministers are the leaders; in their hands, as God's instruments, is the future of the churches.

Secondly, we should labor faithfully to convince our people thoroughly out of the Scriptures that God requires all His children, individually and in their organized capacity, to lend their aid by all means in their power to the propagation of the gospel throughout the world.

Thirdly, they should be constantly exercised in liberality to foreign missions by stated, frequent collections—not impromptu collections sprung upon them occasionally just because they are at the moment in the humor for it—but collections at frequent intervals fixed at the beginning of the year, and for which they are to be encouraged to get and lay up money beforehand as a sacred feature of their religious life. No amount of teaching and exhortation develops liberality unless there is adequate exercise in that discretion.

Fourthly, the missionary spirit should be steadily nourished by a generous supply of information on the progress of the work; information as to its past history; information pertaining to the plans now in use, and the men who are operating them, and how they are operated; information on the fields, the history, temper and condition of the populations; the methods, toils, paivations, persecutions, successes and triumphs of the laborers; on the awakening, seeking, conversion, rejoicing and subsequent

lives of converts, and the cheerfulness with which many of them lay themselves on the Lord's altar in full prospect of suffering in body, purse and mind. Missionaries often write that if their brethren at home could see and hear what they witness every day among the people to whom they minister, there would be no lack of zeal for the cause. This is true. And the constant contemplation of the missionary's life through the medium of the printed page is the benefit we now propose for the members of our Alabama churches. The Foreign Mission Journal, other distincgively missionary periodicals, our denominational papers, including those designed especially for the Subbath school, tracts on missions, the many charming thographies of missionaries and histories of missionary enterprises, these are the kind of literature with which the houmes of our people and their pastors ought to abound. We include the homes of pastors, for how can pastors interest their hearers in missions unless they are themselves informed on the subject? Every available means of getting such literature distributed in lawsh abundance should be used with diligence. The reading of it will kindle and keep alive the missionary five in the hearts of the pastors, their wives and believing children; of the deacons, their wives and believing children; of the whole membership of the church, whather located in town, city or country. If the minds of Christians be constantly replemished with missionary intelligence, the question of raising funds for missions is relieved of its difficulties.

The Foreign Mission Board of the Southern Baptist Convention is seeking to secure in every district association one efficient, unpaid representative of its interests, through whom it hopes to obtain access to every church, and thus to every member of every church. We recommend a hearty, universal co-operation with the Board in this effort to diffuse missionary intelligence and stimulate missionary zeal among the Exptists of the State.

#### REPORT ON SUNDAY SCHOOLS.

It should be unnecessary among Baptists at this late day to urge the importance of the Sunday school. It is among the most important factors in our church work.

The notion has prevailed for a long time, and among many people, that the Sunday school is for children, and children only. The consequence has been that the children are becoming not only "wise unto salvation," but wise in the knowledge of Bible truths, while many of the older people who stay at home are drying up in ignorance and inactivity. Instead of the old teaching the young, there are cases where the young can very easily teach the old a few things, and this is due to the training the young get in the Sunday school, which many of the older ones miss.

We would urge:

- 1. That every member of a Baptist church who can will attend the Sunday school.
- 2. That the pastor keep in sympathetic touch with the school in his church.
- 3. That the Sunday school be in direct accord with the church as a whole, having its officers to make regular reports to the church in order that the affairs of the school may be ratified by the church.
- 4. That we endeavor to devise the best methods of work by having competent officers and teachers, holding teachers' meetings, Sunday school conventions, etc., for the purpose of discussing these methods of work.
- 5. That the lesson helps be used only as helps, and let the Bible be the text-book, not simply studied about, but studied in the school.

We would call attention to the excellent work our Sunday school Board at Nashwille is doing. The sixth annual report last year revealed the fact that its efficient corresponding secretary, Dr. J. M. Frost, was not only fully consecrated to his work, but was likewise a thoroughly competent business man.

The Board now has a home of its own in a building for which was paid \$10,000.

Last year as a result of Missionary Day in our schools in the South, suggested by the Board, it received and sent to the Home and Foreign Boards about \$4,000.

This Board, during the six years of its existence, has contributed in eash, gifts of Bibles, books, tracts, etc., to mission schools and to the other Boards the sum of \$42,089.88.

As is well known, this Board publishes a full list of Sunday school literature, which is furnished to our schools at very reasonable rates. This Board should have our full sympathy and support.

The American Baptist Publication Society is also doing a good work among our schools in the South, as well as elsewhere.

A few years ago there were reported 123,173 Sunday schools in the United States, in which were 1,305,939 teachers and 9,718,432 scholars. At the same time the common schools had an enrollment of 9,208,896, which was considerably below the total enrollment of the Sunday school. It is reasonable to suppose that while both have increased since that report, the proportion remains about the same.

It is gratifying to note that many of our schools not only have the idea of discipling those who attend, but have caught the missionary spirit, and evangelization has become a conspicuous word in the vocabulary of Sunday school workers.

#### REPORT OF COMMITTEE ON TEMPERANCE.

This is an old subject. It has been prominent before the public mind for a long time. It has employed the thoughts, the tongues and the pens of many wise and good men and women in every Christian land. Papers, periodicals and books have been sent out from the printing press in the interest of temperance, and the subject has been so thoroughly discussed as to leave little or nothing new to be said. Yet, so long as the appalling evils of intemperance exist, blighting and destroying human hopes and human happiness, it is the duty of all citizens, and of all faith-

ful Christians, to battle against the liquor business with all their main and might.

The evils of intemperance baggar all description. It destroys health and character, body and soul. It is ruin for time and eternity. Its widespread and deadly influence is to be seen in all lands. It penetrates all departments of society, from the highest to the lowest. Its trail of poisonous slime is to be found upon the sacred floors of God's sanctuary under the guise of dram-draking.

Shall we quarantine against yellow fever and other epidemics, and allow this most desolating pestilence to stalk abroad at will all over our land, leaving sorrow, ruin, temporal and eternal, in its wake?

Christians must take a resolute stand against this great evil. They have in their hands the only true remedy—the Gospel of Christ—and should by example and united action so mould public sentiment that no member can maintain his standing in the church who makes, sells, drinks, favors and encourages in any way the liquor traffic. The rescue of our land from the dreadful effects of intemperance and from the saloon power rests with the Christian people. The saloon exists in our State because of the laws made to license and protect it, and these laws may be repealed whenever the Christian people of the State demand it. Threfore, the Christians of our State are responsible for the existence of the open saloon within our bounds. If all professed Christians would unite their efforts, the speedy overthrow of the saloon power is an assured fact. Wilberforce uttered a truth when he said: "Intemperance could not exist but for the abominable indifference of the Christian church."

We recommend that any member of this convention who is present at Columbus, Ohio, at the National Anti-Saloon Convention be authorized to represent this convention in that body.

Resolved. That we refer the whole matter to the Trustees of the Seminary, with the request that they give it careful and thorough consideration before the next meeting of the Southern Baptist Convention and take such action as in their judgment would be at once just to Dr. Whitsitt, the Seminary and the Baptist denomination.

Upon recommendation of the State Board, Mrs. D. M. Malone was appointed to this office and has entered upon its duties.

We think no better synopsis of the work can be obtained than to quote from the report rendered by Mrs. Brown to the Woman's Missionary Union, at the time of the Southern Baptist Convention, adding to that report the number of letters written and amount of literature distributed to date.

The report reads as follows:

Increased activity and interest are manifest. Lines of work recommended by the Woman's Missionary Union have been followed. Within a few years Alabama Baptists have suffered heavy losses, by fire and otherwise, to their cherished institutions—Howard College and Judson Institute. Our women have helped to rebuild, lift mortgages, etc. The under these added duties and great financial depression, our contributions to missions have not fallen off is a matter for rejoicing. With the approval of our State Board, the Central Committee now receives money contributed by societies. This arrangement gives entire satisfaction. Twenty-nine new mission societies and bands have been formed. The Weeks of Prayer and Self-denial were observed. Thirty-one boxes have been sent to the frontier. We are happy to report the return to the State of our former excellent President, Mrs. T. A. Hamilton. She has accepted the charge

of the Sunbeams, and this important branch of work, we are confident, will make good progress under her efficient leadership.

The sum quoted above does not really represent the work of the Societies, as many reports were sent in too late to be incorporated in this year's report. They will, however, swell the sum in the next financial report.

Reports of the Vice Presidents of Associations were of the deepest interest, and many hearts were inspired with desire to "do better another year" upon hearing the zeal of others.

Rev. W. J. D. Upshaw gave report for the Society at Roanoke and spoke words of encouragement.

Dr. A. J. Barton of the Foreign Mission Board appeared before the Union, and his burning words of appeal for China's millions will not soon be forgotten. The Christmas offering was specially dwelt upon. His answers to question on the subject of missions were particularly striking.

Mrs. S. A. Smith's appeal for Miss Willie Kelly, Alabama's noble missionary, resulted in increased interest for her and many pledges for her support. An interesting letter from Miss Kelly was read.

Mrs. H. L. Mellen moved that Miss KeLy's name be added to our printed circular containing objects for which Alabama women work. This motion was unanimously carried.

A telegram of greeting was received from Mrs. J. T. Mickel's for Harris Association, to which Mrs. T. A. Hamilton was requested to respond.

No more touching incident could have transpired than the singing of "Bring the little ones in to Jesus," by little Mamie Watson, one of the children of the Orphanage.

Mrs. Ansley gave, as usual, a most interesting report of the Orphanage. We only wish it might be inserted here intact. Collection for this institute amounted to \$7.50, a pledge of \$5 being given by Mrs. McCalley of Parker Memorial Church, Anniston, for her Sunbeams.

Mrs. Ward of Greensboro made a touching appeal for the Baptist Church

at that place. The presence of the widow of Mr. Hardy, who fell at his post trying to build the same, added pathos to her appeal.

## LOUISE SHORT BAPTIST WIDOWS AND ORPHANS' HOME.

Act Approved February 14, 1891, as Amended by Act Approved February 8, 1895.

Section 1. Be it enacted by the General Assembly of Alabama. That J. Norwood, J. W. Stewart, Dayton Plaster, R. Meadows, Mrs. M. L. B. Woodson, Mrs. P. L. Brooks, Geo. W. Ellis, C. W. Hare, Mrs. D. 1. Purser, Miss Annie Grace Tartt, N. D. Denson and W. G. Robertson and their successors are hereby created a body politic and corporate by the name and style of the Louis Short Baptist Widows and Orphans' Home, and by that name may sue and be sued, plead and be impleaded, in any court of law or equity; may have a common seal, and alter the same at pleasure; shall have perpetual succession; may receive, hold and use and enjoy, for the purposes hereinafter expressed, by gift, devise, purchase, or otherwise, all manner of estate, real, personal or mixed, to any amount not exceeding three hundred thousand dollars of real estate, and one hundred thousand dollars of personal or mixed property to any amount not exceeding three hundred thousand dollars of real estate, and one hundred thousand dollars of personal estate, and the same to alienate, sell, transfer, lease and convey by the order of the Board of Managers, and do all other acts and things that may be hereafter expressed in this charter not repugnant to the constitution and laws of this State, or of the United States.

Section 2. Be fit further enacted, That the object of this corporation shall be to procure the control of orphans, destitute widows, and such other children as the Board of Trustees may think proper to receive for the purpose of supporting and educating them in the Home established for that purpose in Evergreen, Conecula county, or to secure a suitable home for any such chaldren outside of salid institution when practicable.

Section 3. Be it further enacted, That the estate and concerns of sald institution shall be governed and directed by a Board of Trustees composed of nine (9) members, five (5) of whom shall reside at Evergreen, the successors of said corporation to be selected by the Baptist State Convention of Alabama; in such manner as it may deem best, and the said trustees shall elect one of their number as president, and another as secretary and treasurer of the board, each of whom shall reside in Evergreen, where said institution is located. Said trustees shall adopt such by-laws and regulations for the admission of persons into said institution, and the government and disposition of the same, as they may deem best.

Sections 4, 5, 6. Repealed.

Section 7. Be it further enacted, That said corporation shall, on the decision of the president of and secretary of the board of trustees, in accordance with its by-laws, have power to receive into its custody and control such children as may be recommended, and such widows as may

be found, in the judgment of said president and secretary, to be in such needy circumstances and of such worthy character as to justify their acceptance. Said corporation, for the purpose of protecting the person and rights of any child committed to its care, is hereby vested with all the rights and powers of a parent or natural guardian, with the right of the exclusive control and custody of said child and its property until the age of eighteen (18) if a girl, and twenty-one (21) years if a boy, unless disposed of sooner as provided by this charter. Said corporation shall also have the same power to receive and control such children as may have been abandoned by those having the right to the control and custody tereof, when such children may, in good faith, be committed to its custody and control by two reputable citizens of this State, with the approval of the probate judge or a justice of the peace of the county where such child is found.

Section 8. Be it further enacted. That the said corporation may, through its president, as may be prescribed by its by-laws, permit any suitable person to adopt any child in its custody and control as their own child upon proper covenants in writing being executed by such person and the president, and acknowledged or proven and recorded in the Court of Probate in the county where the principal interests of the Home reside, as deed may be, and said corporation may, through its president, as may be prescribed by its by-laws, bind out to any suitable person any child in its custody and control as an apprentice when such course shall be recommended by the executive committee, and may also receive of such persons other covenants, beneficial to the child, in addition to those prescribed by law; especially that such child should not be treated as a servant, the apprenticeships to terminate at the lawful age, or as soon as may be expressed in the indenture, which shall be acknowledged and recorded as prescribed in the transfer in this section.

Section 9. Be it further enacted. That the property, money, estate and rights of said corporation shall be exempt from all taxation by State or local laws for any purpose whatever.

Section 10. Be it further enacted, That the board of trustees shall have power to procure or have erected such buildings and improvements as they may deem best and to appoint and employ such officers, superintendents, agents, seachers and other persons, and to do such other things and arrange and agree with any donor according to such stipulations as may be deemed to the interest of the institution necessary and proper with the laws of this State or of the United States.

Section 11. Be it further enacted. That the board of managers may provide in the by-laws for the formation of auxiliary societies upon such terms as they think best.

Section —, (Section 5 of Act approved February 8, 1895). Be it further enacted. That the present board of trustees be and they are hereby continued in office until their successors are elected by the next Baptist State Convention, and that all the acts of said corporation heretofore performed under said original charter are hereby ratkied and confirmed,

## CONSTITUTION.

Article 1. This body shall be known as "The Alabama Baptist State Convention," and shall consist: (1) of three delegates from each Baptist District Association in Alabama, co-operating with this convention, if said Association shall have five hundred members, or under and one additional delegate for every five hundred members, or fraction thereof. above that number, whose annual election or appointment shall be duly certified by the printed minutes, or certificate of an officer of the Association represented by them; (2) of one delegate from each church, co-operating with this Convention, (f said church shall have fifty members, or under, and one additional delegate for every fifty members, or fraction thereof, above that number; (3) of persons who contribute funds, or are representatives of churches contributing funds for the regular work of this Convention, on the basis of one representative for each one hundred dollars actually paid into the treasury of the Boards of this Convention during the fiscal year preceding its assembling. But in all cases must delegates to this body be brethren of Baptist Churches in good standing.

Article II. The officers of the Convention shall be a President, First and Second Vice Presidents, a Recording Secretary and a Trensurer, together with a Board of Directors, as hereinafter named, who shall be elected at each annual meeting, and who shall hold their offices until their successors are elected.

Article III. The President, or in case of his absence, one of the Vice Presidents, En their order, shall preside at all the deliberations of the Convention, and discharge the duties usually imposed upon an executive officer of deliberate bodies.

Article IV. The Secretary shall make a fair record of the proceedings of the Convention, and soon after the rising of each regular meeting of the body, shall attend to the printing and distribution of the minutes of the same, of which he shall preserve a file, which file shall constitute the authentic record of the Convention. He shall also conduct the correspondence of the body. For his services he may receive a reasonable compensation. The printing of the minutes of the Convention, and the compensation of the Secretary, shall be paid for by pro rata taken from the funds sent for the various objects forstered by this body each year.

Article V. The Treasurer shall take charge of the funds of the Convention, and hold the same, subject to the order of this body, or of the Board of Directors, during the recess of the Convention; and he shall make an annual report of all receipts and expenditures, which shall be audited and published with the minutes.

Article VI. The President, Vice Presidents, Secretary and Treasurer, with nine other brethren, shall compose the Board of Directors, five of

whom shall form a quorum authorized to transact any business of the Convention during the recess thereof, and shall report their proceedings at each annual meeting of the Convention.

Article VII. The President shall have power to call a meeting of the Board of Directors whenever the exigency of the circumstances may, in his judgment, require the same.

Article VIII. The design of this Convention shall be to effect, combine and direct the energies of the Baptists of Alabama in one sacred effort to encourage and promote, (1) the propagation of the gospel in this State, and, through the Southern Baptist Convention, in the destitute parts of the world; (2) the education of those it believes called of God to the ministry; (3) the education of the youth of our country; (4) the publication and distribution of the Word of God and other literature; (5) the organization and usefulness of Sunday Schools and other religious and educational movements it may deem promotive of the interests of the kingdom of Christ and sanctioned by the Word of God.

Article IX. The Convention shall have the supreme control of any Literary or Theological Institution, which has been, or may bereafter be, originated in this body; and it shall choose for such institution a Board of twenty-four Trustees, to serve for six years, of whom one-third shall go out of office biennially; and the said Trustees shall, on all occasions, be subject to the control of the Convention, and make an annual report to this body on the state of such institution.

Article X. The Convention may receive funds from all such as may be disposed to aid in any of the benevolent purposes mentioned in the 8th Article, and it shall faithfully apply funds contributed to the objects which may be designated by the donors, a portion, however, being taken pro-rata from the same for contingent expenses, in the event of the insufficiency of the general fund for that purpose.

Article XI. The Convention may employ agents, whose duty it shall be to make collections, obtain—subscriptions from Societies, solicit churches and associations to unite with the Convention, and to further all objects of this body.

Article XII. The Convention shall have power to send delegates to the Southern Baptist Convention, and to any other assembly with which, in its wisdom, it may wish to communicate.

Article XIII. The Convention shall hold its meetings at such time and place as it shall, from time to time, appoint,

Article XIV. The funds of the Convention shall consist of voluntary contributions or donations and not otherwise.

Article XV. The convention disclaims all right of exercising authority over any church or association, hereby acknowledging that every church is independent, and within its own sphere, is accountable to no body of men on earth.

Article XVI. This Constitution may be altered or amended by the concurrence of three-fourths of the members present at any annual meeting, but not so as to infringe the 15th Article.

Article XVII. All amendments or alterations of this Constitution shall be proposed at one session and acted upon at the next.

Instead of prescribing distinct Rules of Order, "Mell's Parliamentary Practice," so far as applicable, has been adopted by the Convention.
