FALL is coming a little late this year. Not the season, of course; it's come and gone. The fall issue of THE ALUMNAE NEWS is the subject.

In the morning's mail came a question: "Dear Barbara,—Am I on a blacklist or has THE ALUMNAE NEWS stopped publishing a quarterly issue?" The answer to both parts of the question is "NO." None of you who are Alumnae Fund contributors (and the card-writer is included) are on a blacklist; it's the editor of THE NEWS who's on the blacklist. THE NEWS continues to publish four magazines a year; the current problem is that the editor can't get them sandwiched into the designated months within the calendar quarters. To cover-up this inability, somewhat, the stated intervals of publication have been changed to seasonal designations. Somehow it seems less embarrassing to print "Fall" in February rather than "October."

Whether the editor will be able to publish the proper magazine during the proper season—after this one—remains to be seen. She will try, though.

- This issue marks the beginning of the fiftieth year of this publication. How better to take cognizance of this fact, important to the College and all of us alumnae, than to look back at Vol. 1—No. 1 . . . at its editorial, its contents, its editor, its advertisers? You who knew Miss Dameron and we who have come to the College since her leaving and since her death—all of us are indebted to her. Our tribute is small compared to our debt. But, by looking back at the four issues of Vol. 1, as we will do during the remainder of this Vol. 50 year, we pay our humble and grateful respects to "our beginning and our beginners."

- Those of us who have been students at the College during the latter part of these fifty years of publication, perhaps, need a few "program notes" on the contents of Vol. 1—No. 1.

Dr. W. C. Smith, who wrote the poem "Alma Mater to the Absent," was for many years head of the English department.

To identify roughly the places on today's campus which the alumna, Class of 1895, saw in 1912: Mrs. McIver's house stood on the now-vacant-lot beside the Alumnae House, which is standing about where Midway stood. The "old infirmary" eventually came to be "Little Guilford;" it was razed to make way for today's Soda Shop. The Administration Building was and remains the same. The McIver Memorial Building, new in 1912, was torn down, hauled away, and replaced on the same spot by today's new McIver Building.

OUR CAMPUS

"A fairy godmother must have wrought this wonder," is the comment of an alumna of 1895 as she leaves the street car at College Avenue. She has not seen her Alma Mater since she was graduated fifteen years ago, and though she has read of the growth of the college and told herself again and again that she will see many changes, she is not prepared for the extensiveness of the grounds and buildings—for the wonderful development of the college.

Instead of the ordinary road of her college days, she sees, extending to the north, a broad avenue, guarded at its entrance by two massive granite pillars, the gift of the class of 1908. Along the western side of the avenue is a cement walk especially desirable in wet weather, while along the eastern edge a crushed granite walk tempts one if the weather is fair.

The visitor, on looking to her left, sees Mrs. McIver's residence, Guilford Hall, formerly Midway, and the old infirmary. . . . On looking to her right she beholds a beautiful lawn covered with grass and trees in the place of the unkempt, swampy campus that used to extend along Spring Garden Street in front of the Administration Building. This building remains the same except that granite steps have replaced the wooden ones . . .

With eagerness and yet with hesitancy, the alumna lets her eyes pass beyond the Administration Building to the location of the old dormitory—her college home. More forcibly than heretofore she realizes the destruction wrought by the fire of 1904. The

dormitory is gone. In its stead she sees a massive four-story brick building . . . known as the McIver Memorial Building. . . .

. . . the visitor, being told by the student (who kindly offered to show her over the grounds) of the many changes . . . , passes down the avenue . . . Just beyond the old infirmary she sees, back on the hill in front of the Watson House, instead of the turnip patch, a large, beautiful brick building which faces College Avenue—the new infirmary. Before the student has time to tell of the comforts of the new infirmary, the visitor has reached another building standing where the college barn was located fifteen years ago. She learns that this is the Students' Building—a building which she has long wished to see, since she and nearly every other alumna helped, even if in a small way, to erect this building On either side of the granite steps which lead into this building are lights, the gift of the class of 1910. "These lights are not only beautiful, but also most useful," says the student, "for this building is used for prayer meetings, society meetings, and all public entertainments, and its entrance was insufficiently lighted till 1910."

On turning round from the Students' Building, the visitor sees, across the avenue, where the strawberry patch used to be, the Library. . . . Back of the Library stretches a grass covered lawn, where the green house used to be with the college bell at its rear. . . . Looking on towards town, the visitor sees the laundry and the heating plant in the corner of the campus, behind the McIver Building.

Hastening on, these two pass over Walker Avenue by means of an iron bridge, for Walker Avenue has been graded until it is thirteen feet below the campus. Just beyond the bridge, on the eastern side of College Avenue, facing Walker Avenue, is situated the training school, known as the Curry Building Across College Avenue from the Curry Building is the Spencer dormitory—a two-story brick building which extends five hundred feet down the avenue. More than three hundred girls live in this dormitory, and the dining hall and the kitchen for the entire college are situated in it.

Near the northern end of College Avenue . . . are four class tennis courts. At the northern extremity of the avenue our State flag, during fair weather, floats in the breeze and cheers the hearts of all who behold it. Near the flag pole, on the western side of the avenue, stands an inviting-looking, dark green summer house, the gift of the Class of 1909. Farther over to the west among the trees may be seen the top of the barn where forty or more cows are kept.

At this point the visitor reluctantly retraces her steps towards the car line. As she rapidly glances over the entire grounds, her first conclusion is that the Normal School of the early nineties has developed into a college,—that Dr. McIver's dream of a great future for the school is being realized.

A TOAST

The societies initiated their new member at the usual time last fall, and each society gave a delightful banquet after the initiation exercises. All the toasts were good, and we wish we might reproduce them for the absent Adelprians and Cornelians, but that is impossible. It, however, gives us great pleasure to print the following toast delivered at the Adelprian banquet by Miss Mendenhall, who is known and loved by Cornelian and Adelprian alike, of 1892 or of 1912.

"I presume that the Adelprians have asked me to represent their faculty tonight out of deference to my age, of which since Founder's Day, I have felt painfully conscious. Let me warn you, though the warning is a tardy one, that the garrulity of old age is sometimes to be dreaded, and tonight this is coupled with a Quaker heritage; so none of you can tell what I feel moved to say before I get through with this toast! I have you at my mercy for once by your own invitation!

"However, there is just one message which I wish to leave with you, and I am sure that in giving it I can speak for all your faculty whatever their faith.

"It is the sincere and earnest wish that both of these literary societies—the Adelprian and the Cornelian—may stand firm in this college for real scholarship and real culture. If this college is to stand for real scholarship and real culture, you must do your part toward this end. The faculty—however fine we may think ourselves—cannot succeed in this without the earnest co-operation of the students. You must make us give you our very best. Make us give you real college training. . . . if you do not get the best from us it is your own fault. If we are to be a genuine college, we must be held close together—one brotherhood—students and faculty, devoting ourselves to scholarship, scholarship which is real and genuine, not the superficial variety, which has been thought, and which some still think, sufficient for the feminine mind.

"A genuine college, whether it be that of Agassiz on the Isle of Penikese of which Whittier writes so beautifully, or whether, as President Garfield, I think it was, once said, it be a log with a Mark Hopkins on one end of it and some boy on the other—whatever or wherever the college, if it be worthy of the name, it is a place where stress is laid on duty and service rather than on right and prerogatives, and where search for truth is rewarded by knowledge of the truth which shall make us all free."

COLLEGE NEWS

(Random items) Dr. J. I. Foust has recently met with the committee who accepted the statue of Dr. McIver which has just been completed in Paris by Mr. Ruckstuhl. This

tatue has been placed in the capitol square at Raleigh, where it will be unveiled sometime this spring. A replica, which is now being made for the college, will be unveiled during our next commencement.

The commencement of 1912 will be one of unusual interest, not only because of the unveiling of Dr. McIver's statue, but also because of the May Day Fete which will be given under the direction of Mrs. Sharpe, by the Senior class, assisted by the entire student body.

Miss Kirkland still presides over the social life of the students with her unequalled grace and dignity.

The faculty class committees have been abolished, and the dean Mr. Smith, and the registrar Miss Mary Taylor Moore, attend to the classification of the students and the arrangement of their programs. In addition to the regular work of a registrar, Miss Moore was under her supervision the stationery room, the express, and the mail. The college has a new postoffice of three hundred lock boxes, where the old chemistry laboratory used to be, in the basement of the Administration Building.

FOUNDER'S DAY

On the 5th of October, 1911, the twentieth anniversary of the founding of our college, all class work was suspended, and faculty and students assembled in the auditorium at eleven o'clock to celebrate the establishment of the college and to honor the name of Dr. Charles D. McIver. Seated behind the speaker of the day, Mr. Clarence E. Poe, were the five charter members of the faculty, Misses Kirkland, Boddie, Mendenhall, Fort and Mr. Forney, and nineteen alumnae who represented the classes that have been graduated.

After the usual introductory exercises of song and prayer, Mr. Poe delivered an able address in which he made an appeal for the continuation of the great work begun by Dr. McIver. . . . Every girl who has matriculated in this college is in honor bound to do her part in the educational crusade, otherwise she is unworthy to be an heir of Dr. McIver's fame.

Dr. Foust then read telegrams of greetings from other colleges, from most of the county associations of alumnae and from many individual alumnae. The alumnae have decided to make Founder's Day gift day, and so Dr. Foust had the pleasure of announcing many small gifts, aggregating about two hundred dollars—for the McIver Loan Fund. . . .

At the close of these exercises, the speaker, the charter members of the faculty and the representative alumnae were invited to the dining room (for lunch) . . . The large rectangular table that seated about forty, was beautifully decorated with goldenrod and maidenhair fern. . . .

In the evening of the same day the students and the faculty reassembled to hear greetings from the classes. . . . After the alumnae had spoken, Miss Leah Boddie, president of the class of 1912, brought a message from her class. . . .

ALUMNAE NOTES

CLIPPINGS FROM THE CLASS OF 1893

During the nineteen years that have passed since our happy days together here, varied interests, conscientious study, hard work, great responsibility, travel in foreign lands, deep sorrow, and supreme joy have wrought in us changes that none could have foreseen. But in our loyalty to one another and to our Alma Mater there is no change. We are still *ten*, although dear Maggie Burke passed long since from mortal sight. Our faith is "the faith of our fathers, living still," and our guiding star of hope is our class motto: "The truth shall make you free."

Some of us are mistresses of our own homes . . . (and there follows a section of News Notes which are not very different from the ones which are included in Vol. 50—No. 1 of the ALUMNAE NEWS.)

FORMER FACULTY

(Random items) Mrs. Henryanna Hackney-White, after teaching in the department of mathematics for several years, married Mr. David White. She lives in Greensboro and frequently entertains members of the faculty in her hospitable home. Thus the college has not lost her so completely as it has Mrs. Nellie Bond-Askew and Mrs. Oeland Barnett-Wray. Nellie Bond, after teaching nine years in the English department, was married to Mr. E. S. Askew, in 1909, and lives in McBee, S. C. Oeland Barnett, by whom many of the alumnae were drilled in the conjugation of the Latin verb, is now the wife of Mr. J. S. Wray, Superintendent of the Gastonia schools. She has a daughter, Carolyn, about a year old, whom she finds much more interesting than Latin verbs.

The college is proud of the fact that one former member of its faculty, Dr. P. P. Claxton, is United States Commissioner of Education; that another member, Dr. J. Y. Joyner, is State Superintendent of Public Instruction; and that a third member, Dr. E. A. Alderman, is president of the University of Virginia. The entire State looks with just pride at the records that these men have made, at the work that they are now accomplishing, and at the position they hold in the educational world.

MISS JULIA DAMERON was "a power in the educational progress of North Carolina. Her activities (were) exerted through contact with about two thousand girls at the State College for Women at Greensboro, through the *Alumnae News* of (the) College of which she was editor for sometime, through the North Carolina Education Association which she was active in forming and through her personal appeals to members of the North Carolina Legislature."

She entered the State Normal and Industrial College in 1895. "In college days her scholastic attainments as well as her participation in campus activities made her an outstanding student. The ability to analyze a situation before forming a judgment or making a decision added weight to her espousal of a cause. Her frank outspoken expression of opinion won the confidence of her associates who were never left in doubt as to her position. She gave to whatever work she undertook her wholehearted effort." She was graduated in 1898, and she was one of six chosen from her class by the faculty to read her senior essay at Commencement. (This was a coveted honor and a tribute to her literary ability.) She probably was the first woman in Warren County to hold a real college degree.

Her first teaching was done in small communities. In 1901 she was recalled to the College as an instructor, and with the exception of three years spent in study, she was connected with the College as teacher of Latin and English until 1918. She received her bachelor of arts degree from the University of North Carolina in 1908, and in 1913 Columbia University conferred upon her a master's degree. "As a teacher she exerted a far-reaching influence. Thorough equipment, ability to impart information, impartial treatment of students, patient, kindly interest in their problems, gained for her their love and respect. Thousands of women of the earlier college days bless the name of Julia Dameron for her patient, painstaking accuracy in teaching both English and Latin."

In 1911 the *Alumnae News* of the College was established. She was the only editor at first, but following her return from Columbia University, she was named editor-in-chief. "All the strength and time which she did not need for classroom work was given to the *Alumnae News* and for alumnae work."

Miss Dameron's greatest single achievement was in behalf of equal pay for women when they do equal work. She began her public efforts in behalf of Equal Pay for Equal Service about 1917 in the *Alumnae News*. The Alumnae Association unanimously and enthusiastically endorsed her plans for better schools and higher salaries with equal pay for equal work. Her efforts before the

House Education Committee of the General Assembly resulted in the abolishment of the discrimination against women in the matter of salaries.

"When she left the college to be at home because of her mother's advancing age, she became very active in the civic life of Warrenton; she was the champion of many worthy causes. She organized the Woman's Club of the town and was its president for many years, being instrumental in securing the beginnings of a public library for Warren County, and also for the regular employment of a county public health nurse. In 1919 she began to serve on the school board and was its secretary for many years. In this capacity she worked hard for the passing of a bond issue to erect a new school building. The building was completed in 1923. She organized the Parent-Teacher Association of Warrenton and served as first chairman of the program committee, refusing the presidency so that a parent might have the honor.

"A proof of another kind of ability lies in the profitable business she built up for herself without leaving her own home, devoting her efficiency and strength to the production of commodities which were always of the highest quality. This business she conducted on lines of scrupulous fairness and honesty." She developed a White Leghorn poultry farm (a 1600 egg incubator at one time), and she grew fruit for market. At one time, too, she and her sister represented the Jefferson Standard Life Insurance Company in Warrenton, under the name of Dameron and Dameron.

Miss Dameron died on January 21, 1944. Throughout her life she was "modest in her estimate of her own attainments, but firm in her convictions of right and she kept before herself and others the highest ideals of conduct. Her loyalty to friends and causes was never shaken, once she decided they were worthy of her support. Her generosity extended not only to the giving of her substance but in her judgment of people's motives and behavior. Having a high sense of personal honor, she expected this in others and showed it by her confidence in them. She was a staunch supporter of great causes but the personal problems of a friend, or even acquaintance, were met with the same eager interest. The brightness and sweetness of her outlook on life rounded out the 'wholeness' of her character to make her a most lovable, trustworthy, and helpful person."

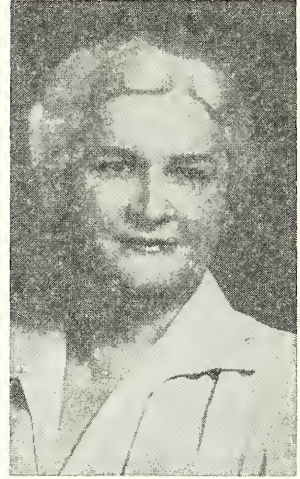

Annie Kizer Bost '03

Annie Kizer Bost died in Raleigh on 6 September 1961.

Her life had been one of continuous service. Her pioneering spirit had inspired colleagues, younger workers, and community leaders. Her record of service to North Carolina had spanned more than seven decades. Her daily life had reflected the strength, vitality, simplicity, and faith which are synonymous with the traditions of the State and the people she loved. The impact of her selfless devotion to social work and state and civic causes made her "one of North Carolina's most distinguished daughters."

She was one of the first women to hold a top position in state government in North Carolina.

Mrs. Bost was twice an alumna of the Woman's College. She was graduated in 1903, and in 1942 she was awarded the honorary degree of Doctor of Laws by the College. She was an alumna of the New York School of Social Work, too. At that institution she furthered her professional training.

After she was graduated from the Woman's College, she taught school in her native Salisbury. In 1912 she married Mr. W. T. (Tom) Bost, and they lived in Durham for three years before they moved to Raleigh, a move which became permanent for the remainder of their lives. Mr. Bost, who died some ten years ago, was a newspaperman and for many years was considered "the dean of North Carolina journalists."

For thirty-seven years he headed the *Greensboro Daily News'* Raleigh Bureau. Mr. and Mrs. Bost had two sons: Tom, Jr., now of Chapel Hill, and John, who lives in Winston-Salem.

Governor O. Max Gardner appointed Mrs. Bost as Commissioner of Public Welfare in 1930. She retained this position until her retirement fourteen years later. The late Governor J. Melville Broughton once said that "four governors served under her administration." At the time of her appointment it was said of her: "Not only is she one of the best known women in North Carolina, especially among those women who are interested in following the progress and development of the state, but she is one of the best-loved as well, because of her wealth of interest in people of all classes and conditions and her constant and untiring efforts to make North Carolina a better place in which to live. . . . And while always determined and with the courage of her convictions, she has always preserved a breadth of mind and a tolerance in her attitude that have won the admiration of all, even of those who disagreed with her. There is nothing of the typical woman crusader or politician about her that likes to strut and assert authority. In fact, she is almost the opposite type — much more the mother and housewife which she really is, but one with a vast amount of common sense and judgment, intensely interested in the welfare of everyone in the state of North Carolina. . . ."

Mrs. Bost stood at the helm of the public welfare program during two crucial periods: the depression years of the early thirties and the first years of World War II. Many relief expenditures were channeled through public welfare offices, and when the Emergency Relief Administration was liquidated, the State Board of Charities and Public Welfare became the State social service agency charged with certifying applicants for the programs of the Works Progress Administration, the Resettlement Administration, the Civilian Conservation Corps, the National Youth Administration, and other federal agencies. During World War II, she was a member of the State Council for Civilian Defense and was responsible for the coordination of local public welfare forces with other local groups for concerted action in the event of a national emergency.

During the years of Mrs. Bost's administration, the Social Security Act was passed, resulting in a State program of expanded child welfare service and in the creation of a division of public assistance. In order to administer a constantly increasing program of services, the staff of the State Board of Public Welfare was greatly increased and new organizational units of services were set up.

Upon her retirement, Governor Broughton appointed her to the State Unemployment Compensation Commission, now known as the Employment Security Commission, on which she served for five years.

In 1930 Mrs. Bost helped found the American Public Welfare Association. She was president of the North Carolina Conference for Social Service in 1937-38.

Governor Angus McLean appointed Mrs. Bost to the Board of Trustees of the North Carolina College for Women in 1926. She served as a member of the Alumnae Board of Trustees from 1950 until 1952.

At one time Mrs. Bost was executive secretary of the North Carolina Federation of Women's Clubs. A past president of the Raleigh Woman's Club, she edited the *North Carolina Clubwoman* from 1952 to 1955. For many years she was a member of the Olivia Raney Library Board of Trustees in Raleigh. Continuously active in the work of the State Legislative Council which presents legislative proposals to the General Assembly, she was a long-time member of the Council's executive board. For many years she was an active member of the State League of Women Voters. In 1956 she served as State Chairman for the North Carolina Tuberculosis Seal Sale. She was an honorary member of the North Carolina Delta Kappa Gamma Society and of the Raleigh Altrusa Club. She was a charter member of Holy Trinity Lutheran Church in Raleigh.

Many were the editorial comments across the State following her death. Among them, the *Sanford Herald*, after lauding her contribution to the State, wrote: "Attractive and feminine in appearance, Mrs. Bost brought to her position none of the preconceived impressions that often hamper the professional caseworker. She knew her State and its people and had a genuine interest in their welfare. A background of culture, personal acquaintance with a wide variety of persons in many stations of life, and years of dealing with organized groups were handy aids in efforts to improve the lot of the underprivileged.

"Annie Kizer Bost was an able official but she was more. She was a woman whose contributions to her family, her church, and the community are deeply engraved across 45 years of Raleigh residence."

And the *Greensboro Daily News* wrote: "A good mind, a beautiful person, and a beautiful personality seldom merged so agreeably as in Mrs. Annie Kizer Bost . . .

". . . she was known and revered as an administrator of ability and a State official who added luster to the Raleigh bureaucracy.

"But those who knew Annie Kizer Bost remember her for the loveliness of her character. A strikingly handsome woman in appearance, she reflected the same qualities in her personality. She was a person of charm, but she was also a person devoted to duty.

"It is fitting that the University of North Carolina recently established an Annie Kizer Bost scholarship in its school of social science, for that was the field of her primary interest. But the universal qualities of goodness and beauty which enhanced her life will, we trust, always be honored by our society."

Mrs. Bost was at the Woman's College for the last time at Commencement in 1957. (Shortly afterward she suffered a stroke from which she never fully recovered.) In 1957 she was president of the Old Guard, and she was here for that group's reunion. Her successor as Commissioner of Public Welfare, Dr. Ellen Winston, was invited to speak at the Commencement Meeting of the Alumnae Association that year. Emily Preyer, who was president of the Alumnae Association, asked Mrs. Bost to introduce Dr. Winston. Emily of course, introduced Mrs. Bost. Long afterward Mrs. Bost remembered, with characteristic modesty and gratitude, Emily's words: "There is not a person in this hall who does not know who Annie Kizer Bost, Class of 1903, President of the Old Guard, is. Mrs. William Thomas Bost is one of the best known women in North Carolina because of her many accomplishments in the Federation of Women's Clubs and in the League of Women Voters and as former Commissioner of Public Welfare of our State.

"At all times she followed the progress and development of the Old North State and has contributed in so many ways to its great growth. She is not only one of the best known but one of the most loved women in our State, because of her wealth of interest in people of all classes and conditions and because of her great constant and untiring efforts to make North Carolina a better place in which to live.

"Woman's College was proud to award Annie Bost an Honorary Doctor of Laws Degree in 1942. This honorary degree comes to those who have proved their worth to mankind by outstanding contributions in some field. Mrs. Bost supplied backbone and vision in the period of expansion and development of the Social Security program within the State, which culminated in county welfare units in every county.

"All of us see in Annie a sparkle and warm geniality that reveal brilliance and an endless vitality.

"Mrs. Bost's life is not all work and no play. She has many hobbies, but I hear she is an avid duplicate bridge enthusiast. She loves to relax with a tricky North-South little slam, doubled and vulnerable.

"The nicest compliment we could pay our guest speaker today is to call on Dr. Annie Kizer Bost to introduce her."



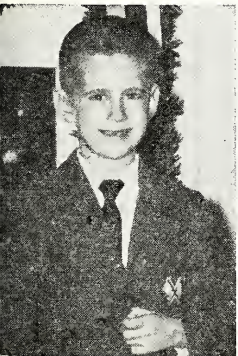

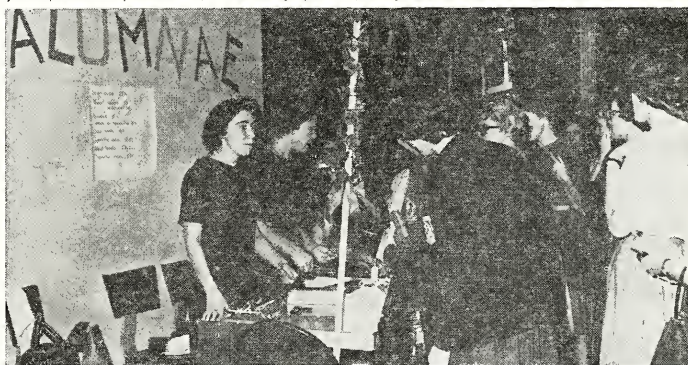

"The other sisters stay here (Sacred Heart Academy at Belmont) and pray, and I go gallivanting," said Sister Mary Michelle (*Jumela Boulus '47*) in a feature story in the *Charlotte Observer* last March. The sisters' prayers and Sister Michelle's travel were combined in behalf of a new convent at Sacred Heart and a man named Danny Thomas. "The next thing we knew was when we read in the paper that Sister Incarnata was giving an organ recital. So she played softly while we filibustered our way through the reception." When offered a chance to plug the show on television, Sister Michelle "went on," and she even took along the Mother Superior, who had no idea she would be on. Sister Michelle rejected any personal credit for promoting the benefit show: "even though the other sisters haven't been in the limelight, they've done as much as I. They've prayed secretly and silently for the program." . . . In an accompanying feature article Sister Michelle described life in the convent, a life which she has been living for twelve years. Besides a deep dedication, she says, a nun needs "an average intelligence, average ability and an above-average sense of humor. It takes that to live a life of religion." In addition to teaching mathematics, Sister Michelle includes in her day, which begins at 5:00 a.m. and rarely ends before 10:00 p.m., prayer and meditation, meal planning and food purchasing for more than 250 daily, study and recreation, and duty in the academy's residence hall.

Opportunities for CONTINUING your EDUCATION

Summer School. The 1962 Summer School announcement and bulletin have been released. Courses planned for graduates who wish to add credits to their degree programs and to meet certification requirements for teaching will be offered. (The six hours of renewal credit required by the North Carolina State Board of Education may be secured in the six weeks summer program.)

Students may take courses in these fields of education: elementary, secondary, guidance, special education, speech correction, phonetics, library education, and audio-visual education. The curricula offered during the summer are identical with those of the fall and spring semester during the regular college session.

AAUW Foundation. A program of graduate study through which mature college women may qualify themselves for teaching, research, or administration in higher education was announced on November 30 by the American Association of University Women Educational Foundation. Financed by a \$225,000 grant from the Rockefeller Brothers Fund, this nationally significant program will be initiated over a three-year period in eleven southern states: Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North and South Carolinas, Tennessee, Texas, and Virginia.

Designed to add fully-qualified women to the nation's resources of college faculty, the program will not only help to relieve the acute shortage of trained college personnel, but will provide unusual opportunity for the mature woman to embark on a professional career in higher education. *Some of the "students" accepted for the demonstration will be wives and mothers whose family responsibilities are lessened as their children reach high school or college age. Others will be women whose plans for a professional career have had to be deferred for financial or other reasons.*

Approximately fifty candidates, thirty-five years of age or older, who hold the bachelor's or master's degree, will be selected each year for further education in one of the cooperating graduate schools. Universities which have already expressed interest in the plan include Auburn, Duke, Emory, Louisiana State, Tulane, Vanderbilt, Florida, Kentucky, North Carolina, Tennessee, and Virginia.

Grants-in-aid for tuition and necessary expenses will be awarded on the basis of need to those candidates who live within commuting distance of the universities they attend.

The first group under the program will enroll in September 1962. Applications should be made not later than April 15, 1962. Inquiries should be addressed to Dr. Eleanor F. Dolan, AAUW Educational Foundation, 2401 Virginia Avenue, N.W., Washington 7, D. C.

British and Austrian Offerings. Four British and two Austrian summer schools are offering American students the opportunity to combine 1962 vacation travel abroad with six weeks of liberal arts study next July and August. Applications for study at all six summer schools are now being accepted by the Institute of International Education.

Under the British University Summer Schools program, students may apply for study at one of four schools, each concentrating on a particular subject and period: Stratford-upon-Avon (Shakespeare and Elizabethan drama), University of London (English Literature, art and music of the 20th century), Oxford (history, literature and the arts of 17th century England), and Edinburgh School (British history, philosophy and literature from 1688 to 1832). The British Summer School fee, including full room, board and tuition, is \$254. A few scholarships, covering part or all of the fee but not travel, are available.

Both Austrian summer schools include in their programs the opportunity to attend performances at Salzburg's famed music festival. The Salzburg Summer School, sponsored by the Anstra-American Society, emphasizes German language study, but courses in art and music and on foreign policy are taught in English. The fee for the entire program is \$245. Applicants must be between the ages of 18 and 40, and must have completed at least one year of college work. A few full scholarships are available.

The University of Vienna, offering summer courses at its St. Wolfgang Campus near Salzburg, combines study with outdoor life at a mountain lake. Its aim is to enable English-speaking students to become acquainted with Austrian education and social values. The fee for the full six-week program is \$335, and a few scholarships covering partial or full fees are available.

Applications for both the British and Austrian programs may be obtained from the Information and Counseling Division, the Institute of International Education, 800 Second Avenue, New York 17, N. Y. British Summer School scholarship applications must be received before March 1, and admission applications before March 31. Scholarship applications for Austrian schools must be returned by March 1, and admission applications by May 1.

The "new Infirmary" of 1912 is now the infirmary, used in part this year for the time in several years for graduate housing. Students' Building is no more; it stood as College Avenue from today's Forney Building which used to be the Library. The television studios are housed in the old Laundry. Of course, today Walker Avenue does not border the campus as it did in 1912; there is a bridge. Today's Library and School of Home Economics straddle the area which was Walker Avenue. The Science Building stands in the area where the first Curry Building stood. Though the summer house is gone and the tennis courts have been relocated, Spencer stretches along the Avenue just as it did in 1912. The barn and the forty cows have since been replaced by the quadrangle area and the athletic fields on beyond. The alumna Class of 1895, was amazed at the changes which fifteen years had wrought. What would she think of "Dr. McIver's College" today, fifty years after the 1912 visit?

Societies "toasted" by Miss Mendenhall with time grew to four, and in time, out of their purposefulness. They were discontinued after 1953.
