WARRANT

Article No. 4 is requesting authority to purchase a new school bus. The present bus was purchased in 1965 and been run over 60,000 miles. This summer, 1971, repairs are estimated at a minimum of \$2,500.00 A few of the necessary repairs, known at this time, are new king pins on the front end, all new brake linings, 6 new tires, 2 new fenders due to rusting, repairs to cab and emergency door due to rusting, replacement of clutch disc, pressure plate and fly wheel, it is using 2 quarts of oil every 500 miles and the power steering has to be adjusted frequently. The estimated cost of a new bus will be \$7,500.00. The \$3,240.43 in the Bus Capital Reserve Fund will reduce the amount to be raised by taxation to \$4,259.57 and an anticipated balance of \$2,000.00 may also be used to reduce this amount.

Your School Board feels that if the bus is kept for another year that the expenses may be very high.
