# In Memoriam

#### JERE LEWIS SMITH 1879 - 1944

His trust was in God and therefore he could at all times say with the poet Whittier:

> And as beside the Silent Sea I wait the muffled oar No harm from Him can come to me On ocean or on shore.

> I know not where his islands lift Their fronded palms in air, I only know I cannot drift Beyond his love and care.

#### TOWN WARRANT

#### STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Seabrook qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall on Tuesday the Fourteenth day of March next, at ten of the clock in the forenoon to act upon the following subjects:

Article 1. To elect by Australian Ballot a Town Clerk-Tax Collector (in compliance with Article 15 of the Town Warrant dated Feb. 10, 1949), one Selectman, Assessor and Trustee of the Trust Funds for a term of three years, Town Treasurer, Three Constables, a Chief of Police and all other Town Officials for the year ensuing.

Article 2. To hear the report of the Budget Committee and act thereon.

Article 3. To see what sums of money the town will vote to raise for the expense of the General Government, for the Protection of Persons and Property, for Health and Sanitation, for Highways and Bridges, for the Support of the Town Poor and all other necessary expenditures for the year ensuing.

Article 4. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes and to renew and refund Town Notes.

Article 5. To see if the Town will vote to allow a discount on Taxes.

Article 6. To see what sums of money the Town will vote to raise to defray the expense of collecting garbage

and rubbish throughout the Town, the contract to be awarded by the Selectmen. Approved

Article 7. To see if the Town will vote to raise and appropriate for advancement of the Town through publicity and promotional services of the Seacoast Development Association in cooperation with other regional committees, a sum not exceeding one one-hundredth of one percent of assessed valuation, namely \$180.00.

Approved

Article 8. To see if the Town will vote to raise the sum of \$50.00 to defray the expense of lighting the World War II Soldiers Memorial at Smithtown Square, for the ensuing year. Approved

Article 9. To see if the Town will vote to raise the sum of \$222.41, the State to contribute \$887.07 for Town Road Aid. Approved

Article 10. Upon petition of James F. McIntosh and forty-four others. To see if the Town will vote to continue the program for better lighting facilities on Seabrook Beach — To install and maintain 19 electric lights and appropriate \$760.00 for the same. Approved

Article 11. Upon petition of Hollis I. Brown and 20 others. To see what action the Town will take in regard to building a Police Station, and to raise and appropriate the sum of five thousand (\$5,000.00) Dollars for the building and five hundred (\$500.00) Dollars for a building lot, the same to be left in the hands of the Selectmen and the Chief of Police, the building to be completed before the Annual Town Meeting in 1951.

Article 12. Upon petition of Joseph E. Bartley and 18 others. To see if the Town will vote to raise and appropriate the sum of Eight Hundred (\$800.00) Dollars to gravel and tarvia the Black Snake Road, so called, beginning at the town line near the residence of Dominic Bartley and extending to True's Corner a distance of four tenths of a mile. Approved

Article 13. Upon petition of Frank G. Randall and 19 others. To see if the Town will vote to raise and appropriate the sum of Seven Hundred (\$700.00) Dollars for the Raymond E. Walton Post No. 70 American Legion, to be used toward the expense of providing and equipping a home for the American Legion in Seabrook. Approved

Article 14. Upon petition of Herbert R. Brown and 33 others. To see if the Town will vote to raise and appropriate the sum of Five Hundred (\$500.00) Dollars to be spent for improvement of the Baseball Field at Veterans Memorial Park, the same to be spent by the Seabrook Athletic Association. Approved

Article 15. Upon petition of Ernest W. Sargent and 54 others. To see what action the Town will take in regard to building a dam at Cane's Brook so called, for a skating pond and to raise and appropriate Four hundred (\$400.00) Dollars for the same. Approved

Article 16. Upon petition of Harold W. Hewlett and 36 others. To see if the Town will vote to rescind the action of the Town Meeting of 1935 by which the Town adopted the provisions of Chapter 9 of the Session Laws of 1934 known as the Municipal Budget Act.

Article 17. Upon petition of Roger L. Cole and 12 others. To see if the Town will vote to print a list of the 1949 and 1950 valuations and distribute the copies to the residents of Seabrook before September 1, 1950.

Article 18. Upon petition of Robie M. Beckman and 14 others. To see if the Town will vote to establish the number of members at large of the Budget Committee under the Municipal Budget Act adopted in 1935 at three, six, nine or twelve and provide for the selection of such numbers by election or appointment.

Article 19. Upon petition of William H. Durkee and 10 others. To see if the Town will vote to have the Selectmen issue individual vouchers or checks to the person who may be entitled to the same for all departments of the Town that come under their jurisdiction.

Article 20. Upon petition of James W. L. Brown and 10 others. To see if the Town will vote to adopt Chapter 175 of the revised laws pertaining to a Board of Fire Wards or Engineers to be appointed one for each 5, 4, 3, 2 and 1 years, each subsequent year to elect one member for five years and to fill any vacancy for the remaining term.

Article 21. Upon petition of Howard A. Eaton and 28 others. To see what action the Town will take to accept all or part of the unimproved roads on the Easterly side of the State Boulevard on Seabrook Beach.

Article 22. (1) Upon petition of William H. Durkee and 10 others. To see if the Town will vote to give the Cemetery Department the authority to mark off and sell all cemetery lots in Town owned cemeteries and set the price of them. Deeds to be made out by the Selectmen.

(2) To see if the Town will vote to allow the cemetery Department to rearrange the Quaker Cemetery, and sell lots for burial on same.

(3) To see if the Town will vote to set aside all monies received from cemetery lots and spend it for cemetery purposes only.

Article 23. To hear the report of the Planning Board and to act thereon.

Article 24. To hear the report of the Water Supply Committee and to act thereon.

Article 25. To retain the present Water Supply Committee and to act upon keeping the Water Supply proposition.

Article 26. To transact all other business that may legally come before said meeting.

# REPORT OF FIRE DEPARTMENT

Owing to a very dry hazardous year the department had a rather large overdraft.

This overdraft was caused not only because of the extremely dry spell, but also because of other facts. A large amount was spent trying to keep water-holes operatable, which is the only supply of water we have for fighting fire.

The use of a tractor at the orders of the state fire warden was another rather high figure that doesn't normally exist, we also had to use the tractor to make roads to fire holes.

A forest fire patrol had to be kept which doesn't normally exist, the town dump was ordered burned at a very critical time and got away from the men appointed to stand by, resulting in a fire that lasted better than several hours for the whole fire department, which also is a large sum not normally spent.

Another big factor, was that minors were going about setting wood fires as well as building fires, this can be laid to negligence on the part of the parents not knowing where their children are or caring what they are doing.

We had a total of \$701.90 for forest fires alone, a very staggering figure when you consider that the most of them were set by minors, also some building fires were set in unoccupied buildings.

Before another drought exists we are asking the parents of the town to kindly watch their children more<sup>\*</sup> closely, keep matches, cigarettes, cigarette lighters, and magnifying glasses away from them, remember you are paying for your negligence through a higher tax rate, as the town appropriates money for various departments, through taxation.

In closing, here is a list of equipment on hand and what we feel is needed to carry on firefighting for the coming year.

#### Gentlemen:

Submitted herewith is the report of an audit and examination of the accounts of the Town of Seabrook for the fiscal year ended December 31, 1949, which was made by this Division in accordance with the vote of the Town. Exhibits as hereafter listed are included as part of the report.

## SCOPE OF AUDIT

Included in the examination and audit were the accounts and records of the Board of Selectmen, Treasurer, Tax Collector, Town Clerk, Municipal Court and Trustees of Trust Funds.

#### FINANCIAL STATEMENTS

## Comparative Balance Sheets—Dec. 31, 1948 - Dec. 31 1949: (Exhibit A-1)

Comparative Balance Sheets as of December 31, 1948 and December 31, 1949, are presented in Exhibit A-1. As indicated therein the Net Debt increased by \$1,798.22 during the year 1949.

#### Analysis of Change in Financial Condition: (Exhibit A-2)

An analysis of the change in financial condition of the Town, during the year is made in Exhibit A-2, with the factors which caused the change indicated therein.

#### Comparative Statements of Appropriations and Expenditures Estimated and Actual Revenues: (Exhibits A-3 and A-4)

Comparative statements of appropriations and expenditures, estimated and actual revenues for the fiscal year ended December 31, 1949, are presented in Exhibits A-3 and A-4. As indicated by the budget summary (Exhibit A-4), a net overdraft of appropriations of 5,624.02, less a net revenue surplus of 1,863.98, resulted in a net budget deficit of 3,760.04.

#### Statement of Long Term Indebtedness: (Exhibit G)

A statement of long term indebtedness as of December 31, 1949, showing annual maturities of principal and interest thereon, is contained in Exhibit G.

#### Summary of Receipts and Expenditures: (Exhibit B-1)

A summary of receipts and expenditures for the fiscal year ended December 31, 1949, made up in accordance with the uniform classification of accounts, is included in Exhibit B-1. Proof of the Treasurer's balance as of December 31, 1949, is indicated in Exhibit B-2.

#### AUDIT PROCEDURE

The accounts and records of all town officials charged with the custody, receipt and disbursement of public funds were examined and audited. Vouchers and cancelled checks were compared with supporting invoices and payrolls as well as entries in the books of record. Receipts were checked by source insofar as possible and totals of receipts and expenditures verified. Book balances were verified by comparison with reconciled bank balances made from statements obtained from depository banks. Verification of uncollected taxes was made by mailing notices to delinquent taxpayers as indicated by the Collector's records.

Section 5 of Chapter 52, Revised Laws of New Hampshire, (Municipal Budget Law) the provisions of which have been adopted by the Town of Seabrook, provides as follows:

"5. Exceeding Appropriations. In towns adopting the provisions of this chapter, no board of selectmen, school board, or other spending agency shall pay or agree to pay any money or incur any liability involving the expenditure of money for any purpose for which an appropriation has not been made, or in excess of any appropriation or allotment made to it except for the purpose of paying judgments rendered against a town or school district, provided, however, that in case of sudden and unexpected emergency the selectmen may on application to the tax commission and the school board on application to the state board of education after hearing be given a certificate of emergency authorizing them to make such expenditure or incur such liability; provided, further, that in cases arising during the year following a town meeting where changes occur which make it unnecessary to use the amount appropriated for a specific purpose an unexpended balance may be transferred by boards of selectmen or school boards from one appropriation to another, provided the total amount expended for all purposes does not exceed the total amount appropriated at town or school meetings for all purposes."

It must be stated, therefore, that contrary to the provisions of this section of the Municipal Budget Law, (1) total expenditures exceeded budgetary appropriations and (2) no application was made to the Tax Commission for authority to exceed appropriations.

In this connection it is recommended that the budget committee give careful consideration to the matter of the costs of required and essential services when the budget is prepared this year. Appropriations should be adequate in amount to cover necessary expenditures.

#### Uncollected Poll Taxes of Prior Years:

It will be noted from the summary of the Tax Collectors' warrants (Exhibit C-1), that on December 31, 1949 there were uncollected poll taxes on tax warrants of levies prior to 1947 as follows:

Inasmuch as the collections on account of the poll taxes of these prior years' levies amounted to only \$22.00 in 1949, it is reasonable to assume that the larger part of them may be uncollectible. The lists should be carefully gone over by the Board of Selectmen and Tax Collector and abatements made in cases where the taxes appear to be uncollectible. Including a substantial amount of such uncollectible taxes as "assets" in the Town balance sheet tends to give an inaccurate picture of the true financial condition of the Town.

#### Municipal Court:

As indicated by Exhibit E, there was a balance in the Municipal Court-account on December 31, 1949, amounting to \$331.03. As this apparently represented unidentified receipts of previous years, the Judge of the Municipal Court will remit this balance to the Town Treasurer in 1950.

#### Record of Property Acquired by Tax Deeds:

Each piece of property acquired by the Town through tax collector's deed should be recorded on the regular form of card which is available for this purpose. All taxes, interest and costs paid by the Town to date of tax deed are entered on the card. Taxes which may accrue subsequent to the time when deed is taken and before the property is resold by the Town are likewise entered, and also such other expenses as insurance and repairs. This makes available to the Town at any time the total investment in each piece of tax deeded property, which should be used as a basis in establishing the re-sale price of the property.

#### **Relief Orders:**

Town aid to welfare cases should be given only by regular relief orders authorized by the Selectmen. The recipient should always sign the vendors copy when the goods or materials are received and the vendor should attach this copy to his bill when it is presented to the Town for payment.

#### **Town Officers' Expense Accounts:**

Town officials should make out detailed statements of their expense accounts, indicating by dates on which the expense was incurred such items as mileage, meals, etc.

#### Miscellaneous Expenditures:

Inasmuch as practically all expenditures can be properly classified under the regular classification headings, it is not necessary to have a "miscellaneous" expenditure column in the Selectmen's book.

#### Conclusion:

The provisions of Section 31, Chapter 211, of the Laws of 1939, require that this report or a summary of its essential features shall be published in the next annual Town report. This letter of transmittal should be included in its entirety.

We extend our thanks to the officials of the Town of Seabrook for their assistance during the course of the audit.
