- l. I am a former Scientologist who worked directly for L. Ron Hubbard until December 1981. At that time, I was working on an authorized biography of L. Ron Hubbard and discovered that many of the claims Hubbard made about his past and his qualifications were false.
- 2. Since I left the organization, I have been a target of constant harassment. I have been sued once and the organization has attempted to have me arrested on at least two occasions on trumped up charges. I was completely exonerated in the case in which I was sued, Church of Scientology v.

 Armstrong, No. C 420 153, Los Angeles Superior Court. In fact, after a five-week trial, Judge Breckenridge found that I "was the subject of harassment, including being followed and surveilled by individuals who admitted being employed by plaintiff (Church of Scientology); being assaulted by one of these individuals; being struck bodily by a car driven by one of these individuals; having two attempts made by said individuals

apparently to involve defendant Armstrong in a freeway automobile accident; having said individuals come into defendant Armstrong's property, spy in his windows, create disturbances, and upset his neighbors."
