21 Plaintiff, Church of Scientology International, by its
22 attorneys, Wilson, Ryan & Campilongo and Bowles & Moxon, hereby
23 apply to this Court for the entry upon a tentative finding by the
24 Court that a preliminary injunction shall issue, until such time as
25 plaintiff's Preliminary Injunction Application may be heard. As
26 grounds therefore, plaintiff states that the Motion for Preliminary
27 Injunction was originally set for hearing before the Honorable
28 William Stephens on March 6, 1992; that on February 28, 1992, after


1 Judge Stephens refused to grant defendant's application for a
2 continuance of the hearing, defendant challenged Judge Stephens
3 pursuant to C.C.P. Section 170.6; that the case was accordingly
4 transferred to the Honorable Michael B. Dufficy; that Judge Dufficy
5 will be out of town on Friday, March 6, and intends instead to issue
6 a tentative ruling on plaintiff's motion on Thursday, March 5, with
7 oral argument to follow, if it is requested by either party, on or
8 following March 16, 1992. Plaintiff requests that in the event that
9 the Court, after a full review of the moving and opposing papers
10 concerning the preliminary injunction, finds tentatively that an
11 injunction should issue, that the Court issue a Temporary
12 Restraining Order identical to the Preliminary Injunction for the
13 time period from March 5, 1992 until the ultimate resolution of
14 plaintiff's motion.

15 This Application will be based upon the Declaration of Andrew
16 H. Wilson submitted concurrently herewith, and upon the various
17 pleadings and papers filed by plaintiff in support of its Motion for
18 Preliminary Injunction.
