- 4. I became involved in that case after the case-in-chief had been dismissed by a secret settlement agreement between Ms. Wakefield and Scientology.
- sas prosecuting secret, sealed enforcement proceedings by means of contempt charges against Ms. Wakefield for allegedly violating confidentiality provisions of the secret settlement agreement. These proceedings were closed to the public and the press. Due to such closure the Tampa Tribune and the St. Petersburg Times sought to intervene in order to contest the fact that secret proceedings were transpiring in consequence of which an individual could be jailed for exercising her right to Free Speech.
- 6. Most of the file in <u>Wakefield</u> is sealed; thus I am precluded from stating all I know regarding that case. I am not precluded, however, from stating that the contempt enforcement proceedings prosecuted by Scientology against Ms. Wakefield were based upon a preliminary injunction it obtained in <u>secret</u>, <u>closed proceedings</u> against Ms. Wakefield while she was <u>not represented by counsel</u>. Ms. Wakefield also has a history of mental illness and instability. Based upon the foregoing, it is my opinion that the issues in <u>Wakefield</u> were never truly litigated and therefore the appellate opinion relied on by Scientology fails to properly address the issues raised by its brand of secret, settlement agreement.
