Gerald Armstrong</u>, Los Angeles Superior Court, Case No. C 420 153, or by any other department of the Los Angeles Superior Court.

This is an issue because plaintiff's Memorandum In Support of Motion for Preliminary Injunction at p. 11:5-6 states that the settlement agreement had been "approved" by the Los Angeles Superior Court and Witness Michael Lee Hertzberg has conceded on the record on December 23, 1991, before Judge Bruce R. Geernaert in Los Angeles Superior Court that the settlement agreement had never been filed with that Court. This contradiction of stated positions by Scientology in the two different Courts, Los Angeles and Marin County, must be resolved in order that no fraud is perpetrated upon Marin County Superior Court.

Witness Michael Lee Hertzberg will testify to this matter and said testimony should take five to fifteen minutes.
